Independent Auditor's Report

Opinion on the 2024 Financial Statements

We have audited the financial statements of Professional Contract Services, Inc. Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with U.S. GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Other Matter - Auditor's Report on the 2023 Financial Statements

The 2023 financial statements of the Plan were audited by predecessor auditors whose report dated October 15, 2024, expressed an unmodified opinion on those financial statements.

NOTE 1 PLAN DESCRIPTION

The following description of Professional Contract Services, Inc. Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan provides a broad range of employee welfare benefits to eligible employees of Professional Contract Services, Inc. (the Company), as defined, and covered dependents. Certain participants and their covered dependents are also entitled to continue coverage under the Plan beyond the time coverage would ordinarily have ended if they meet certain criteria, as defined. The Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was effective as of March 1, 2018.

Benefits

The Plan provides health benefits (medical, dental and vision), group-term life and accidental death and dismemberment insurance, life insurance, short-term and long-term disability, flexible spending account program and voluntary group legal assistance. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act.

Insured Benefits

All Plan benefits are fully insured (other than dental). The Company or employee pays a fixed premium to the insurance carriers. The premium rates are fixed for a year and determined by the insurance carriers.

Self-insured Benefits

All dental Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the third-party, the Plan's VEBA trust or the general assets of the Company. Despite the Plan's utilization of claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions

Participants receive health and welfare wages from the Company, which are contributed into the trust to fund health benefit premiums and accidental death and dismemberment insurance premiums. If the health and welfare wages are not sufficient to cover the premium, the participant contributes a specified amount to cover the premium expense. The health and welfare wages are defined in the employee's Company contract. For all other benefits, these are either paid by the employee or employer, depending on the benefit type and whether the employee is direct or indirect. These benefit premiums are withheld from the employee's paycheck and remitted by the Company to the insurance provider.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions and Contributions Receivable

Contributions from Plan participants and the employer contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Payment of Benefits

Premiums are recorded as premium expenses and claims are recorded when paid in the accompanying Statements of Changes in Net Assets Available for Benefits.

Administrative Expenses

The Plan pays third-party administrative fees. These expenses are recorded as administrative and legal expenses in the accompanying Statements of Changes in Net Assets Available for Benefits. All other administrative expenses are paid by the Company on behalf of the Plan and are excluded from these financial statements.

NOTE 3 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As described in Note 1, the Plan has several arrangements with insurance providers to support its operations. These arrangements constitute party-in-interest transactions under the ERISA. Such transactions are conducted in accordance with applicable regulations and are disclosed to ensure transparency and compliance with ERISA requirements.

NOTE 4 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 5 PLAN TAX STATUS

The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 SUBSEQUENT EVENTS

The Plan has evaluated subsequent events to December 31, 2024 to assess the need for potential recognition and/or disclosure in the financial statements. Such events were evaluated through October 15, 2025, the date the financial statements were available to be issued. Management determined that no subsequent events require disclosure or adjustment to the accompanying financial statements.
