### **Independent Auditor's Report**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements***

We have performed an audits of the financial statements of the Coastal Management LLC 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). #### Plan Description

The following brief description of the Coastal Management LLC 401(k) Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

##### General

The Plan is a defined contribution plan effective February 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by Coastal Management LLC (the Company or plan sponsor) through the plan administrator, who is responsible for the oversight of the Plan. The trustee, Reliance Trust Company, receives contributions on behalf of the Company and the participants, makes all distribution and benefit payments, and maintains all records of the Plan.

##### Eligibility

The Plan covers substantially all employees of Coastal Management LLC and its affiliates, who have attained age 21. Eligible employees may enter the Plan on the first date of the month following completion of eligibility requirements.

##### Contributions

The Plan is primarily funded through employee elective wage deferrals under the deferred compensation provisions of the Internal Revenue Code Section 401(k). Each year, participants may elect to defer up to 90% of their pretax annual compensation contributed as pre-tax 401(k) or Roth 401(k) contributions, as defined by the Plan, not to exceed the annual limitation as defined by the Internal Revenue Service. A participant who has attained age 50 before the end of the Plan year is eligible to defer additional amounts to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans.

The Company makes a safe harbor matching contribution to the Plan on behalf of the participants of 100% of the participant's salary deferrals up to 4% of eligible compensation. The Plan also allows the Company to make additional discretionary contributions. During the years ended December 31, 2024, and 2023, no additional discretionary contributions were made.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

##### Vesting

Participants are immediately vested in their contributions, employer contributions, and actual earnings thereon. As a result, no forfeitures are recognized under the Plan.

#### Plan Description (continued)

##### Investment Options

A participant may direct Company and participant contributions in any of the various investment options offered by the Plan. Participants may change their investment option at any time. The Plan currently provides several mutual funds and one common collective trust account as investment options.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loan terms range from one month or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participants' accounts and bear interest at the prime rate plus 2.00% at December 31, 2024 and 2023, which is determined at loan inception based on prevailing interest rates by the plan administrator. Interest rates currently range from 9.00%-10.50%. Principal and interest are paid ratably through bi-weekly payroll deductions.

##### Payment of Benefits

Upon termination of service due to death, disability, or normal retirement age (defined as 65), a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution, installment (if participant is subject to lifetime required minimum distributions), or partial withdraws, provided the minimum withdrawal is \$500. The Plan allows for in-service distributions if a participant reaches age 59½, and also allows for hardship and deemed severance distributions subject to Plan provisions. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or rollover their vested amounts to another qualified retirement account as soon as administratively feasible following severance of employment.

The Plan includes automatic cash-out provisions. If the balance of the terminated participant's vested account balance is less than \$5,000, the Plan Sponsor may authorize the benefit to automatically distribute without the participant's consent.

##### SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. There was no material impact to the Plan's 2024 or 2023 financial statements.

#### Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investment Valuation and Income Recognition

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded as of the ex-dividend date. Net appreciation includes the Plan's unrealized and realized gains and losses on investments bought and sold as well as held during the period.

##### Payment of Benefits

Benefits are recorded when paid.

##### Note Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis recognizing income when received. Related fees are recorded as administrative expenses and are expensed when they are paid. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan's agreement.

##### Administrative Expenses

The Company pays for certain plan administrative expenses. The Company provides the Plan with certain accounting and administrative services for which no fee is charged.

### Fair Value Measurements

U.S. GAAP established a fair value hierarchy that prioritizes the inputs to measure the fair value of the assets or liabilities being measured. Fair value is defined as the exchange value that would be received on the measurement date to sell an asset or to value the amount paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are unadjusted quoted market prices in active markets for identical assets or liabilities that the entity has the ability to access at the measurement date. Level 1 inputs provide the most reliable measure of fair value as of the measurement date.
- Level 2 Inputs are based on significant observable inputs, including unadjusted quoted market prices for similar assets and liabilities in active markets, unadjusted quoted prices for identical or similar assets or liabilities in markets that are not active, or inputs other than quoted prices that are observable for the asset or liability.
- Level 3 Inputs are significant unobservable inputs for the asset or liability.

### Fair Value Measurements (continued)

The level of the fair value hierarchy within which a fair value measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year-end.

*Common Collective Trust:* The fair values of participation units in common collective trusts are based upon the NAVs of such funds under the practical expedient approach and therefore are not assigned to a level in the hierarchy table. The funds invest in conventional and synthetic investment contracts issued by various companies and institutions, with the objective of providing a high level of return that is consistent with also providing stability of investment return, preservation of capital and liquidity to pay plan benefits of its retirement plan investors. There are no redemption restrictions upon which the participant may redeem investments in the funds. However, the Plan is required to provide a one-year redemption notice to liquidate its entire investment in the funds.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's net assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will continue to be 100% vested in their accounts.

### Tax Status

The Plan has adopted a prototype plan, which obtained its latest prototype opinion letter on October 6, 2020, in which the Internal Revenue Service (IRS) stated that the plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Company is relying on the Plan's IRS opinion letter. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Party-in-Interest Transactions**

Reliance Trust Company is the trustee as defined by the Plan. Fees incurred are paid directly by the Plan for investment management services.

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor and certain others. Notes receivable from participants qualify as party-in-interest transactions. Certain Plan investments are units of a common collective trust managed by ADP, LLC. ADP, LLC is the Plan's third-party administrator; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. Fees paid by the plan amounted to \$12,160 and \$7,524 for the years ended December 31 2024 and 2023, respectively.

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 and 2023 statements of net assets available for benefits.

#### **Subsequent Events – Date of Management's Evaluation**

The Plan has evaluated subsequent events through the date of the Independent Auditor's Report, which is the date that the financial statements were available to be issued.
