## Independent Auditor's Report

To the Board of Trustees of  
1199SEIU/Greater New York Child Care Fund

### ***Opinion***

### (1) Description of the Fund

The following description of the 1199SEIU/Greater New York Child Care Fund (the “Fund” or “Plan”) provides only general information. For more detailed information about the Plan and benefit provisions, consult the *Summary Plan Description*, available from the Plan Administrator. Full details of the Plan are contained in the official Plan documents, which are available for inspection at the office of the Plan Administrator.

#### (a) General

In October 2002, the Plan was established by an agreement and declaration of trust. It was created to provide and maintain childcare services and program options to assist participants with their childcare needs. The Plan is subject to the regulations of the U.S. Department of Labor and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). It is a Taft-Hartley employee benefit trust fund. The Plan is sponsored by the 1199SEIU United Healthcare Workers East (the “Union”) and the Greater New York Health Care Facilities Association (the “Association”).

#### (b) Plan Benefits and Eligibility

The Plan provides reimbursements for childcare services, including childcare vouchers, day care centers, summer day camps, after school programs, holiday programs, scholarships, weekend programs, community service programs, youth service programs and childcare resource and referral services. An individual becomes eligible for participation in the Plan if he/she is a member of a bargaining unit represented by the Union and if the collective bargaining agreement between the individual’s employer and the Union provides for employer contributions to the Plan for that bargaining unit. A single schedule of benefits will be uniformly applicable to all participating employers (“Contributing Employers”) of the Association.

#### (c) Funding

The Fund receives revenue from employer contributions pursuant to several Collective Bargaining Agreements (“CBAs”) entered into between certain Contributing Employers and the Union.

On November 29, 2021, the parties entered into a new MOA covering the period from October 1, 2021 through September 30, 2024 (the “2021 MOA”). In accordance with the 2021 MOA, all employers who contribute to the Fund will continue to be contributing employers at the same contribution rate as the current for the life of the agreement.

On July 1, 2023, the 2021 MOA was extended through September 30, 2026 (the “2024 MOA”). Contribution rates did not change under the 2024 MOA.

Under the term of the CBAs, employers are required to make a monthly contribution to the Plan based on a specified percentage of the total gross wages of such employer’s covered union employees, in accordance with the requirements of the related CBA.

Additionally, the Fund receives revenue from participant co-payments (“program revenue”).

## (2) Significant Accounting Policies

### (a) *Basis of Accounting*

The financial statements of the Plan have been prepared on the accrual basis of accounting.

### (b) *Cash and Cash Equivalents*

Cash consists of funds held in commercial checking accounts and a highly liquid money market account held at Amalgamated Bank that is considered a cash equivalent.

As of December 31, 2024 and 2023, the Fund held noninterest bearing cash of \$136,219 and \$217,423 and money market funds of \$257,446 and \$244,796 respectively. As of December 31, 2024 and 2023, the money market fund is classified as level 1 under the hierarchy leveling criteria under the hierarchy leveling criteria under ASC 820, *Fair Value Measurement*. The valuation methodology of the money market funds is based on unadjusted quoted prices for identical assets in active markets that the Fund has the ability to access.

### (c) *Depreciation and Amortization*

Furniture and equipment are stated at cost, net of accumulated depreciation, and depreciated on a straight-line basis over their estimated useful lives. Leasehold improvements are stated at cost, net of accumulated amortization, and amortized on a straight-line basis over their estimated useful lives or the remaining term of the sublease, whichever is shorter. Expenditures for maintenance and repairs are expensed as incurred, while additions and improvements that extend the life of the asset are capitalized.

### (d) *Program Expenses*

Program expenses are benefit payments to participants and care providers which are recorded when paid.

### (e) *Employer Contributions*

The Fund recognizes contributions based on the latest executed collective bargaining agreement on an individual employer basis. Accordingly, contribution revenues from each Contributing Employer are recorded based on the rates of the latest signed agreement by such Employer. Contributions from employers are based on a percentage of the participating employers’ monthly payroll for covered employees and are payable to the Fund during the subsequent month. The Fund recognizes contributions as revenue in the same period in which the wages were earned by the covered employees.

### (f) *Receivables and Liabilities*

The carrying value of receivables and liabilities approximate their fair values.

**(g) Allowance for Doubtful Accounts**

Management of the Fund evaluates employer contributions receivable periodically for potential uncollectible amounts based on the likelihood of collection.

**(h) Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“US GAAP”) requires management to make estimates and assumptions that affect the reported amount of assets, liabilities and changes therein and disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements and accompanying notes. Actual results could differ from those estimates.

**(3) Benefit Obligations**

Benefit obligations consist primarily of amounts payable at the end of the year related to certain childcare expenses provided by the Fund for eligible members in accordance with US GAAP. Each of the programs is governed by specific rules as described in the Plan’s summary plan description.

**(4) Tax Status**

The Plan is qualified pursuant to section 501(c)(9) of the Internal Revenue Code (“IRC”) and, accordingly, is exempt from income taxes. The Internal Revenue Service has determined and informed the Plan by a letter dated November 24, 2004, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(5) Termination of the Plan**

Although they have not expressed any intention to do so, the Plan’s Board of Trustees has the right to amend or terminate the Plan subject to the provisions set forth in ERISA. Furthermore, the Union

and a majority of employers may terminate the Plan pursuant to a mutual agreement.

### **(6) Related-Party Transactions and Administrative Expenses**

For some central administrative operations, the Fund and certain other 1199SEIU related funds (collectively the “Related Funds”) are administered by the same personnel and share the same office space and other administrative services.

In addition, certain other central administrative expenses are paid by the 1199SEIU National Benefit Fund for Health and Human Service Employees (NBF). These expenses are then pooled and allocated among the Related Funds based on an allocation study reviewed by an external consultant. The 2024 allocations were based on an allocation study that was approved on December 13, 2023 and the 2023 allocations were based on an allocation study that was approved on December 11, 2021.

In addition, certain other administrative expenses are allocated among the Fund, the 1199SEIU/Employer Child Care Fund (“CCF”) and the 1199SEIU/Employer Child Care Corporation (the “Corporation”). First, shared expenses are allocated to the Corporation based on employee time studies. Then, after allocating these shared expenses, the remaining shared operations expenses are allocated between the Fund and CCF. These allocations are subject to the approval of the respective Boards of Trustees of the Fund and CCF and of the Board of Directors of the Corporation. For the years ended December 31, 2024 and 2023, total shared operating expenses allocated to the Fund amounted to \$261,769 and \$624,427, respectively.

As of December 31, 2024, the Fund had amounts due from the related parties of approximately \$730,000, which includes expenses that are pooled and allocated among the Related Funds based on an allocation study reviewed by an external consultant. Balances include approximately \$34,000 due from NBF, approximately \$579,000 due from CCF, \$112,000 due from GNY Benefit Fund, and \$5,000 from others. As of December 31, 2023, the Fund had amounts due from the related parties of approximately \$473,000, which includes expenses that are pooled and allocated among the Related Funds based on an allocation study reviewed by an external consultant. Balances include approximately \$60,000 due from NBF, approximately \$282,000 due from CCF, \$99,000 due from GNY Benefit Fund, \$23,000 due from the Corporation related to a refund of unspent Youth Services program advances and \$9,000 from others.

As of December 31, 2024, the Fund had amounts due to related parties of approximately \$137,000, which includes approximately \$120,000 due to 3BF Partners LLC related to the Fund’s usage of the NYC Office, and approximately \$17,000 due to Greater NY Education Fund. As of December 31, 2023, the Fund had amounts due to the related parties of approximately \$352,000, mainly attributable to an interfund settlement of \$350,000 and approximately \$1,000 due to the NBF, and approximately \$1,000 from others relating to shared cost.

The Fund also paid various claims and stipend expenses for the Corporation relating to Direct Program (Workforce 2000) for the years ended December 31, 2024 and 2023 in the amount of \$1,995 and \$1,651, respectively.

**(7) Concentration of Credit Risk**

Financial instruments that subject the Fund to concentration of credit risk consist of cash and cash equivalents. The Fund maintains accounts at a high quality financial institution. While the Fund attempts to limit any financial exposure, its cash deposit balances may, at times, exceed federally insured limits. The Fund has not experienced any losses on such accounts. Short-term investments are not covered by the Federal Deposit Insurance Corporation.

**(8) Risks and Uncertainties**

Preparing financial statements requires management to make estimates and assumptions about current, and for some cases future, economic and market conditions, which affect reported amounts and related disclosures in the financial statements. Although current estimates and assumptions contemplate current conditions and how management expects them to change in the future, as applicable, it is reasonably possible that in the near term, those estimates and assumptions could change which would have a material impact on amounts currently reported. These changes would impact future financial statements in accordance with US GAAP. Examples of some of the more significant assumptions and estimates are as follows:

Benefit obligation is reported based on projected benefit payments payable during the subsequent year based on eligibility prior to December 31, 2024, all of which are subject to change. Due to uncertainties inherent in the estimations, it is reasonably possible that changes in these estimates would be material to the financial statements.
