Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tavant Technologies 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such

procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Tavant Technologies 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Tavant Technologies 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion —

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1. DESCRIPTION OF THE PLAN

The following description of Tavant Technologies 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General:

The Plan was established under the application provisions of the Internal Revenue Code (IRC) and is a defined contribution plan for eligible employees, as defined in the Plan Document, of Tavant Technologies Inc. (the Company). The Plan is a 401(k)-salary deferral and profit-sharing plan covering all eligible employees of the Company as defined in the Plan agreement. Certain classes of employees as defined in the Plan agreement are excluded from the plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the IRC.

Administration:

The Plan administrator manages the operation and administration of the Plan. The Company has contracted with Reliance Trust Company (Reliance) to act as the trustee, and custodian to process and maintain the records of the participant data. The Company is the Plan sponsor, and the plan administrator is the Committee appointed by the Employer.

Eligibility:

Employees are eligible to participate in the Plan upon reaching age 21. The entry date will be the first day of the month coinciding with or next following the date that the participant satisfies the eligibility requirements. Employees excluded from the Plan are as follows:

- certain nonresident aliens who have no earned income from sources within United States
- employees who are residents of Puerto Rico

Participant contributions:

Participants may elect to defer up to 90% of pretax and Roth 401(k) of the annual eligible compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, called rollovers. Contributions are subject to regulatory limitations. The limit is \$23,000 for 2024. In addition, participants aged 50 or older before the end of the Plan year, are able to make catch-up contributions. The catch-up dollar limit for 2024 is \$7,500.

Employer contributions:

The Plan allows matching employer contributions. For the year ended December 31, 2024, the Company matched 50% of employee salary deferral, up to a maximum of 3% of eligible compensation. The participant must make elective deferrals in order to receive matching contributions. Matching contributions are made each pay period that the elective deferrals are made. Following the end of the Plan Year, the matching contribution will be recalculated based on each participant's total elective deferrals relative to eligible compensation for the entire Plan Year, and an additional matching contribution will be made if applicable. In 2024, the Company made a matching contribution in the amount of \$538,568 of which \$74,157, was funded by forfeiture account.

The Plan also allows for an additional discretionary profit-sharing contribution. The participant must have completed at least 500 hours of service to receive this. No discretionary profit-sharing contribution was made during the years ended December 31, 2024 and December 31, 2023.

Rollover:

Employees may roll over eligible amounts from other qualified retirement plans or Individual Retirement Account (IRA) to the Plan. Employees can also rollover Roth contributions from another qualified plan to this Plan, but rollovers are not permitted from a Roth IRA.

Participant accounts:

Each participant's account is credited with the participant's contribution and Company's matching contribution, an allocation of the Company's discretionary profit-sharing contribution (if any), plan earnings and losses, and plan expenses as applicable to the Plan. Allocations of plan earnings and losses are based on individual participant investment choices. All contributions / investments are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment:

The Plan provides for investments to be directed by participants into a number of investment options held by the Trustee. Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options and may change their investment options at any time.

Forfeitures:

Forfeitures are non-vested portion of participants' accounts that are lost upon termination of employment. Forfeited accounts can be used to pay plan expenses or reduce future employer contributions. As of December 31, 2024 and December 31, 2023 the forfeiture account balance was \$334 and \$315 respectively

Vesting:

Participants are 100% vested in their contributions and rollover amounts plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts is based on years of continuous service. Participants vests in the Company's contributions based on the following schedule:

Participants become fully vested in the event of death, disability, retirement age or plan termination.

Payment of benefits:

Upon the satisfaction of certain distributable events, participants or their beneficiaries may elect to receive their vested account balance and are paid in accordance with plan provisions.

Notes receivable from participants:

Participants may borrow from their fund account a minimum of \$500 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Only one outstanding note per participant is permitted at any given time. The notes are issued by the Plan and secured by the vested balance in the participant's account. All notes must be repaid within a period of five years, unless the note is used to purchase a principal residence, in which case, the note must be repaid within a reasonable period of time not to exceed 30 years. Outstanding notes receivable from participants as of December 31, 2024 and 2023 carry interest rates which range from 5.25% to 10.50% and from 5.25% to 10.50% respectively. Principal and interest are paid ratably through payroll deductions as per the terms of the note and in accordance with plan provisions. The Plan administrator establishes the specific terms and conditions of such notes.

Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting:

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Reliance certifies the market value of all investments. If available, quoted market prices are used to value investments. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions:

Contributions from plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of benefits:

Benefits are recorded when paid.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded at December 31, 2024 or 2023.

Plan expenses:

In 2024, some fees related to the administration of the Plan were paid by the Company and these amounts are excluded from the Plan's financial statements. Investment/fund fees and participant transaction fees were charged to participant accounts as applicable.

NOTE 3. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, overall market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (Mutual Funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust - Investments held in a common/collective trust (CCT) are valued using the NAV practical expedient as reported by the CCT issuers. The NAV is based on the fair value of the underlying assets held by the CCT, less its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CCT is calculated based on a compilation of primarily observable market inputs. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of its investments in a CCT, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations are carried out in an orderly manner.

NOTE 5: CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, interest, dividends, net appreciation in fair value of investments, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 6: PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Plan investments are held by Reliance Trust Company. Any purchases and sales of these funds are performed in the open market at fair value or contract value. Plan related fees are paid to Reliance Trust Company and ADP, Inc. The Plan has other service providers. All these transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 7: INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated October 6, 2020 from the IRS stating that the form of the plan is qualified under Section 401 of the Code and, therefore, the related trust is tax-exempt. The Plan has been amended since, however the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8: EXCESS CONTRIBUTIONS PAYABLE

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan is required to return contributions to participants in the event certain non-discrimination tests defined under the IRC are not satisfied. As of December 31, 2024 and 2023, excess contributions payable was recorded amounting to \$2,030 and \$529 respectively.
