We have performed audits of the financial statements of Affinius Capital 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Note 1. Description of Plan

The following description of Affinius Capital 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan which covers employees of Affinius Capital (the Company) who are age 21 or older who are not part time, temporary, seasonal or otherwise expected to work less than 1,000 hours per year. The Investment Committee is responsible for oversight of the Plan. The Investment Committee consults with ADP, Inc. (ADP), the Investment Advisor, and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan became effective on January 1, 2008. The Plan Administrator is Affinius Capital LLC. The Plan recordkeeper is ADP. The Plan trustee is Reliance Trust Company (Reliance).

Contributions: Each year participants may elect to contribute up to 80% of eligible compensation, which includes cash compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions from Plan participants are recorded in the year in which participant compensation is earned. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 100% of the first 6% of eligible compensation a participant contributes to the Plan. The Company performs a true-up calculation at year-end resulting an employer contribution receivable as presented in the statements of net assets available for benefits.

New participants are automatically enrolled with a contribution rate of 6% but can subsequently opt out or adjust the contribution rate. Additional profit-sharing amounts may be contributed at the option of the Company's Board of Directors. No such profit-sharing contributions were made during 2024. Pursuant to Internal Revenue Service (IRS) regulations, contributions are subject to limitations based on annual compensation limits.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Participants are cliff vested in the Company's contributions plus actual earnings thereon based on years of continuous service whereby a participant is 100% vested after two years of credited service.

Participant loans: Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest, as determined by the Plan Administrator. Notes outstanding at December 31, 2024, had interest rates ranging from 4.25% to 9.50% and mature through November 2029. Principal and interest are paid through payroll deductions.

Payment of benefits: On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Any balance of \$5,000 or less is automatically paid out as soon as administratively possible. Hardship withdrawals are also available subject to certain limitations.

Note 1. Description of Plan (Continued)

Forfeitures: Forfeitures will be used to reduce future employer contributions or pay Plan expenses. Forfeited nonvested accounts totaled \$0 at December 31, 2024 and 2023. During 2024, \$128,052 in forfeitures were used to reduce employer contributions.

Service fee sharing arrangement: Plan participants invested in certain funds are charged fees by the fund administrators. ADP (the Plan recordkeeper) receives a share of these fees for its administrative services. In July 2011, the Company amended its Administrative Services Agreement with ADP to enter into a service fee sharing arrangement. Under the arrangement, a portion of these service fees are to be refunded to the Plan quarterly based on a fixed percentage of the average daily balance of assets invested in funds that pay service fees. The Company has directed ADP to use the proceeds to pay Plan expenses, as defined in the Administrative Services Agreement and as allowed in the Plan document or the proceeds can be contributed to each participant's account. The Plan allocates all fee sharing proceeds remaining after payment of any Plan expenses to participants on a per capita basis. At December 31, 2024 and 2023, the statements of net assets available for benefits reflected a receivable of \$0 and \$18,588, respectively, for service fees to be refunded by ADP. The Plan's share of the service fees totaled \$16,157 during 2024. The fees are included as a reduction of expenses in the statement of changes in net assets available for benefits.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Administrative fees include certain recordkeeping fees paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan changed its trustee from Reliance Trust Company to ADP Retirement Trust Services, LLC. This change in trustee does not affect the financial statements as of December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus accrued, but unpaid interest. Interest income is recorded on the accrual basis.

Note 2. Summary of Significant Accounting Policies (Continued)

Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024, or 2023.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Payment of benefits: Benefits are recorded when paid.

Note 3. Information Certified and Provided by Reliance

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Reliance, the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust funds: Valued at the NAV of shares of the collective trusts, as reported by the investment manager. The NAV is used as a practical expedient to estimate fair value.

The methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related-Party and Parties-in-Interest Transactions

ADP is the Plan's recordkeeper. Fees paid by the Plan to the recordkeeper totaled \$163,047, net of shared fees, for the year ended December 31, 2024. The Company also paid certain administrative expenses of the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan adopted a non-standardized form of a prototype plan. The Plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Reconciliation of Financial Statements to the Form 5500
