We have performed audits of the accompanying financial statements of NickCo Hospitality LLC 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **NOTE 1 - DESCRIPTION OF THE PLAN**

The NickCo Hospitality LLC 401(k) Profit Sharing Plan & Trust (the "Plan") is a defined contribution plan. The Plan covers eligible employees, as defined in the Plan, of NickCo Hospitality LLC (the "Company"). The Plan was effective January 1, 2015 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**A. Eligibility**

Employees become eligible to participate in the Plan after attaining the age of 21, one year of service and completing 1,000 hours of service.

**B. Contributions**

Participants may elect to defer up to 100% of their eligible compensation, subject to limitations by the Internal Revenue Code ("IRC"). Participants age 50 or older may make additional catch-up contributions also subject to limitations by the IRC. Roth contributions are permitted.

Participants are allowed to make rollover contributions of amounts received from other tax qualified retirement plans, subject to approval of the plan administrator. Such contributions are deposited in the appropriate investment funds in accordance with the participant's investment directions.

Eligible employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled in the Plan at a deferral rate of 3% as soon as the eligibility requirements are satisfied.

The Plan allows for the Company to make a discretionary matching and discretionary non-elective profit-sharing contribution. To be eligible for employer contributions, participants must have 1,000 hours of service in the plan year and be employed with the company at year end. For the year ended December 31, 2024, the Company did not elect to make any discretionary employer contributions.

**C. Participant Accounts**

Each participant's account is credited with the participant's contribution, rollovers and allocation of Company's contribution, Plan earnings and administrative expenses. These amounts are invested in any of the available investment funds as directed by the participant. Plan earnings are based on each participant's investment election.

**D. Vesting**

Participants are immediately vested in their employee contributions. Vesting in the Company's contributions is based on years of credited service as follows:

**E. Payment of Benefits**

Normal retirement age under the Plan is age 62. Upon termination of service, death, disability, retirement or attainment of age 59½, a participant or beneficiary may choose to maintain his or her account in the Plan or receive benefits in a lump sum payment equal to the value of the participant's account balance. If a terminated participant's account balance is greater than \$1,000 up to \$5,000 and no distribution election has been received from the participant or beneficiary of the account, the account may be rolled over to an individual retirement account at the direction of the plan administrator. If such account does not exceed \$1,000, the balance may be paid in a lump sum distribution. Under limited circumstances, the plan administrator may approve hardship withdrawals. Benefits are recorded when paid.

**F. Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of the vested account balance. The \$50,000 is reduced by the highest outstanding loan balance during the past 12 months or any existing loan balances on the date a new loan is made, whichever is greater. Principal and interest are paid ratably through payroll deductions. The interest rate is the prime rate as published in the Wall Street Journal on the day of the loan request plus 1%. Loan terms range from 1 to 5 years unless the purpose of the loan is to acquire a dwelling unit, which is to be used within a reasonable time as the principal residence of the participant. The loans are secured by the present value of a participant's vested interest in the Plan. Each participant may have two loans outstanding at a time. At December 31, 2024, interest rates on loans ranged from 4.25% to 9.50%.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**B. Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**C. Investment Valuation and Income Recognition**

The participants select how their share of plan assets will be invested among those investment vehicles made available. Participants may change their investment options at any time during the Plan year.

GAAP establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Level 1 investments consist of mutual funds valued at quoted prices in active market. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual funds' capital gains distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**D. Administrative Expenses**

To the extent that administrative expenses are not paid by the Company, they may be paid by the Plan.

**E. Forfeitures**

Forfeitures result from nonvested accounts remaining in the Plan for terminated employees. Forfeitures are used to reduce Plan expenses first, then Company contributions. Forfeitures contributed during the year totaled \$4. Forfeited nonvested account balances totaled \$129 and \$123 as of December 31, 2024 and 2023, respectively.

**F. Risks and Uncertainties**

The Plan holds a variety of investments that are exposed to various risks such as interest rate, market fluctuations, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEES**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Information regarding investments held at December 31, 2024 and 2023 and investment income for the year ended December 31, 2024 that is disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America the custodians of the Plan, the trustees.

**NOTE 4 - INVESTMENT AT CONTRACT VALUE**

The Plan's investment in Empower's Key Guaranteed Portfolio Fund comprises unallocated insurance contracts. Because the fund meets fully benefit-responsive investment contract criteria, it is reported at contract value. Contract value is the amount received by participants when they initiate permitted transactions under the terms of the Plan, and represents contributions made to the account plus earnings, less withdrawals and expenses. The crediting interest rate of the fund is based on a formula. The actual average yield earned by the Plan was 1.41% and 1.23% for years ended December 31, 2024 and 2023, respectively. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Guaranteed Portfolio Fund. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6 - INCOME TAX STATUS**

The Company has adopted an Empower Trust Company, LLC prototype plan, which has received an opinion letter from the Internal Revenue Service stating that the form of the Plan is acceptable under the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

Certain investments held by the Plan are issued and managed by the trustees or their affiliates. Transactions related to these investments qualify as party-in-interest transactions under ERISA regulations, but such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 8 - PLAN AMENDMENT**

Effective February 1, 2024, the Plan adopted an amendment to exclude tips from compensation for all contribution purposes.

**NOTE 9 - SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan was amended to revise the definition of compensation to include tips and exclude bonuses for all contribution purposes.

Management has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available to be issued. Except as noted above, there were no material subsequent events that required recognition or additional disclosures in these financial statements.
