To the Administrative Committee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Native Seed, LP 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Native Seed, LP 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. DESCRIPTION OF THE PLAN

The following description of the Native Seed, LP 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

First Year Audit

This is the first year the Plan was subject to an audit under the Employee Retirement Income Security Act of 1974 (ERISA). In prior years, the Plan was eligible to file as a small plan and was not required to have audited financial statements. Accordingly, only current-year financial information is presented.

General

The Plan is designed to be a defined contribution plan covering employees of Native Seed, LP, LLC (the "Company") who are 21 years of age or older, have completed 3 months of service and have elected to become participants. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may elect under a salary reduction agreement, to contribute to the Plan up to 100% of their compensation, as defined by the Plan agreement, through payroll deductions subject to certain limitations under the Internal Revenue Code (IRC). The plan allows pre-tax deferrals and Roth deferrals. In addition, the Company makes safe harbor match contributions equal to 100% of the participant's 401(k) elective deferral contributions up to 3% of their compensation, plus 50% of their 401(k) elective deferral contributions between 3% and 5%. Participants direct the investment of all contributions made on their behalf.

Participants may also contribute certain rollover amounts representing distributions from other qualified employee benefit plans.

Participant Accounts

Each participant's account is credited with the participant's contributions and (a) the Company's contributions and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the balance in the participant's vested account.

1. DESCRIPTION OF THE PLAN - *Continued*

Investments

Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan's investments were held in trust and administered by the trustees, Empower Trust Company, LLC for 2024. All investment information disclosed in the accompanying financial statements and supplementary schedule was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

Vesting

Participants are immediately and fully vested in all contributions to their accounts, including participant deferrals, employer Safe Harbor matching contributions, discretionary matching contributions, and nonelective contributions. Because all contributions are fully vested upon allocation, participants have a nonforfeitable right to their entire account balance, and the Plan does not maintain any forfeiture accounts.

Notes Receivable from Participants

The Plan permits participants to borrow a minimum of \$1,000 up to 50% of their vested account balance not to exceed \$50,000. Notes are secured by the balance in the participant's account and as of December 31, 2024, bore interest rates ranging from 4.25% to 9.50%. Interest rates are based on the Prime Rate plus 1% published in the Wall Street Journal on the first business day of the month the loan is originated and is commiserate with local prevailing rates. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within 12 to 60 months for general purpose loans and 61 to 180 months for principal residence loans. Participant notes receivable are valued at their outstanding principal balance plus accrued and unpaid interest.

Distribution of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive his or her contribution and the vested portion of the employer's contribution in a lump sum or annual installments over a reasonable period of time. For termination of service due to other reasons, participants with vested benefits equal to or less than \$5,000 will receive a lump sum distribution. Under certain circumstances, participants may withdraw their account balances prior to the occurrence of these events.

Forfeitures

The plan document allows forfeitures to be used to reduce employer contributions or pay plan expenses. Although all participants are fully vested, forfeitures may arise from administrative corrections such as excess or erroneous employer contributions. During the year ended December 31, 2024, forfeitures of \$9,744 were used to offset employer matching contributions, and no forfeiture balance remained at year-end.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and the Plan. In the event of Plan termination, participants would become 100% vested in their employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America, except that benefits paid to Plan participants are recorded on a cash basis.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, disclosure of contingent assets and liabilities. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on the investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Contributions

Contributions from employees are recorded as they are withheld from the participant's wages.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Risks and Uncertainties

The Plan provides for investments in securities that are exposed to various risks, such as interest rate, currency exchange rate, credit and overall market fluctuation. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. See Note 4 for the three levels of the fair value hierarchy applicable to the Plan.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value: The Plan invests in a stable value collective trust valued at the NAV of the units of a bank collective trust. The NAV, as provided by the trustee, is used as a readily determinable fair value to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This readily determinable fair value is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Fixed Annuities: Valued at fair value based on contract values as reported by the insurance company, which approximate the present value of future cash flows using observable market inputs such as current interest rates and yield curves. These investments are classified as Level 2 within the fair value hierarchy.

Self-Directed Brokerage: Investments held in self-directed brokerage accounts consist primarily of mutual funds and publicly traded securities valued using quoted market prices (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - *Continued*

Federal Income Tax Status

The Plan is a non-standardized defined contribution prototype plan sponsored by Empower Trust Company, LLC. The prototype plan has received a letter from the Internal Revenue Service as to its qualified status. The Plan obtained its latest opinion letter on November 14, 2022, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

For the year-ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through the date of the independent auditor's report, which is the date the financial statements were available to be issued. Effective January 1, 2025, the assets of the Star Seed, LLC 401(k) Plan were merged into the Native Seed, LP 401(k) Plan pursuant to a board-approved merger resolution dated September 3, 2024.
