Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Acorn Stairlifts, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Plan Description

The following description of the Acorn Stairlifts, Inc. 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering all full-time employees of Acorn Stairlifts, Inc. (the "Company") who have completed three consecutive months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Eligibility* – The Plan substantially covers all employees of the Company who have completed one hour of service in three consecutive months and are age twenty-one or older. Once an eligible employee has satisfied the eligibility requirements the employee will become a participant in the Plan on the first day of the month next following the date you satisfy the eligibility requirements.
- c) *Employee Contributions* – Each year participants may contribute up to 90% of annual compensation, as defined by the Plan, subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans. The Plan includes an automatic deferral feature. The Company withholds 3% of compensation as a pre-tax contribution unless the participant opts not to participate in the Plan.
- d) *Employer Contributions* – For the year ended December 31, 2024 and 2023, the Company made a matching contribution of 50% of the first 6% of compensation that each participant contributed to the Plan. The matching contributions are discretionary and determined annually. Additional profit sharing amounts may be contributed at the discretion of the Company. No such additional contributions were made for the years ended December 31, 2024 and 2023.

- e) *Investment Options* – Participants direct the investment of their contributions and the Company’s contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or internet. Participants who do not select specific investments are invested in accordance with the default investment alternatives established under the Plan.
- f) *Participants Accounts* – Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses maybe charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- g) *Vesting* – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s matching contribution and discretionary profit sharing contributions is based on years of continuous service. A participant is vested 100% after four years of credited service or upon the events of death, disability or attaining normal retirement age.
- h) *Notes receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant’s account and bear interest at prime rate plus 1.0%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.
- i) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution or rollover to an individual IRA or another qualified plan.

- j) *Forfeited accounts* – Forfeitures of nonvested balances may be used to reduce employer contributions or pay plan expenses. As of December 31, 2024 and 2023 respectively, there were \$38,055 and \$4,179 in forfeited non-vested accounts. Forfeitures of \$54,855 were used to reduce employer contributions and forfeitures of \$25,413 were used to pay plan expenses during 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the origination of notes receivable from participants as well as participant distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through October 15, 2025, which is the date the financial statements were available to be issued. No events have occurred since December 31, 2024 that require recognition or disclosure in the financial statements.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair

value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund – Stable value option is a deposit liability of Transamerica with no underlying assets and are based on the general unallocated account of Transamerica and the risk of investment is based on Transamerica's insurance ratings. Regardless of the activity of the Transamerica general fund, Transamerica pays the stated interest rate and backs the capital deposit where the "risk" is measured by the insurance credit rating. The stable value fund is considered fairly valued at contract value which is the equivalent of fair value and is included in level 2 of the fair value hierarchy.

Common Trust Funds - Common trust funds are valued based on the net asset value reported by the trust manager as of the financial statement dates, which may reflect recent transaction prices, evaluations based on pricing services or other observable input. The common trust funds are issued by Blackrock and T. Rowe Price and hold investments in accordance with stated objectives.

- T. Rowe Price Blue Chip Growth Trust, which focuses on "blue chip" companies with leading market positions, seasoned management teams, strong financial conditions, and above-average growth and profitability.
- BlackRock EAFE Equity Index Securities seeks to track the investment results of an index composed of large- and mid-capitalization developed market equities.

- BlackRock Equity Index Fee, seeks to achieve investment results that are similar to the price and yield performance, before fees and expenses, of the S&P 500 Index.
- BlackRock Mid Cap Equity Index Fee, seeks to track the investment results of an index composed of mid-capitalization U.S. equities.
- BlackRock Russell 2000 Index Fee, invests in a portfolio of assets whose performance seeks to match the performance of the Russell 2000 Index.

Guaranteed Investment Contract – Valued by discounting the related cash flows based on current yields of similar instruments, as calculated by the contract provider. Fair value equals the contract value prior to termination. The value is subject to the general financial condition of the issuer of the investment contract as a component of validating whether the calculated contract value of the guaranteed contract is an accurate value.

6. Guarantee Investment Contract (GIC) with Insurance Company

The Key Guaranteed Portfolio Fund is a benefit-responsive investment contract held with Great-West Life & Annuity Insurance Company (Great West), an affiliate of Empower. Great West maintains the contributions in a general account. The GIC is included in the financial statements at fair value as reported to the Plan by Great West. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Contract value is equal to fair value prior to contract termination. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The investment contract (Great West Key Guaranteed Portfolio Fund) is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly.

The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average yield for 2024 was 1.41% and for 2023 was 1.23%.

7. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

8. Related Party Transactions and Party in Interest Transactions

Empower Trust Company, LLC (Empower) was the recordkeeper until May 2024. Transamerica Financial Life Insurance Company Inc. (TFLIC) is the current recordkeeper and custodian of the Plan's assets beginning May 2024. Both qualify as parties-in-interest. Fees paid by the Plan for recordkeeping services, investment management services, and other administrative fees amounted to \$92,908 for the year ended December 31, 2024. Empower also maintains the Key Guaranteed Portfolio Fund, an investment contract written by Empower affiliate Great West.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

10. Tax Status

The Plan is a pre-approved defined contribution plan (“Pre-approved Plan”) sponsored by Bates & Company. Bates & Company obtained its latest opinion letter dated June 30, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.


