As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, the plan administrator instructed us not to perform, and we did not perform, any auditing procedures with respect to the information summarized in Note 4, which was certified by Reliance Trust Company, the trustee of the Plan, except for comparing the information with the related information included in the financial statements and supplemental schedule. We have been informed by the plan administrator that the trustee holds the Plan's investment assets and executes investment transactions. The plan administrator has obtained a certification from the trustee as of and for the year ended December 31, 2020, that the information provided to the plan administrator by the trustee is complete and accurate.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Harbor Truck Bodies, Inc. 401(k) Salary Reduction Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Harbor Truck Bodies, Inc. 401(k) Salary Reduction Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Harbor Truck Bodies, Inc. 401(k) Salary Reduction Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Harbor Truck Bodies, Inc. 401(k) Salary Reduction Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN

The following brief description of the Harbor Truck Bodies, Inc. 401(k) Salary Reduction Plan (the "Plan") is provided for general information purposes only. The Plan was amended in June of 2015 and most recently in February of 2022. Participants should refer to the plan agreement for more complete information.

General

The Plan is a qualified retirement savings plan that contains a deferred arrangement and is maintained and administered for the exclusive benefits of participants and their beneficiaries. It is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all subsequent laws and modifications.

Eligibility

Every employee of Harbor Truck Bodies, Inc. (the "Company") shall become eligible to participate in the Plan if they are at least 21 years of age and have completed one year of service, defined as 1,000 hours of service. If 1,000 hours of service is not completed in the first 12 months of employment, an employee will be credited with a year of service provided he completes 1,000 hours in any following calendar year.

Company contributions

The Company may decide to make a non-elective contribution to the Plan, although the Company is not required to do so. The non-elective contribution will be allocated to all employees eligible in the Plan. A participant employed by the Company on December 31 is entitled to receive this allocation. If employment terminates prior to December 31 due to death, disability or attainment of age 65, the Plan's normal retirement age, the participant will be eligible to receive any non-elective contribution that the Company may make for the year in which employment was terminated.

Deferral election

Each participant and each individual who will become a participant in the Plan year may elect to defer a portion of his compensation for that year and to have the deferred amount contributed directly by the Company to the Plan. The amount of each participant's compensation that may be deferred can range from 1% to 15% and shall be an amount not to exceed the maximum allowable by law. There are also various provisions affecting highly compensated employees.

1. DESCRIPTION OF PLAN (CONTINUED)

Participant accounts

A separate account will be maintained for each participant covering Company non-elective contributions, deferrals and any other applicable account. The Company's contribution shall be allocated to the account of each participant in the proportion that each participant's compensation bears to the total compensation of all participants. The participant deferrals shall be allocated to his deferral account.

Vesting

A participant shall always be one hundred percent (100%) vested in his elective deferrals and will be vested in non-elective Company contributions based upon the following schedule:

Years of service:	<u>Vested</u>
Less than 2 years	0%
At least 2 years, but less than 3	20%
At least 3 years, but less than 4	40%
At least 4 years, but less than 5	60%
At least 5 years, but less than 6	80%
6 or more years	100%

Participant loans

Participant loans are evidenced by promissory notes with level amortization and repayable on a regular schedule with monthly payments including interest ranging from 5.25% to 10.25% through November of 2027. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. As of December 31, 2024 and 2023, outstanding loans receivable from participants were \$6,769 and \$9,249, respectively.

Payment of benefits

The Plan's normal retirement age is 65 years. A participant's benefit shall be distributed upon termination either as a single lump sum payment or as a direct rollover into another qualified plan based upon the terms of the Plan.

Forfeited accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$70,589 and \$39,868, respectively. These accounts will be used to reduce future employer contributions. For the years ended December 31, 2024 and 2023, no employer contributions were made.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of accounting

Employer and employee contributions are accounted for on the accrual method and benefits paid are accounted for on the cash method. There were a total of \$4,572 and \$4,643 of employee contribution receivables as of December 31, 2024 and 2023, respectively.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Net unrealized appreciation or depreciation in the fair value of investments are reflected in the statement of changes in net assets available for Plan benefits as a result of stating investments at fair market value.

Notes receivable from participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest net of any allowance for uncollectible amounts, as estimated by management.

Fair value of financial instruments

The carrying value of cash and cash equivalents, accounts receivable and accounts payable approximate fair value due to the short-term nature of these instruments.

Payment of benefits

Benefits are recorded when paid.

Operating Expense

The costs of administration of the Plan shall be borne by the Plan to the extent they are not paid by the Company. Commissions and charges relative to the purchase and sale of investments are paid by the Plan and capitalized as part of the investment costs.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs are those that are observable, either directly or indirectly, for the asset or liability other than quoted prices included in Level 1; and Level 3 inputs, which are unobservable and are used when level 1 and 2 inputs are not available. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs, if any, were only used when Level 1 or Level 2 inputs were not available.

Level 1 fair value measurements

The fair value of mutual funds and money market funds are based on quoted net asset values of the shares held by the Plan at year-end. The fair values of common stock, corporate bonds, and U.S. Government securities are based on quoted market prices.

5. INVESTMENTS (CONTINUED)

Investment contracts

The guaranteed investment contracts are invested under a fully benefit-responsive investment contract with Invesco Stable Asset Fund. Invesco Advisors, Inc. maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract values, as reported to the Plan by the trustees, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Invesco Advisors, Inc. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan's sponsor that would cause a significant withdrawal from the plan, or (d) the failure of the plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

The current rates averaged approximately 3.07% and 3.03% for 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

6. RELATED PARTY TRANSACTIONS

Certain Plan investments are in common collective trusts managed by the trustees of the Plan. These transactions qualify as party-in-interest transactions. These party-in-interest transactions are allowable under ERISA regulations.

ADP Retirement Services, a party-in-interest to the Plan, is responsible for the day-to-day administration and operation of the Plan. As of December 31, 2024 and 2023, total administrative fees paid by the Plan to ADP Retirement Services totaled \$333 and \$345, respectively.

7. PLAN TERMINATION

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

8. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. Generally, the Plan's tax returns remain open for federal income tax examination for three years from the date of filing.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

11. SUBSEQUENT EVENTS

In January of 2025, all of the Plan's participants and assets were transferred to a new plan.

Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.
