Note - 1 Description of Plan

The following description of Wayne Action Group for Economic Solvency, Inc. Employee Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The WAGES Employee Benefit Plan (the "Plan") is a self-funded employee welfare benefit plan sponsored and administered by Wayne Action Group for Economic Solvency, Inc. (the "Plan Sponsor"). The Plan provides medical and prescription drug benefits to eligible employees and their dependents. The Plan is effective January 1, 2023, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan year runs from January 1 through December 31 and has been assigned ERISA Plan Number 501. WAGES serves as the Plan Administrator and named fiduciary, with responsibility for overall oversight of the Plan, including ensuring compliance with applicable law and proper administration of benefits.

Benefits Provided

The Plan provides coverage for medically necessary health services and prescription drugs. The plan operates as a non-grandfathered, self-funded plan and the benefits are administered in accordance with federal requirements, including the Mental Health Parity and Addiction Equity Act (MHPAEA) and the Affordable Care Act (ACA) preventive-services mandate. Retired employees are not entitled to similar health benefits. The Plan also provides continuation of certain health benefits upon termination of employment in accordance with the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

The Plan Sponsor periodically evaluates the Plan's funding method and sets the required contributions from Participants and/or the Plan Sponsor. Contribution levels are established using the VERIS program's Benecon Risk Financing Model and annual funding calculations. The Plan Sponsor funds the Plan in a manner consistent with the IRC and ERISA, and the means of funding is at the Sponsor's discretion; participant contributions are used to cover Plan costs and are expended immediately.

Note - 2 Summary of Significant Accounting Policies

Basis of accounting

The preparation of these financial statements of the Plan and accompanying notes in conformity with United States of America Generally Accepted Accounting Principles requires management to make estimates and assumptions that affect the amounts reported. Actual results could differ from those estimates.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Cash and cash equivalents

Cash and cash equivalents comprise cash at banks and cash in hand. It represents money market funds or short-term investments with original maturities of three months or less from the date of purchase, except for those amounts that are held in the investment portfolio which are invested for long-term purposes.

Claim fund income

Claim fund revenue is recognized in the month of coverage based on the contracted claims funding rate per employee per month established by Benecon's actuarial team. The applicable single/family tier rate is applied to current enrollment, and any changes in headcount are reflected in the subsequent month's billing. Revenue is recorded in the period to which the coverage relates, regardless of when amounts are billed or collected. Related claim fund expenses are recorded in the period in which medical and prescription claims are incurred and processed from the claim fund account.

Stop-loss premium income

Stop-loss premium revenue is recognized in the period of coverage using the specific and aggregate stop-loss premium rates applied to enrolled employees each month. Related stop-loss premium expenses are recorded in the period incurred, and reimbursements from carriers are recognized when the underlying claims giving rise to reimbursement have been settled and payment is reasonably assured.

Benefit Payments and Claims Incurred but Not Reported (IBNR)

Benefit payments under the Plan consist primarily of medical and prescription drug claims. These claims are reported as claim fund expenses in the accompanying financial statements and are recorded in the period in which they are incurred and approved for payment from the claim fund. The Plan also records an accrual for claims incurred but not reported (IBNR) as of year-end. The IBNR estimate is based on information provided by the Plan's Program Manager, Benecon Group and actuarial methods that consider historical claims experience, enrollment data, trend adjustments, and provisions for adverse deviation. Note - 1 Description of Plan

The following description of Wayne Action Group for Economic Solvency, Inc. Employee Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The WAGES Employee Benefit Plan (the "Plan") is a self-funded employee welfare benefit plan sponsored and administered by Wayne Action Group for Economic Solvency, Inc. (the "Plan Sponsor"). The Plan provides medical and prescription drug benefits to eligible employees and their dependents. The Plan is effective January 1, 2023, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan year runs from January 1 through December 31 and has been assigned ERISA Plan Number 501. WAGES serves as the Plan Administrator and named fiduciary, with responsibility for overall oversight of the Plan, including ensuring compliance with applicable law and proper administration of benefits.

Benefits Provided

The Plan provides coverage for medically necessary health services and prescription drugs. The plan operates as a non-grandfathered, self-funded plan and the benefits are administered in accordance with federal requirements, including the Mental Health Parity and Addiction Equity Act (MHPAEA) and the Affordable Care Act (ACA) preventive-services mandate. Retired employees are not entitled to similar health benefits. The Plan also provides continuation of certain health benefits upon termination of employment in accordance with the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

The Plan Sponsor periodically evaluates the Plan's funding method and sets the required contributions from Participants and/or the Plan Sponsor. Contribution levels are established using the VERIS program's Benecon Risk Financing Model and annual funding calculations. The Plan Sponsor funds the Plan in a manner consistent with the IRC and ERISA, and the means of funding is at the Sponsor's discretion; participant contributions are used to cover Plan costs and are expended immediately.

Note - 2 Summary of Significant Accounting Policies

Basis of accounting

The preparation of these financial statements of the Plan and accompanying notes in conformity with United States of America Generally Accepted Accounting Principles requires management to make estimates and assumptions that affect the amounts reported. Actual results could differ from those estimates.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Cash and cash equivalents

Cash and cash equivalents comprise cash at banks and cash in hand. It represents money market funds or short-term investments with original maturities of three months or less from the date of purchase, except for those amounts that are held in the investment portfolio which are invested for long-term purposes.

Claim fund income

Claim fund revenue is recognized in the month of coverage based on the contracted claims funding rate per employee per month established by Benecon's actuarial team. The applicable single/family tier rate is applied to current enrollment, and any changes in headcount are reflected in the subsequent month's billing. Revenue is recorded in the period to which the coverage relates, regardless of when amounts are billed or collected. Related claim fund expenses are recorded in the period in which medical and prescription claims are incurred and processed from the claim fund account.

Stop-loss premium income

Stop-loss premium revenue is recognized in the period of coverage using the specific and aggregate stop-loss premium rates applied to enrolled employees each month. Related stop-loss premium expenses are recorded in the period incurred, and reimbursements from carriers are recognized when the underlying claims giving rise to reimbursement have been settled and payment is reasonably assured.

Benefit Payments and Claims Incurred but Not Reported (IBNR)

Benefit payments under the Plan consist primarily of medical and prescription drug claims. These claims are reported as claim fund expenses in the accompanying financial statements and are recorded in the period in which they are incurred and approved for payment from the claim fund. The Plan also records an accrual for claims incurred but not reported (IBNR) as of year-end. The IBNR estimate is based on information provided by the Plan's Program Manager, Benecon Group and actuarial methods that consider historical claims experience, enrollment data, trend adjustments, and provisions for adverse deviation. Related stop-loss reimbursements are recognized when the underlying claims have been paid and collection from the carrier is reasonably assured. Actual results may differ from these estimates.
