Note 1. Description of the Plan

The following description of the American Trim, L.L.C. Employee Benefit Plan (Plan), formerly American Trim L.L.C. Health and Dental Plan, provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which is available from the Plan Administrator.

General

The Plan provides health and other benefits covering certain employees of American Trim, L.L.C. (Company) and eligible dependents. The employees of Cullman Products, a division of American Trim, L.L.C., are covered via the Cullman Products Group Health & Dental Plan (Cullman Plan), which is merged into the Plan and is a fully insured plan. The employees of Erie Ceramic Arts Company, L.L.C., a wholly owned subsidiary of American Trim, L.L.C., are covered via the Erie Ceramic Arts Company Thrift Incentive Plan (Erie Plan), which is merged into the Plan and is a fully insured plan. The Plan carries a stop-loss coverage of \$175,000 per eligible participant with no aggregate limit. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Company's chief executive officer, chief financial officer, and chief operating officer are trustees of the Plan.

Payment of Benefits and Premiums

The Plan provides health benefits for both basic and major medical expenses, dental expenses, and prescription drugs to eligible full-time employees (who average a minimum of 30 hours of service each week) and to covered dependents.

United HealthCare Services, Inc. (UMR) processes medical claims of participants and dependents and makes payments to participants and providers. Premiums paid by the Plan for medical and dental benefits of the Cullman Plan and Erie Plan participants are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

Contributions

The Company makes contributions to the Plan as required to provide for payment of claims and administrative expenses. Active employees are required to make weekly or biweekly contributions to the Plan through payroll deductions.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to modify the benefits provided to active employees, discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all claims incurred prior to such termination shall be paid.

Health Reimbursement Arrangement

The Plan has a health reimbursement arrangement (HRA) that is funded solely through Company contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year. The employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable upon termination once the employee leaves the employer.

Flex Spending Accounts

The Plan offers flexible spending accounts (FSA) that are funded solely through employee contributions. The FSA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year. The employer is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses; and remaining amounts are not portable upon termination once the employee leaves the employer.

Note 2. Summary of Significant Accounting Policies

Method of Accounting

The accompanying financial statements are prepared on the accrual method of accounting.

Other Plan Benefits

Plan liabilities for health claims incurred, but not reported (IBNR), are estimated based upon historic claims experience and actual claims reported subsequent to the Plan year-end. Additional accruals are included for the estimated ultimate cost of future claims only if such claims are covered as of the Plan's fiscal year-end and the Plan is obligated to pay for the care regardless of continued participation in the Plan.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, benefit obligations and changes therein, IBNR and claims payable at the date of the financial statements. Actual results could differ from those estimates.

Plan Tax Status

The Plan has not requested a determination letter from the Internal Revenue Service stating that the Plan is tax-exempt. As an employee welfare benefit plan, the Plan is required to operate in conformity with the Internal Revenue Code and ERISA. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and ERISA.

Health Reimbursement Arrangement

There are no amounts included in the accompanying statements of net assets available for benefits that remain to reimburse participants for qualifying medical expenses as of December 31, 2024 and 2023.

Flex Spending Accounts

Included in the accompanying statements of net assets available for benefits are amounts available to reimburse participants for qualifying medical expenses as of December 31, 2024 and 2023, totaling \$8,033 and \$12,790, respectively. Claims incurred before Plan year-end that were submitted after year-end (but before the date defined by the Plan agreement) totaled \$64 and \$6,561 relating to 2024 and 2023, respectively. Forfeited amounts were used by the Company to offset Company administrative expenses in the year forfeited.

Note 3. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Fees for general administration, record keeping and stop-loss coverage paid by the Plan to third-party administrators were \$589,278 and \$472,217 for the years ended December 31, 2024 and 2023, respectively.

The Company provides certain administrative services at no cost to the Plan.
