***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed an audit of the accompanying financial statements of Creole Cuisine Restaurant Concepts 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Creole Cuisine Restaurant Concepts 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1) Description of plan

The following description of the Creole Cuisine Restaurant Concepts 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan sponsored by Ammari of Louisiana, LLC (Company or Employer). The Plan covers substantially all employees of the Company, except for union employees, non-resident aliens, highly compensated employees, waiters, waitresses and hourly employees. Employees are eligible after completing 90 days and one thousand hours of service and having attained the age of twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Participant contributions

Participants may elect to contribute and defer a percentage of their eligible earnings each pay period, as defined by the Plan, subject to further limitations imposed by provisions of the Internal Revenue Code. Participants may make after-tax voluntary contributions, as defined by the Plan. In addition, a participant who has attained age 50 before the close of the plan year shall be eligible to make catch-up contributions in accordance with limitations under the Internal Revenue Code.

(c) Employer contributions

(i) Basic matching

The Employer contributes to the Plan in the form of a matching contribution in an amount equal to 50% of a participant's elected deferral; however matching contributions will not be made with respect to participant contributions in excess of 6% of eligible earnings.

(ii) Employer non-elective contributions (profit-sharing contributions)

The Employer may make a profit-sharing contribution at its discretion, allocated on a uniform percentage of included compensation or a uniform dollar amount. Participants must be employed on the last day of the Plan year. There were no profit sharing contributions made for the years ended December 31, 2024 and 2023.

(d) Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. Participants vest 20% each year, starting in year one and are fully vested after five years of service.

(e) Forfeitures

Forfeited balances of terminated participants non-vested accounts are used to reduce Employer contributions and administrative expenses. During 2024 and 2023, \$8,039 and \$4,596, respectively, of forfeited participant accounts were used to reduce the Employer's contributions. At December 31, 2024 and 2023, forfeited non-vested accounts available to offset future Employer contributions or administrative expenses totaled \$68,691 and \$38,773, respectively.

(f) Participant accounts

Each participant's account is credited with (a) the participant's contribution, (b) allocation of Plan earnings and administrative expenses, (c) the Employer's contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(g) Payment of plan benefits

Upon termination of services due to death, disability, or retirement, a participant may elect to receive their benefits in installment payments, or a lump sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions are permitted after attaining age 59 ½. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan. For vested benefits of a terminated participant not exceeding \$5,000, the plan administrator has the discretion to pay such benefits as a lump sum as soon as administratively feasible.

(h) Administrative expenses

The Company absorbs the Plan's administrative expenses. Administrative expenses paid by the Plan arise from processing fees that are allocated among the respective participants.

(i) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(j) Participant loans

Participants borrowing from their account is not permitted.

2) Summary of significant accounting policies

(a) Basis of accounting

The accompanying financial statements have been prepared on an accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because the contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

(b) Investment valuation and income recognition

The Plan's investments are stated at fair value (except the fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (loss) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of realized gains or losses, and the unrealized appreciation of those investments. For the years ended December 31, 2024 and 2023, investment income per the statements of changes in net assets available for benefits consisted of interest and dividend income of \$84,380 and \$33,459, respectively, and net appreciation in fair value of investments of \$217,956 and \$185,025, respectively.

(b) Investment valuation and income recognition (continued)

Total investment income was \$302,336 for 2024 and \$218,484 for 2023. These amounts are reported on Form 5500, Schedule H, line 2i(10), as net investment gain from registered investment companies. There are no reconciling differences between total investment income reported in the financial statements and total investment income reported in the Form 5500; the difference relates solely to presentation format.

(c) Use of estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America, requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

(d) Risks and uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(e) Payment of benefits

Benefits are recorded when paid. There were no amounts allocated to accounts of participants who have elected to withdraw from the plan but not yet been paid as of December 31, 2024 and 2023.

(f) Excess deferrals

During 2023, the Plan identified and returned excess participant deferrals totaling \$13,857 in accordance with applicable Internal Revenue Code requirements.

3) Group annuity contract

The Plan has a group annuity contract with Empower Annuity Insurance Company of America (Empower) that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product of Empower. The methodology for determining the interest crediting rate is based on the earnings of the underlying general account investments, adjusted for participant withdrawals and administrative expenses. The contract meets the criteria for a fully benefit-responsive investment contract and, accordingly, is reported at contract value. Contract value, which approximates fair value, is the relevant measure for such contracts because it represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value reflects contributions made under the contract, plus earnings credited, less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The issuer is contractually obligated to repay principal and to provide a guaranteed minimum interest rate, which may not be less than zero percent. The crediting rate is reviewed quarterly and declared in advance by Empower. The average annualized crediting rate was approximately 1.45% for 2024 and 1.35% for 2023.

Certain events may limit the ability of the Plan to transact at contract value with the issuer, including Plan termination, a complete or partial Plan-level withdrawal, a Plan merger, or a significant change in the Plan's investment structure. The plan administrator does not believe that any such events are probable of occurring. The contract is backed by the general account of Empower, and participants do not have any claim against the specific underlying assets of the issuer. The issuer's ability to meet its obligations under the contract is dependent on its financial condition. There are no reserves against contract value for credit risk of the contract issuer or otherwise, as the issuer is considered financially sound and investment-grade by major rating agencies. Contract value which approximates fair value at December 31, 2024 and 2023 was \$90,391 and \$77,375 respectively.

4) Federal income taxes

The Plan adopted a prototype plan document. The prototype plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the letter, including amendments made to comply with recent law changes. The Plan itself has not separately applied for a determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes had been included in the Plan's financial statements.

United States generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to United States federal and state income tax examinations by tax authorities for a period of three years beyond the filing of those returns.

5) Certified investment information

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, a qualified institution.

6) Investments

The Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$217,956 and \$185,025 for the years ended December 31, 2024 and 2023, respectively.

7) Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. That hierarchy gives the highest priority to unadjusted quoted prices in active markets for

identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurements level within the fair value hierarchy is based on the lowest level of any inputs that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common collective trust:* Valued at the net asset value (NAV) of units held. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisors reserve the right to temporarily delay the withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* Shares held in mutual funds traded on national securities exchange are valued at the net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8) SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and in subsequent years, there was no material impact to the Plan's financial statements for 2023 and 2024.

9) Related party transactions

The Plan invests in mutual funds and investment contracts offered and managed by Empower Trust Company, LLC. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

10) Prohibited transactions

During the Plan year ended December 31, 2024, employee withholdings in the amount of \$66,986, were not remitted within the appropriate period by the Company. These transactions constitute prohibited transactions as defined by ERISA. Lost earnings on the withholdings have not been remitted to the Plan as of the date of this report.

During the Plan year ended December 31, 2023, employee withholdings in the amount of \$81,438, were not remitted within the appropriate period by the Company. These transactions constitute prohibited transactions as defined by ERISA. Lost earnings on the withholdings have not been remitted to the Plan as of the date of this report.

11) Subsequent events

The Plan has evaluated subsequent events through the date of the independent auditors' report, the date which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
