## INDEPENDENT AUDITORS' REPORT

To the Trustees of the

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of National Products, Inc. 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of National Products, Inc. 401(k) Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of National Products, Inc. 401(k) Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

**NOTE A.--DESCRIPTION OF PLAN**

The following description of National Products, Inc. (Company or Sponsor) 401(k) Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a 401(k) defined contribution plan originally established by the Company effective May 1, 2015. The Plan was amended and restated January 1, 2018 to elect safe harbor 401(k) plan status, additionally amended and restated January 1, 2022 as part of the required Cycle 3 restatement and most recently amended effective December 31, 2022 to adopt the Secure and Cares Act provisions. See also Note M. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An employee becomes eligible to participate in the Plan after completing 60 days of service excluding collectively bargained employees, non-resident aliens, and leased employees. Additionally, a participant is eligible for the non-safe harbor match after completing one year of service with at least 1,000 hours. The entry dates are the first day of each calendar month coinciding with the satisfaction of the service requirements.

*Contributions:* The Plan is funded by eligible participant elective deferrals, which may be up to 100% of compensation, and matching contributions. The Company has a safe harbor matching contribution equal to 100% of elective deferrals up to 4% of eligible compensation. The Company may make additional non-safe harbor matching contributions for the benefit of the employees determined at the discretion of the Company, not to exceed 6%.

Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants attaining age 50 prior to the end of the calendar year may make "catch-up contributions" in addition to regular salary deferrals. Roth contributions are allowed. Contributions are subject to certain limitations.

*Participant Accounts:* Each participant's account is credited with the participant's contributions, allocation of any Company contributions, and allocations of Plan earnings (losses) and charged with an allocation of certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

*Vesting:* Participants are immediately vested in their elective deferrals, safe harbor matching contributions, and rollover contributions plus actual earnings thereon. Vesting in employer discretionary matching contributions and matching contributions made prior to the implementation of the safe-harbor match is based on a five-year graded vesting schedule in which the participant is 100% vested after five years of service at a rate of 20% per year after year one. Participants will be 100% vested upon death or disability.

*Notes Receivable from Participants:* Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the vested account balance. Loans are issued by the Plan and secured by the balance of the participant's account. Loan transactions are treated as a transfer between the investment fund and the loan fund. The loans are to bear a reasonable interest rate. Only one outstanding loan is permitted per participant. Loan terms cannot exceed five years unless the loan is used for the purchase of a principal residence. Principal and interest are paid through payroll deductions.

*Retirement:* The normal retirement date is the date a participant attains age 65. There is no early retirement.

*Payment of Benefits:* Upon death of a participant, payments made to a beneficiary shall be made in a lump sum payment before the end of the calendar year containing the 5<sup>th</sup> anniversary of the participant's death. Upon termination of service or disability, if a participant's account exceeds \$5,000, they may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. If, on termination of service, a participant has a vested interest in his account which is \$1,000 or less, payment may be made in a lump sum without the participant's consent. If the balance is less than \$5,000 but greater than \$1,000, without other election, the balance will be rolled over to an Individual Retirement Account without participant consent. In service distributions are allowed at age 59 ½ or for a qualified reservist in accordance with the provisions of the Plan. Hardship distributions are allowed in accordance with the provisions of the Plan.

*Forfeited Accounts:* Forfeitures of terminated participants' non-vested account balances may be used for employer contributions, to pay Plan expenses, restore forfeitures, or be re-allocated to participants' accounts. There were no forfeitures used by the Plan to offset employer contributions during the year ended December 31, 2024. The balance of unused non-vested account balances forfeited into the Plan as of December 31, 2024 and 2023, was \$3,066 and \$1,373, respectively.

*Investment Options:* Participants are allowed to direct their contributions and account balances in various investment options offered under the Plan. The Sponsor periodically reviews the investment options available to participants and changes them as warranted. Participants may change their investments at any time.

*Plan Expenses:* Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and not included in these financial statements. Fees relating to administration of notes receivable from participants and for certain withdrawals are charged directly to the participant's account and are included in administrative expenses.

*Plan Expenses (Continued)*: Certain investment related expenses, including 12(b)(1) and revenue sharing fees, as applicable, are deducted from each fund's earnings to arrive at net appreciation or depreciation in fair value of investments as reported in the accompanying statement of changes in net assets available for benefits.

**NOTE B.--SUMMARY OF ACCOUNTING POLICIES**

*Basis of Accounting*: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

*Use of Estimates*: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results could differ from those estimates.

*Investment Valuation and Income Recognition*: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determine the Plan's valuation utilizing information provided by the investment advisor and custodian. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

*Payment of Benefits*: Benefits are recorded when paid.

*Notes Receivable from Participants*: Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when incurred. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

*Excess Contributions Payable:* Amounts payable to participants totaling \$773 and \$937 for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to 2024 and 2023 contributions, respectively. The Plan distributed the 2024 and 2023 excess contributions prior to March 15, 2025 and 2024, respectively.

**NOTE C.--INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan has entered into an investment contract with Massachusetts Mutual Life Insurance Company (“Mass Mutual”). On December 31, 2020, Empower Annuity Insurance Company of America (“EAIC”) acquired the retirement business of Mass Mutual. Following an initial transition period, Empower became the sole administrator of this business in 2021. Mass Mutual/EAIC maintains the investments of the Plan in pooled separate accounts and in a guaranteed interest contract. The guaranteed interest contract is fully benefit-responsive and therefore reported at contract value.

Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate transactions under the terms of the plan.

Contract value, as reported to the Plan by Mass Mutual/EAIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023, was \$261,659 and \$210,229, respectively.

The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and was 2.80% and 1.35% at December 31, 2024 and 2023, respectively. The crediting rate may not be less than the minimum guaranteed rate of 1%. Such interest rates are reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Mass Mutual/EAIC. Such events may include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, and partial or total plan termination. Upon occurrence of any of these events, a market value adjustment may apply. The plan administrator does not believe the occurrence of any such event which would limit the Plan's ability to transact at contract value are probable of occurring.

Mass Mutual/EAIC may terminate the contract by written notice for certain reasons which include the following: (1) the Plan or Plan trust fails to maintain its special tax qualified or exempt status under 401(a) of the Code, (2) the Plan fails to provide the information necessary to perform the contract and the Plan fails to remedy the failure within 31 days from the notification date, (3) the Plan trust is amended in a way that adversely affects obligations under this contract, (4) all contracts in this class of business are amended, changed or altered due to changes in any applicable laws and it is determined that obligations under this contract or ability to maintain this class of business are thereby materially affected, (5) the assets held or the participants covered under the contract are less than the amount required for the contract to be a group annuity under any applicable insurance law, (6) the Plan changes such that the Plan is no longer considered to be an entity which is authorized or eligible to sponsor this contract, (7) no contributions are made to this investment during any consecutive 12-month period, (8) at any time the contributions or balances are less than the amount required for this class of business under the underwriting standards in effect as of the contract effective date.

The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

The Plan may terminate the contract at any time by written notice.

**NOTE D.--CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value and contract value of fully benefit-responsive investment contracts, interest income, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the custodian of the Plan, Empower Annuity Insurance Company of America.

**NOTE E.--FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at Net Asset Value (NAV) less operating expenses accrued but not deducted, if any, which is based on the fair value of the underlying investments held in such separate accounts. NAV per unit is used as a practical expedient for measuring fair value. Participant transactions (purchases and sales) may occur daily. There are no participant redemption restrictions for these investments. However, if the Company terminates the group annuity contract, redemption restrictions may apply to the pooled separate accounts. Valuation is daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE F.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments may be in funds managed by the custodian, Empower Annuity Insurance Company of America; therefore, these transactions would qualify as party-in-interest transactions. Additionally, the Plan may incur 12(b)(1) revenue sharing fees used to offset costs of administering the Plan. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**NOTE G.--PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan including employer contributions shall become fully vested and non-forfeitable

**NOTE H.--TAX STATUS**

Effective January 1, 2022, the Plan adopted a non-standardized pre-approved profit sharing plan with a cash deferral arrangement that received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

The Plan has been amended since the date of this determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

**NOTE I.--RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**NOTE L.--OPERATIONAL ERROR**

During the year ended December 31, 2024, it was discovered that one employee's contribution rate was entered incorrectly into the payroll system, resulting in a 1% pre-tax contribution as opposed to the elected 10% pre-tax contribution rate. The error was corrected with a qualified non-elective contribution (QNEC), in accordance with the prescribed IRS and DOL methods during 2025. Related missed safe harbor matching contributions and lost earnings were also contributed.

**NOTE M.--SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan was amended to add Ram Mounts USA LLC as a participating employer in the Plan.
