We have performed audits of the financial statements of The Lockwood Group, LLC 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### 1. Description of the Plan

The following description of The Lockwood Group, LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was effective January 1, 2007. The Plan was amended and restated effective January 1, 2017, for certain Plan changes to allow employees to participate in the Plan on the first day of hire, instead of after completing one year of service. The Plan covers all eligible employees of The Lockwood Group, LLC (the Company or Employer). Employees subject to a collective-bargaining agreement and non-resident aliens are excluded from participation in the Plan. Prior to January 1, 2024, temporary, seasonal, and part-time employees who work fewer than 1,000 hours, were also excluded from participating in the Plan.

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into law. Effective January 1, 2023, the SECURE Act 2.0 updated certain rules related to required minimum distributions, which impacted the Plan. Effective January 1, 2024, employees classified as part-time, temporary, or seasonal employees who have completed 500 hours of service during each of the immediate three consecutive years are eligible to participate in the Plan.

#### *Contributions*

Each year, participants may contribute up to 90% of pre-tax annual eligible earnings into the Plan. The total participant contribution in any year is subject to certain limitations of the Internal Revenue Code (IRC). The limit for 2024 was \$23,000. Participants who attained age 50 before the end of the Plan year were eligible to contribute up to an additional \$7,500 in 2024 as catch-up contributions. Participants may designate all or a portion of their elective deferrals as Roth elective deferrals. Participants may also rollover amounts from other eligible retirement plans, as defined in the Plan.

Participants are eligible to receive Company discretionary profit-sharing contributions upon completion of one year of service, as defined in the Plan. The Company may, in its sole discretion, make a profit-sharing contribution. For the year ended December 31, 2024, the Company made a profit-sharing contribution of \$200,000. Also, upon the completion of one year of service, the Company will make a safe harbor matching contribution equal to 100% of the employees' salary deferrals that do not exceed 3% of the employee compensation, plus 50% of the employee salary deferrals between 3% and 5% of the employees' compensation. During the year ended December 31, 2024, the Company made safe harbor matching contributions in the amount of \$1,682,807. On August 14, 2025, the Company remitted the \$200,000 discretionary profit-sharing contribution to the Plan for the year ended December 31, 2024.

#### *Participants Accounts*

The Plan maintains individual accounts for each Plan participant. Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of the Plan's investment earnings or losses and charged with benefits paid and certain administrative expenses.

Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are always 100% vested (which means that they are entitled to all of the amounts) in their accounts attributable to the following contributions:

- Salary deferrals, including Roth 401(k) deferrals and catch-up contributions
- Safe harbor matching contributions
- Employer profit-sharing contributions
- Rollover contributions

### ***Payment of Benefits***

A participant is eligible to receive a single lump-sum distribution on his or her vested account balance under the following circumstances: (a) retirement, (b) termination of employment, (c) disability, and (d) death. A participant is also eligible for in-service withdrawals after reaching the age of 59½. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$500 up to a maximum of the lesser of half of the vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. The loans are secured by assignment of a participant's vested interest in the Plan, and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed, as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions, or as a lump sum for the outstanding loan balance. Loan terms range from one to five years; however, terms may be longer for the purchase of a primary residence.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, there were \$11 and \$0 of forfeited non-vested accounts, respectively. These accounts may be used to reduce future employer contributions. No forfeited funds were used to fund employer contributions in 2024.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are presented under the accrual basis of accounting.

### *Use of Estimates*

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements and changes therein. Accordingly, actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### *Contributions Receivable*

Participant contributions and any related safe harbor matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### *Payment of Benefits*

Benefit payments are recorded when paid.

### *Administrative Expenses*

The Company pays the administrative costs of the Plan associated with any professional services provided to the Plan and pays the cost of communications to the participants. Administrative expenses paid directly by the Company are excluded from the financial statements. Loan origination and distribution fees are deducted directly from the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when earned. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

## **3. Certified Investment Information**

### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies for the Plan assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - This class primarily consists of publicly traded funds of registered investment companies. The mutual funds invest primarily in marketable equity securities. The fair value of these investments is determined by reference to the fair value of the underlying securities of the mutual funds. The net asset value (NAV) of the mutual fund's share is quoted on the exchange where the fund is traded. These funds are required to publish their daily NAV and to transact at that price.

*Common Collective Trust (CCT)* - This asset is valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to

ensure that securities liquidations will be carried out in an orderly business manner. The CCT is a direct filing entity.

In addition, the Plan is required to provide a 15-day advance written notice to the trustee prior to withdrawal of trust units; the notice period may be shortened or waived by the trustee at its sole discretion. The Plan has no unfunded commitments with the fund as of December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their accounts.

### 7. Tax Status

The Plan uses a pre-approved plan document designed by ADP, LLC, which the Plan has adopted via a non-standardized adoption agreement. The Internal Revenue Service (IRS) has informed ADP, LLC in an opinion letter dated October 6, 2020, that the pre-approved plan document is in compliance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan provides for various investments that, in general, are exposed to various types of risks, such as interest rate, credit, and market volatility risks. Further, due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Subsequent Events

Effective January 1, 2025, the Plan complied with the benefit provisions under SECURE Act 2.0 increasing the catch-up contribution limit for individuals aged 60-63 to the greater of \$10,000 (indexed for inflation) or 150% of the regular catch-up amount.

Effective on January 1, 2025, the Plan changed trustee from Reliance Trust Company to ADP Retirement Trust Services, LLC. State Street Bank and Trust Company remained the subcustodian of the Plan's assets.

Plan management has evaluated events subsequent through October 15, 2025, on which the financial statements were available to be issued. There were no other significant subsequent events requiring adjustment to the financial statements or disclosures.
