Notes to Financial Statements

December 31, 2024

1. Description of the Plan

The following description of the Capital of Texas Public Telecomm Council 403(b) DC Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution plan available to eligible employees of Capital of Texas Public Telecomm Council (the Employer). Employees are immediately eligible to participate in the Plan for elective deferrals upon date of hire. Effective January 1, 2024, employees who normally work less than 20 hours per week are generally excluded from participation in the Plan and effective December 1, 2024, employees who are eligible to participate in another plan of the Employer, as defined, are excluded. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Management of the Employer is responsible for oversight of the Plan. Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA and CREF), are the insurance carriers of the Plan. TIAA also serves as the recordkeeper of the Plan.

Contributions

Each year, participants may contribute up to the maximum allowed by law, as defined in the Plan. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time. Effective December 1, 2024, the Plan was amended to allow Roth contributions.

The Employer makes safe harbor nonelective contributions to the Plan equal to 4% of participant's eligible compensation. The Employer also makes an additional matching contribution equal to 100% of participant deferrals up to 3% of participant's compensation. Effective January 1, 2024, employees are immediately eligible to receive the safe harbor nonelective contributions and additional Employer matching contributions. Prior to January 1, 2024, employees were eligible to receive Employer contributions after one year of service if they were 21 years of age.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer's safe harbor nonelective contributions and the Employer additional matching contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in all contributions plus actual earnings on these contributions.

Note Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. If the loan is being taken from a TIAA or CREF Annuity, further limitations apply, as defined in the Plan. The notes are secured by the balance in the participant's account. The notes are required to bear interest and to be repaid over periods not exceeding five years, except for those utilized for the acquisition or improvement of a qualified principal residence. Principal and interest are paid ratably.

Payment of Benefits

Effective January 1, 2024, if the participant's vested benefit in the Plan does not exceed \$5,000 at the time of termination of employment, the participant's benefit may be distributed in a single lump-sum payment as soon as administratively feasible. If the participant has a vested benefit in the Plan that exceeds \$5,000 at the time of termination of employment, the participant may elect to maintain their account in the Plan, receive a lump-sum distribution, or rollover their account balance into another individual retirement account. The participant may also elect to receive installment payments of the vested portion of his or her account over a period not to exceed the life expectancy of the participant or the joint and last survivor life expectancy of the participant and the designated beneficiary, or to apply the vested portion of his or her account toward the purchase of an annuity contract. Participants may also withdraw their vested account balances at any time on or after the age of 59½, or upon retirement, death or disability.

Forfeitures

Participants are fully vested upon entrance to the Plan; therefore, no portion of account balances may be forfeited upon exit from the Plan.

2. Significant Accounting Policies

Basis of Accounting

The 2024 financial statements of the Plan are prepared on the accrual basis of accounting. The 2023 financial statements were prepared on the modified cash basis of accounting which is a comprehensive basis of accounting other than GAAP. The change in basis of accounting was to align with GAAP. Contribution receivable and contribution revenue totaling \$439,206 (\$421,217 relates to the operational defect noted in Note 12) would have been recorded as of and for the year ended December 31, 2023, if the 2023 financial statements were prepared on the accrual basis.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for its fully benefit-responsive investment contracts, which are valued at contract value (see Note 6). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by the investment advisors and TIAA and CREF. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Contributions from Plan participants and the safe harbor nonelective contributions and additional matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

2. Significant Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make scheduled repayments and the Plan administrator deems the note receivable to be in default, the note receivable balance is reduced and a benefit payment recorded.

Benefits Paid to Participants

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025 the date the financials were available to be issued.

3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF.

4. Concentrations

The Plan has one investment representing greater than 20% of net assets available for benefits as of December 31, 2024 and 2023.

5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.
- Level 2 Inputs to the methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy for assets and liabilities is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

TIAA traditional annuity contracts (non-benefit responsive contracts) (referred to as an insurance general account in 2023): Valued at fair value which is equal to the accumulated cash contributions, interest credited, and transfers in less any withdrawals and transfers out.

Variable annuity accounts: Accounts invest primarily in equity securities, fixed-income instruments and short-term investments. Valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing.

5. Fair Value Measurements (continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

Real estate account (2023): Referred to as a pooled separate account in the prior year financial statements. Valued based on the net asset value of units as determined by TIAA and CREF based upon its valuation of the underlying real estate holdings or other real estate related investments using periodic external appraisals. This account is included with the variable annuity accounts in the 2024 fair value hierarchy table below.

5. Fair Value Measurements (continued)

In estimating fair value of investments in level 3, Plan management may use third-party pricing sources or appraisers. In substantiating the reasonableness of the pricing data provided by third parties, the Plan management evaluates a variety of factors including review of methods and assumptions used by external sources, recently executed transactions, existing contracts, economic conditions, industry and market developments and overall credit ratings.

6. TIAA Traditional Benefit Responsive Contracts

The Plan invests in fully benefit-responsive investment contracts with TIAA totaling \$282,149 and \$258,643 as of December 31, 2024 and 2023, respectively. TIAA maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract provides a guaranteed minimum rate of interest between 1% and 3%.

The contracts meet the fully benefit-responsive investment criteria and therefore are reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts, because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include amendments to Plan documents (including complete or partial Plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Employer or other events that cause a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guideline, a breach of material obligation under the contract, a material misrepresentation or a material amendment to the agreement without consent of the issuer.

7. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are in accounts of TIAA and CREF; therefore, these transactions qualify as party-in-interest transactions. Net appreciation and dividend and interest income from investments held with parties-in-interest totaled \$1,308,650 and \$65,507, respectively, in 2024. Notes receivable from participants and participant contributions are also considered to be party-in-interest transactions. Employer contributions are considered to be both party-in-interest and related party transactions.

8. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

9. Tax Status

The Plan adopted a volume submitter 403(b) plan sponsored by Pentegra Services, Inc. which received an opinion letter dated March 31, 2017, from the IRS which stated the plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. Delinquent Employee Deferrals Transmittals

During 2024, the Employer failed to remit certain Plan participant contributions totaling \$21 within the period prescribed by the DOL regulations. Delays in remitting contributions to the custodian were due to administrative errors, and during 2025, the Employer has made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays.

12. Operational Defect

For numerous years, participants were improperly denied entry to the Plan upon date of hire and were unable to make employee deferral contributions and receive employer safe harbor nonelective contributions until they had completed one year of service. Additionally, certain classes of employees were improperly excluded from participation in the Plan, and certain other operational errors occurred. The Employer consulted with an attorney and filed an application with the IRS under the Voluntary Correction Program ("VCP") during the year ended December 31, 2024 to correct these operational failures.

The Employer estimates that required corrections associated with the 2009 through 2023 plan years total \$456,641, including the related lost earnings. A receivable has been recorded in the accompanying 2024 financial statements for this amount, with an offsetting increase to contributions. Management intends to remit these funds to the Plan on behalf of the affected former and current participants once the IRS approves its VCP application, which contains its proposed methods of correction and underlying correction calculations.

As of December 31, 2023, no corrections were accrued for as the 2023 financial statements were prepared on the modified cash basis of accounting. A receivable and an offsetting increase to contribution totaling \$421,217 would have been recorded as of December 31, 2023 if the 2023 financial statements were prepared on the accrual basis.
