## INDEPENDENT AUDITORS' REPORT

To the Plan Administrative Committee of the  
PVR Technologies Employees Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- the information in the accompanying financial statements, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their

**NOTE 1: DESCRIPTION OF PLAN**

The following brief description of PVR Technologies Employees Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is defined contribution plan that was established on January 1, 2016, covering all eligible employees of the Company, as defined in the Plan Document of PVR Technologies, Inc., and StatMinds LLC (collectively, the company and plan Sponsor). Certain classes of employees as defined in the plan agreement as excluded from plan participation. The company has contracted Reliance Trust Company to serve as the Trustee and is responsible for administration and management of the Plan. The Plan is subject to the provisions of The Employment Retirement Income Security Act of 1974 (ERISA) and is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC).

Plan Administration:

The Company, being the Plan sponsor and the Plan Administrator (the Administrator) manages and is responsible for the operation and administration of the Plan. The company has contracted with Reliance Trust Company to act as trustee of the Plan.

Eligibility:

Employees become eligible to participate once they have attained the age of twenty-one and after they have completed three months of service. The Plan allows for automatic enrollment at a rate of 3%, on the first day of the month coinciding with or next following the date they meet the eligibility requirements. Employees excluded from the plan are as follows:

- Non-resident aliens
- Residents of Puerto Rico

Contributions:

Each year, participants may contribute an amount of eligible pretax annual compensation as defined in the Plan agreement, not to exceed the maximum statutory amount. Participants who are age 50 or older before the end of the Plan year can elect to make catch-up contributions to the Plan, not to exceed the maximum statutory amount. The annual elective deferral limit is \$23,000 for 2024 and the catch-up dollar limit for 2024 is \$7,500. The Plan allows for Roth deferral contributions, Roth rollovers. The employer may make a discretionary match. There may be special requirements for one to receive company contributions. The Company did not make any employer contribution match during the year December 31, 2024.

Rollovers

Employees may roll over eligible amounts from other qualified retirement plans or IRA to the Plan. Employees can also rollover Roth contributions from another qualified plan to this Plan, but rollovers are not permitted from a Roth IRA.

Investment:

The Plan provides for investments to be directed by participants into a number of investment options held by the Trustee. Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options and may change their investment options at any time directly through the Trustee.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant starts to vest 20% after two years of service and additional 20% each year thereafter and is 100% vested after six years of credited service.

Forfeitures:

Forfeitures are the non-vested portion of participants' account that are lost upon termination of employment. Forfeitures can be used to pay administrative expenses or to reduce any employer contributions. There was no forfeiture as of December 31, 2024 and 2023.

Individual Participant Account:

Each participant's account is credited with the participant's contribution, Plan earnings and losses, and Plan expenses as applicable to the Plan. Allocations of Plan earnings and losses are based on individual participant investment choices. All contributions/investments are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivable from Participants:

The Plan provides that participants may borrow from their fund accounts a minimum of \$500 up to maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The note issuances are accounted for as a transfer from the participant directed accounts into notes receivable from participant. The term for the notes to participants ranges from one to five years, or longer for the purchase of a primary residence no more than 30 years. The notes are secured by the balance in the participant's account and bear interest at market rates for similar notes. The interest rate for a note will be the rate in effect in the month your loan is effective. The notes receivable as of December 31, 2024, carry an interest rate of 7.5% to 10.25%.

Payment of Benefits:

Upon the satisfaction of certain distributable events, participants or their beneficiaries may elect to receive their vested account balance and are paid in accordance with plan provisions.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting:

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits, changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuations and Income Recognition:

The plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plans committee determines the plan's calculation policies utilizing information provided by Reliance Trust Company. See note 5 for discussion of fair value measurements.

Purchase and sales of securities were recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses investments bought and sold as well as held during the year.

Contributions:

Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are paid when they are incurred. Delinquent participant notes are recorded as distributions on the basis of the terms of the Plan agreement.

Plan Expenses:

In 2024, some Plan fees were paid by the Company and the amount is excluded from the Plan's financial statements. Investment/fund fees and participant transaction fees were charged to participants accounts as applicable.

Payment of benefits:

Benefits are recorded when paid

**NOTE 3: RISK AND UNCERTAINTIES**

The Plan invests in various investment Securities. Investment securities are exposed to various risks such as interest rate, overall market volatility, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 4: CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the Trustee of the Plan.

**NOTE 5: FAIR VALUE MEASUREMENT**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The Hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:  
Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds**

Mutual funds are registered with the U.S. Securities & Exchange Commission. The funds are valued at daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 6: PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS**

Plan investments are held by Reliance Trust Company. Any purchases and sales of these investments are performed in the open market at fair value. Plan related fees are paid to Reliance Trust Company and ADP, Inc. The Plan has other service providers. All these transactions while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 7: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**NOTE 8: INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved plan which received an opinion letter dated October 06, 2020 from the IRS stating that the form of the plan is qualified under Section 401 of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore believe that the Plan is qualified, and the related trust is tax- exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax position taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the law under similar statutes. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9: EXCESS CONTRIBUTIONS PAYABLE**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as liability with a corresponding reduction to contributions. The Plan is required to return the contributions to participants in the event certain non- discrimination tests defined under the IRC are not satisfied. As of December 31, 2024 and December 31, 2023 there is \$697 and \$21,313 respectively recorded as excess contributions payable.
