## **Note 1. Description of the Plan**

### ***General***

The following description of Heritage Pointe Communities 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

The Plan is a defined contribution plan sponsored by United Methodist Memorial Home (Sponsor) for the benefit of its employees. All employees (other than PRNs) are eligible to participate for elective deferrals upon their date of hire. Employees are eligible for matching and nonelective contributions upon attainment of age 18 and completion of one year of service (1,000 hours in a 12-month period).

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Nationwide Trust Company, FSB, (Nationwide) serves as Plan custodian. JHR Pensions, LLC, serves as the third-party administrator and service provider.

### ***Contributions***

Each year, participants may voluntarily contribute the maximum amount allowed by law of pretax annual compensation, as defined in the Plan Document, not to exceed limits established by the Internal Revenue Code.

The Plan includes an Eligible Automatic Contribution Arrangement (EACA). New participants are automatically enrolled at a 1% deferral rate, which increases by 1% each year up to a maximum of 10%, unless the participant elects otherwise.

The Sponsor may make discretionary matching and nonelective contributions. The matching formula and nonelective contribution amounts are determined annually at the Sponsor's discretion.

Participants may also make rollover contributions from amounts representing distributions from other qualified plans and certain Individual Retirement Accounts (IRA) as defined in the Plan Document.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows for special code Section 403(b) catch-up contributions for those participants with 15 years of service.

Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Plan assets are held in participant-directed custodial accounts invested in mutual funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Sponsor's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon.

Vesting in matching and nonelective contributions from the Sponsor is based on years of service: 25% after 1 year, 50% after 2 years, 75% after 3 years, and 100% after 4 years. Participants become fully vested upon death, disability, or attainment of normal retirement age (62). The nonvested balance, if any, is forfeited upon termination of service. Forfeitures are used to reduce Corporation contributions or pay Plan expenses.

***Payment of Benefits***

Termination, Retirement, Death, or Disability: Upon termination of employment, retirement, death, or disability, participants may elect to receive their vested account balance as a lump sum or in installments, subject to the terms of the investment arrangements.

In-Service Distributions: Allowed upon attainment of age 59½ or in the event of financial hardship, subject to plan and investment arrangement rules. Hardship withdrawals are permitted for medical, education, housing, funeral, casualty, and federally declared disaster expenses.

Mandatory Distributions: If a participant's vested account balance does not exceed \$5,000, a mandatory distribution will be made.

***Forfeited Accounts***

At December 31, 2024, forfeited nonvested accounts totaled \$1,869. These accounts will be used to reduce future contributions from the Sponsor or pay Plan expenses, as defined in the Plan Document. No forfeited nonvested accounts were used to reduce contributions from the Sponsor or pay Plan expenses during 2024.

***Notes Receivable from Participants***

The Plan does not permit participant loans.

***Plan Termination***

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their contributions from the Sponsor.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions***

Contributions from participants and the Sponsor are recorded in the year in which they are withheld from compensation or earned, respectively.

### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

### ***Administrative Expenses***

Administrative expenses may be paid by the Sponsor or the Plan, at the Sponsor's discretion.

### ***Plan Tax Status***

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and custodial document sponsored by American Pension Advisors, LTD. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of assets available for benefits.

***Subsequent Events***

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended and restated to increase the EACA initial enrollment percentage to 3%.

Effective May 1, 2025, the Plan was amended and restated to include participants made eligible through an acquisition executed by the Plan Sponsor.

**Note 3. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments as shown in the statement of net assets available for benefits as of December 31, 2024
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$20,130 of recordkeeping and asset management fees to the Plan's custodian and third party administrator during the year ended December 31, 2024.

The Sponsor provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

**Recurring Measurements**

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statement of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no investments classified as Level 2 or Level 3 at December 31, 2024.

**Note 6. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the Sponsor's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the Sponsor. While the Sponsor remitted all employee contributions to the Plan, contributions of \$10,743 were not remitted within the required time period for the year ended December 31, 2024. The Sponsor contributed the lost earnings, if any, on the late contributions in accordance with the Department of Labor's self-correction program during the year ended December 31, 2024.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matter – Supplemental Schedules Required by ERISA***

The supplemental schedules listed in the table of contents are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Note 1. Description of the Plan**

### ***General***

The following description of Heritage Pointe Communities 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

The Plan is a defined contribution plan sponsored by United Methodist Memorial Home (Sponsor) for the benefit of its employees. All employees (other than PRNs) are eligible to participate for elective deferrals upon their date of hire. Employees are eligible for matching and nonelective contributions upon attainment of age 18 and completion of one year of service (1,000 hours in a 12-month period).

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Nationwide Trust Company, FSB, (Nationwide) serves as Plan custodian. JHR Pensions, LLC, serves as the third-party administrator and service provider.

### ***Contributions***

Each year, participants may voluntarily contribute the maximum amount allowed by law of pretax annual compensation, as defined in the Plan Document, not to exceed limits established by the Internal Revenue Code.

The Plan includes an Eligible Automatic Contribution Arrangement (EACA). New participants are automatically enrolled at a 1% deferral rate, which increases by 1% each year up to a maximum of 10%, unless the participant elects otherwise.

The Sponsor may make discretionary matching and nonelective contributions. The matching formula and nonelective contribution amounts are determined annually at the Sponsor's discretion.

Participants may also make rollover contributions from amounts representing distributions from other qualified plans and certain Individual Retirement Accounts (IRA) as defined in the Plan Document.

Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows for special code Section 403(b) catch-up contributions for those participants with 15 years of service.

Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Plan assets are held in participant-directed custodial accounts invested in mutual funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Sponsor's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon.

Vesting in matching and nonelective contributions from the Sponsor is based on years of service: 25% after 1 year, 50% after 2 years, 75% after 3 years, and 100% after 4 years. Participants become fully vested upon death, disability, or attainment of normal retirement age (62). The nonvested balance, if any, is forfeited upon termination of service. Forfeitures are used to reduce Corporation contributions or pay Plan expenses.

***Payment of Benefits***

Termination, Retirement, Death, or Disability: Upon termination of employment, retirement, death, or disability, participants may elect to receive their vested account balance as a lump sum or in installments, subject to the terms of the investment arrangements.

In-Service Distributions: Allowed upon attainment of age 59½ or in the event of financial hardship, subject to plan and investment arrangement rules. Hardship withdrawals are permitted for medical, education, housing, funeral, casualty, and federally declared disaster expenses.

Mandatory Distributions: If a participant's vested account balance does not exceed \$5,000, a mandatory distribution will be made.

***Forfeited Accounts***

At December 31, 2024, forfeited nonvested accounts totaled \$1,869. These accounts will be used to reduce future contributions from the Sponsor or pay Plan expenses, as defined in the Plan Document. No forfeited nonvested accounts were used to reduce contributions from the Sponsor or pay Plan expenses during 2024.

***Notes Receivable from Participants***

The Plan does not permit participant loans.

***Plan Termination***

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their contributions from the Sponsor.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions***

Contributions from participants and the Sponsor are recorded in the year in which they are withheld from compensation or earned, respectively.

### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

### ***Administrative Expenses***

Administrative expenses may be paid by the Sponsor or the Plan, at the Sponsor's discretion.

### ***Plan Tax Status***

The Plan operates under a volume submitter agreement in connection with a volume submitter plan and custodial document sponsored by American Pension Advisors, LTD. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan is qualified.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of assets available for benefits.

***Subsequent Events***

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was amended and restated to increase the EACA initial enrollment percentage to 3%.

Effective May 1, 2025, the Plan was amended and restated to include participants made eligible through an acquisition executed by the Plan Sponsor.

**Note 3. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Nationwide, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments as shown in the statement of net assets available for benefits as of December 31, 2024
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$20,130 of recordkeeping and asset management fees to the Plan's custodian and third party administrator during the year ended December 31, 2024.

The Sponsor provides certain administrative services at no cost to the Plan.

**Note 5. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

**Recurring Measurements**

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statement of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no investments classified as Level 2 or Level 3 at December 31, 2024.

**Note 6. Nonexempt Transactions**

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the Sponsor's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the Sponsor. While the Sponsor remitted all employee contributions to the Plan, contributions of \$10,743 were not remitted within the required time period for the year ended December 31, 2024. The Sponsor contributed the lost earnings, if any, on the late contributions in accordance with the Department of Labor's self-correction program during the year ended December 31, 2024.
