Opinion

We have audited the financial statements of United Mine Workers of America 1974 Pension Trust Employees' 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of United Mine Workers of America 1974 Pension Trust Employees' 401(k) Plan as of December 31, 2024 and 2023 and the changes in net assets available for benefits for the years ended December 31, 2024 and 2023, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). 1. Description of Plan

The following is a general description of the United Mine Workers of America 1974 Pension Trust Employees' 401(k) Plan (the "Plan"). Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a deferred compensation plan, commonly referred to as a 401(k) plan. It is available to substantially all employees who perform work for the United Mine Workers of America 1974 Pension Trust, the employer maintaining the Plan, and certain affiliated United Mine Workers of America plans (collectively, "the employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is operated in accordance with adoption of the Vanguard Fiduciary Trust Company Volume Submitter Profit Sharing Plan.

Contributions

The Plan allows each participant to defer up to 50% of his or her pre-tax compensation up to a maximum of \$23,000 and \$22,500 for 2024 and 2023, respectively. Employees who are eligible to make elective deferrals and who have attained age 50 before the close of the calendar year are eligible to make additional pre-tax elective deferrals to the Plan ("Catch-up Contributions"). The amount of the Catch-up Contributions is subject to the Internal Revenue Service limitation of \$7,500 for 2024 and 2023. Participants may also rollover contributions from other tax qualified plans provided certain requirements are satisfied. Such contributions are 100% vested and non-forfeitable. The employer provides a matching contribution based on the deferral for each employee each bi-weekly pay period. Employee deferrals are matched 50% up to the first 6% of compensation as of December 31, 2024 and 2023.

Contributions Receivable

There were no contributions receivable as of December 31, 2024 or December 31, 2023.

Participant Accounts

Each participant's account is credited with the participant's deferrals, the employer's contributions, any rollover contributions, and an allocation of the Plan earnings. The account is charged with any withdrawals or distributions made. Each participant may direct his or her account into any combination of several investment funds depending on his or her desired level of investment risk. Allocation of the Plan's earnings and administrative expenses are based on account balance or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

As of December 31, 2024 and 2023, there were no pending withdrawal elections from participants who had elected to take a withdrawal from the Plan but for whom funds had not yet been disbursed.

Vesting

Participants are immediately 100% vested in all amounts credited to their accounts.

Notes Receivable from Participants

Participants may borrow up to 50% of the balance in their accounts, not to exceed \$50,000 at the time the loan is made. The minimum loan amount is \$500. Loans are secured by the balance in the participant's account and must be repaid using an interest rate which is fixed at the time of the loan at prime plus 1%. Loans must be repaid within 5 years, except those loans taken for the purchase of a principal residence which may be repaid within 10 years. Principal and interest are paid ratably through payroll deductions. The fixed interest rate on loans ranged from 4.25% to 9.50% at December 31, 2024, with maturities through January 2030.

Payment of Benefits

Upon termination of service, disability, normal retirement (age 60), early retirement (age 55 and 5 years of service), or death, a participant with an account balance that exceeds \$5,000, or his or her beneficiary, may elect to receive a distribution in the form of a lump-sum amount equal to the value of his or her account, or substantially equal installment payments. Participants who terminate employment and whose account balance is less than \$5,000 shall receive an immediate lump-sum cash distribution. In addition, an employee may receive a hardship distribution, in accordance with the regulations and rulings of the Internal Revenue Code.

Administrative Expenses

The costs of administering the Plan are paid by the employer. Certain investment related expenses are included in net appreciation in fair value of investments presented in the statements of changes in net assets available for benefits as they are paid through revenue sharing, rather than a direct payment.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants arise from participant loans, which are carried at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan's document.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments Measured at Net Asset Value: Consisting of a common-collective trust, valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 3.

* In accordance with subtopic 820-10, certain investments that are measured at fair value using net asset value ("NAV") per share (or its equivalent) as the practical expedient have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

The fair value of the common/collective trust, the Vanguard Retirement Savings Trust III, as of December 31, 2024 and 2023 has been determined using the net asset value per unit of the investment. As of December 31, 2024 and 2023, there were no unfunded commitments for additional investment. Withdrawals may be made daily; however, certain Plan-directed withdrawals may be subject to market value adjustments calculated in accordance with the provisions of the investment contract. The common/collective trust invests solely in Vanguard Savings Master Trust ("VRST Master Trust").

The VRST Master Trust provides for the collective investment of assets of tax-exempt pension and profit sharing-plans, primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by bond funds and trusts.

4. Related-Party and Party In Interest Transactions

The Plan invests in shares of mutual funds and a common/collective trust managed by an affiliate, Vanguard Fiduciary Trust Company ("VFTC"). VFTC acts as investment custodian of the Plan, and as such is a party-in-interest. Investment in such mutual funds and expenses paid to VFTC qualify as party-in-interest transactions that are exempt from prohibited transaction rules. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as exempt party-in-interest transactions.

5. Plan Termination

In the event of Plan termination, each participant's account shall be distributed to the participant in a one-time lump sum payment as soon as administratively feasible. Participants are 100% vested in their accounts at all times.

6. Tax Status

The Internal Revenue Service determined and informed the trustee by a letter dated March 31, 2014 that the prototype adopted by the Plan, as then designed, was qualified under the appropriate sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken and recognize an income tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Management has evaluated the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations in progress for any tax periods. In addition, there have been no tax-related interest or penalties for the periods presented in these financial statements.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. Investments representing a concentration of greater than 10% of the Plan's net assets available for benefits for the years ended December 31, 2024 and 2023 was one.

8. Delinquent Participant Contributions

For the years ended December 31, 2024 and 2023, certain participating employers did not remit certain participant contributions and loan repayments to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances are identified on the Schedule of Delinquent Participant Contributions, which totaled \$75,716 in 2024. Additionally, the Plan submitted a Voluntary Fiduciary Correction Program (VFCP) application to the Department of Labor (DOL) on October 11, 2024 to correct delinquent participant contributions. On January 16, 2025, the Department of Labor issued a "no action" letter, indicating that it would not pursue enforcement action regarding the matter. No further action was taken, and the application was considered closed.

9. Subsequent Events

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after December 31, 2024 for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through October 14, 2025, the date that the financial statements were available to be issued and no items have come to the attention of management that would require recognition or disclosure.
