The audit of the plan's financial statements is currently in process and has not yet been finalized. Upon completion of the audit, the Plan Sponsor will file an **amended Form 5500** that includes the independent auditor's report and final audited financial statements, in accordance with Department of Labor and Internal Revenue Service requirements.

This filing is being submitted timely to meet the Form 5500 filing deadline while the audit process is being completed.
