SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of The Ivy Hotel 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 DESCRIPTION OF PLAN

The following brief description of The Ivy Hotel 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document or the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Mount Vernon Mansion, LLC (referred to as the Company), excluding non-resident aliens and residents of Puerto Rico. Employees are eligible to participate in the Plan after completing a three-month period of service and turning 21 years old. Employees are automatically enrolled on the first day of any month on or following the date the employee meets eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 90% of their annual compensation, as defined in the Plan, subject to certain annual limitations in the Internal Revenue Code (IRC). The Plan allows pre-tax participant contributions as well as Roth 401(k) contributions. Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions to the Plan. Participants may rollover distributions received from other qualified plans. The Plan automatically enrolls new participants, once eligibility requirements have been met, at a 3% deferral rate, unless elected out by the employee. Beginning in 2024, the automatic deferral rate will increase by 1% each Plan year, up to a maximum deferral rate of 6%. The annual escalation will occur on the first day of each Plan year, unless the participant elects otherwise.

Under safe harbor provisions of the Plan, the Company makes matching contributions equal to 100% of a participant's elective deferrals, that do not exceed 1% of compensation, plus 50% of the amount of the participant's elective deferrals, up to 6% of the participant's compensation. The Company made matching contributions of \$48,288 and \$61,043 during the years ended December 31, 2024 and 2023. The Company may elect to contribute discretionary matching and profit-sharing contributions to the Plan. The Company did not make discretionary profit-sharing contributions during the years ended December 31, 2024 and 2023 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's discretionary contributions, and an allocation of any Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(See Independent Auditors' Report)

Vesting

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's matching contributions is based upon years of service with full vesting obtained after two years or attainment of normal retirement age, disability (as defined by the Plan), or death. Vesting in the Company's non-elective contributions is based upon years of service with full vesting obtained after six years or attainment of normal retirement age, disability (as defined by the Plan), or death.

Investment Options

Participants may direct contributions into various investment options offered by the Plan.

Notes Receivable From Participants

Participants may borrow against their non-Roth 401(k) account balance, a minimum of \$500 up to a maximum of the lesser of 50% of their vested balance or \$50,000. Loan terms require amortization of principal and interest over a period not to exceed five years. Loans used to acquire a principal residence may extend beyond a five-year term. The loans bear interest at a rate comparable to rates charged by commercial lending institutions for loans of similar terms. Loans are repaid through payroll deductions and may be repaid in full at any time. Loans are collateralized by the balance in the participant's account.

Payment of Benefits

Benefits are payable in the form of a lump-sum distribution in cash or a transfer to another qualified plan as soon as practicable following normal retirement, disability, death, or termination of employment, subject to specific benefit payment requirements in the Plan document. If the balance of the account is less than \$5,000, the balance is automatically distributed in a lump-sum payment. In-service withdrawals are permitted upon a participant reaching early retirement age of 59½. In the event of financial hardship, participants may elect a distribution from their elective deferral contributions up to the amount of the financial hardship.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$3,628 and \$3,255, respectively. These accounts will be used to reduce administrative expenses and Company contributions in accordance with the Plan document.

Administrative Expenses

Substantially all administrative expenses are paid by the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Basis of Presentation

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Valuation of Investments

Investments are reported at fair value. See Note 4 for a discussion of fair value measurements.

Risk and Uncertainties

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Notes Receivable From Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Related fees are recorded as administrative expenses and expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 13, 2025, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE

The Plan's investments were held by the Trustee, Reliance Trust Company, at December 31, 2024 and 2023. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee. NOTE 4 VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(See Independent Auditors' Report)

- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Common Collective Trusts: Valued using NAV, which is determined based on the fair value of the underlying investments of the trust. There were no unfunded commitments or redemption restrictions as of December 31, 2024. Participant-initiated transactions may occur daily at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan paid administrative fees of \$2,886 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.

NOTE 6 TAX STATUS

The Plan has been recognized by the Internal Revenue Service (IRS) as a qualified non-standardized pre-approved profit-sharing plan under the IRC Section 401(a) and 401(k) and is exempt from deferral income taxes under the provisions of IRC Sections 501(a). The Plan obtained its latest determination letter on October 6, 2020, wherein the IRS stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan since was amended and restated. The Plan Administrator believes the Plan is designed and operating in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded there were no uncertain tax positions as of December 31, 2024.

NOTE 7 **PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their entire accounts.
