Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of Alibaba.com U.S. LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”), and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1: Description of plan

The following description of the Alibaba.com U.S. LLC 401(k) Plan (the “Plan”), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan covers employees Alibaba.com U.S. LLC and the following participating affiliates:

- Alibaba Group (U.S.), Inc.
- AUS Merchant Services, Inc. (F.K.A Alipay US, Inc.)
- Alibaba Pictures International LLC
- Eye Verify, Inc.
- Alibaba Cloud US LLC
- Ant Technologies US LLC
- Alibaba.com US E-Commerce

Subsequent to yearend, effective January 1, 2025, the Plan was amended to include Apic US, Inc. as a participating employer.

General: The Plan is a defined contribution plan established on January 1, 2008 and restated and amended on April 1, 2024, under substantially the same provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan provides benefits for all eligible employees of Alibaba.com U.S. LLC, (the “Company” or “Plan sponsor”) and participating affiliates.

The Company is the Plan administrator and retains the services of a third party to assist in the administration of the Plan. Through December 31, 2024 the Plan’s custodian, recordkeeper and third party administrator is Principal Trust Company (“Principal”).

In the current year, the Plan received approximately \$66,000 of assets into the Plan from one participant employed by AUS Merchant Services, Inc.

Eligibility: Except for excluded employees, all employees who have reached twenty-one years of age and have completed three months of service are eligible to participate in the Plan. Excluded employees include collectively bargained employees, non-resident aliens, leased employees, employees not on the United States payroll of the Company and participating affiliates, independent contractors, and interns. Employees may enter the Plan on the first day of the month following completion of the eligibility requirements. An employee may elect not to participate in the Plan.

Participant contributions: Each year, participants may contribute up to 75% of their pre-tax annual compensation, as defined in the Plan, limited to \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions, subject to statutory limits. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants may also designate a portion or all of their contributions as Roth contributions. Roth contributions are post-tax contributions of compensation, maintained in separate accounts in the Plan. Participants direct the investment of their account balances into various investment options offered by the Plan. A participant may elect to increase or decrease their percentage as of each entry date defined as the first day of each month following completion of the eligibility requirements.

Employer matching contributions: The Company and participating affiliates made matching contributions equal to 50% of the first 75% of the employee’s eligible earnings, up to a maximum amount of \$11,250 and effective February 29, 2024, the Company increased the maximum limit to \$11,500. The employer matching contribution, net of forfeitures, was approximately \$3,206,000 for the year ended December 31, 2024. Subsequent to year-end, effective March 4, 2025, the Plan was amended to increase the maximum limit to \$11,750.

Participant accounts: Each participant’s account is credited with the participant’s contributions and allocations of: (a) the Company's matching contributions, and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment options: The Plan provides for investments to be directed by participants into a number of investment options held by the custodian. Participant investment options include a guaranteed income fund and a variety of mutual funds. Earnings of each investment fund are allocated to participants’ accounts in proportion of each participant’s share of that fund. Participants may change their elections at any time.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Participants terminated prior to July 1, 2017, will follow a 4-year vesting schedule. Participants terminated after July 1, 2017, will be 100% vested in employer matching contributions.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Note terms range from one to five years but may not exceed five years. The notes are secured by the balance in the participant’s account and bear interest at market financing rates (which is defined as the prime rate plus 2%). Principal and interest are paid ratably through payroll deduction each pay period. Participants are only permitted to have one outstanding note at a time.

Payment of benefits: Upon termination of service due to death, disability, retirement or separation from service, participants may receive benefits in a lump sum. Unless otherwise instructed by the participant, participants with vested account balances of \$1,000 or less upon separation will receive a lump sum cash payout and participants with vested account balances ranging from \$1,000 to \$7,000 will be rolled over to an individual retirement account (“IRA”).

Forfeitures: Participants forfeit the non-vested portion of their accounts in the Plan upon termination of employment with the Company and participating affiliates. Forfeited balances of terminated participants’ non-vested accounts may be used at the Company and participating affiliate’s discretion, as outlined in the Plan, to reduce its matching contribution obligations and plan expenses. Forfeitures at December 31, 2024 and 2023, and forfeitures applied for the year ended December 31, 2024 were immaterial.

Administrative expenses: The Plan pays the cost of administering the Plan such as recordkeeping, accounting, legal and trustee services. Investment fees are generally assessed as a percentage of assets invested and are deducted directly from investment returns. Transaction-based fees that are associated with optional services offered under the Plan are charged directly to the account of the participant, who takes advantage of such a feature, such as a note receivable from a participant.

Note 2: Summary of significant accounting policies

Basis of accounting: The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted (“GAAP”) in the United States of America. Contributions from participants are recorded when withheld from the participant. Benefit payments to participants are recorded when paid.

Use of estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and schedule. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan holds investments in mutual funds and a guaranteed income fund. Mutual funds are valued at quoted market prices that represent the net asset values of shares held at year-end. The guaranteed income fund is fully benefit-responsive investment contract and is reported at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Fair value measurements: The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures. Refer to Note 3 for the fair value measurement disclosures associated with the Plan’s investments.

Net appreciation (depreciation) in fair value of investments: The earnings, expenses, realized gains and losses, and unrealized appreciation (depreciation) in registered investment companies and other investments are recorded in the accompanying financial statements as net appreciation (depreciation) in fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through the date that the financial statements are available to be issued which is the date of the independent auditors' report.

Note 3: Fair value measurements

The Plan performs fair value measurement in accordance with ASC 820. ASC 820 defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. The accounting guidance for fair value measurement requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard establishes a fair value hierarchy based on the level of independent, objective evidence surrounding the inputs used to measure fair value. A financial instrument’s categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The fair value hierarchy is as follows:

- Level 1: quoted prices in active markets for identical assets or liabilities;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Investments

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal, the custodian of the Plan, as complete and accurate, except for comparing such information to information included in the Plan's financial statements and supplemental schedule.

The following information included in the financial statements and supplemental schedule was provided by and certified by the Plan's custodian as complete and accurate:

- Investments as shown in the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Notes receivable from participants as shown in the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income (loss) and interest income on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the year presented.
- Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

Note 5: Investment contract

The Plan invests in a guaranteed investment contract administered by Principal Financial Group. The investment contract is a fully benefit-responsive contract entered into with Principal. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract is valued at contract value for presentation in the Plan's net assets available for benefits. Contract value is the relevant measurement attributed for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract has a surrender fee should the Plan discontinue without proper notification as prescribed in the contract. Currently, Plan management believes that the occurrence of an event that would cause the Plan to transact at less than contract value is not probable. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6: Party-in-interest transactions

Certain investments are units in a guaranteed income fund managed by Principal. Principal is the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. At December 31, 2024 and 2023, the Plan held for investment approximately \$3,820,000 and \$4,883,000, respectively, in the custodian's guaranteed income fund.

Note 7: Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8: Income tax status

The Plan sponsor obtained a copy of the latest Internal Revenue Service ("IRS") opinion letter dated June 30, 2020 issued to Principal Life Insurance Company for its prototype plan in which the IRS stated that the prototype plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Subsequent to receiving this opinion letter, the prototype plan was amended. The Plan administrator believes that the amended prototype plan, as adopted by the Company, is operating in compliance with the requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and uncertainties

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participant account balances.
