INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

1. Description of the Plan

Reconstruction Holdings, Inc. (the Company and Employer) established the Reconstruction Experts, Inc. 401(k) Plan (the Plan), effective January 1, 2015, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees, who are responsible for selecting investment options offered under the Plan and monitoring investment performance. Ascensus Trust Company and Ascensus, LLC (collectively, Ascensus) serve as the Plan's trustee and recordkeeper, respectively. Ascensus holds, invests, and reinvests Plan assets in the interest and direction of the participants and their beneficiaries.

Eligible Participants:

Employees who are at least 18 years of age, as defined by the Plan agreement, may participate in the Plan on the first day of the month following completion of two months of service.

Contributions:

Participants are permitted to make voluntary pre-tax salary deferral and Roth post-tax contributions up to 100% of annual compensation, as defined by the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), excluding rollovers of after-tax contributions, subject to Code regulations.

The Plan provides for automatic enrollment on the date employees become eligible to participate in the Plan. The automatic election for eligible participants is 2% of their compensation, unless the participants request a different amount to be contributed or formally decline participation.

Reconstruction Experts, Inc. 401(k) Plan Notes to Financial Statements

1. Description of the Plan (continued)

Contributions: (continued)

The Company may make discretionary matching and profit sharing contributions to the Plan, as determined by the Company's Board of Directors. The Company has elected to make matching contributions equal to 50% of each participant's contribution, up to 6% of participant eligible compensation per pay period. The Company made matching contributions of \$317,932 in 2024.

Contributions are subject to certain limitations under the Code.

Participant Accounts:

Participant accounts are credited with participant contributions, discretionary Company contributions, rollovers, and an allocation of Plan net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant vested account balances.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Vesting:

Participants are immediately vested in their salary deferral, Roth post-tax, and rollover contributions, plus actual earnings (less any losses) thereon. Vesting in Company contributions, plus allocated earnings (less any losses) thereon, is based on years of service. Participants become 20% vested in Company contributions after two years of service and are fully vested after six years, or upon retirement, disability, death, or Plan termination.

Forfeitures:

Forfeitures of non-vested Company contributions may be used to reduce future Company contributions. The Plan had \$171,835 of forfeitures as of December 31, 2024 available for future use (\$62,338 as of December 31, 2023).

1. Description of the Plan (continued)

Notes Receivable from Participants:

Participants may borrow up to one-half of their vested account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which terms of up to thirty years are permitted. Participants may only have one note outstanding. Participant notes are evidenced by a written note, secured by the vested balance in the participant account and bear interest at the prime rate, as published in The Wall Street Journal on the 1st day of the month the note is granted, plus 1%. The interest rate on the notes outstanding as of December 31, 2024 ranged from 8.75% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Liability for Corrective Distributions:

The liability for corrective distributions represents contributions that must be refunded to participants in order for the Plan to be in compliance with applicable non-discrimination tests. The December 31, 2024 liability of \$48,371 was refunded in 2025 (the December 31, 2023 liability of \$61,562 was refunded in 2024).

Payment of Benefits:

On termination of service for any reason, benefits are paid to participants in a lump-sum cash distribution equal to the value of the participant accounts, or in partial withdrawals, or regular cash installment payments of their choice. Terminated participant accounts between \$1,000 and \$7,000 may be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Terminated participant accounts below \$1,000 may be distributed directly to participants without participant approval. The Plan agreement also allows for in-service and hardship withdrawals of benefits to current employees. Benefits are recorded when paid.

Administrative Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain account maintenance fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue Company contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts and distributions would be made to participants, as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments:

Investments are comprised of mutual funds, a money market fund, and common/collective trusts, which are accounted for as follows:

Mutual Funds and Money Market Fund: These funds are valued at the net asset value of shares held by the Plan at year end, as quoted in active markets.

Common/Collective Trusts (CCTs): The Plan invests in CCTs through Wilmington Trust Collective Investment Trusts, which are reported at fair value, as determined by Wilmington Trust based on the fair value of the fixed income securities in the trust portfolios.

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net income on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Nonexempt Prohibited Transactions

In 2022 and 2024, the Company did not remit participant contributions and note repayments totaling \$24,055 and \$70,541, respectively, on a timely basis as required by the Department of Labor (DOL). The DOL considers delinquent contributions to be nonexempt prohibited transactions with the Plan sponsor that can jeopardize the Plan's tax-exempt status.
