### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification(s), comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedules Required by ERISA***

The supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to



prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of Plan

The following description of the Long Island Select Healthcare Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan document or summary plan description for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan under Section 403(b) of the Internal Revenue Code (the Code) and covers all employees of Long Island Select Healthcare (the Plan Sponsor or LISH). The effective date of the Plan was January 1, 2016 and has been restated effective January 1, 2024. Employees are immediately eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Plan Administration*

The Plan is sponsored by LISH. Beginning in October 2024, administration services for the Plan are provided by The Retirement Advantage, Inc; Lincoln Retirement Services Company, LLC (Lincoln) is the recordkeeper of the Plan; and Lincoln Financial Group Trust Company (Lincoln Financial) is the custodian of the Plan. Prior to this, administration services to the Plan were provided by MillenniumM Investment and Retirement Advisors, LLC; PCS Retirement, LLC (PCS) was the recordkeeper of the Plan; and AdvisorTrust, Inc. (AdvisorTrust) was the trustee.

#### *Eligibility*

All employees are considered eligible for participation. There is no age requirement to enter the Plan, with an immediate entry date. Additionally, there is no minimum service requirement to participate in the Plan. With respect to employer non-elective discretionary contributions, participants must complete at least 1,000 hours of service or be employed on the last day of the Plan year to be eligible. Entry is on the first day of each Plan quarter.

#### *Contributions*

Participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan document, limited to Internal Revenue Service (IRS) regulations to a maximum amount of \$23,000 for the year ended December 31, 2024. Individuals who were at least age 50 by December 31, 2024 could make an additional catch-up contribution, up to a maximum amount of \$7,500 for the year ended December 31, 2024. Participants may also elect to make special catch-up contributions prior to the age of 50 if 15 years of service has been rendered by the participant, subject to certain limitations. Participants may also contribute amounts representing rollovers from other qualified plans.

LISH may make an employer contribution, to be determined annually, to employees who meet the eligibility requirements of the Plan for an allocation of the employer contribution. The employer contribution shall be allocated to the accounts of eligible participants in the proportion the participant's compensation bears to the aggregate compensation of all participants eligible to receive a contribution for the Plan year. For the year ended December 31, 2024, LISH made a non-elective discretionary employer contribution to the Plan of \$225,000.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### ***Vesting***

Participants are immediately 100% vested in their individual deferral contributions, rollover contributions, and the allocated earnings thereon. A participant's vested interest in employer contributions and any net earnings or losses thereon is 0% until the participant reaches three years of credited service. Participants are 100% vested after they attain three years of credited service.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balances or \$50,000 minus the difference between the participant's highest outstanding loan balance in the prior 12 months and the outstanding balance of any loans on the date the loan is made. The loans are secured by the vested balance in the participant's account. The loans bear interest at 1% above the prime rate. The interest rate on loans outstanding at December 31, 2024 ranges from 4.25% to 9.50%. The interest rate on loans outstanding at December 31, 2023 ranges from 4.25% to 9.50%. Principal and interest repayments are made through direct payments from the participant in accordance with an amortization schedule. The notes are repaid over a period of five years or less, unless used to purchase a principal residence up to a length of time determined by the Plan Sponsor at the date the loan is made. Upon termination of employment, a participant is required to pay off the balance of the loan. Otherwise, the unpaid balance will be treated as a deemed distribution to the participant and taxable income in the year the deemed distribution occurs.

### ***Payment of Benefits***

Upon termination of service due to death, disability, termination of employment, or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested account balance, determined in accordance with the Plan agreement.

### ***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested account balances totaled \$993 and \$14,238, respectively. Forfeitures may be used to pay Plan administrative expenses or offset employer contributions. In 2024, \$14,747 of forfeitures were used to pay administrative expenses.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Contributions Receivable***

Employer non-elective discretionary contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Benefit Payments***

Benefit payments are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in administrative expenses.

### ***Use of Estimates***

The preparation of the Plan's financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, as well as the disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### 3. Financial Instruments and Fair Value

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodology used at December 31, 2024 and 2023. The following is a description of the valuation methodology used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had no financial assets or liabilities that were measured at fair value on a nonrecurring basis during the year ended December 31, 2024.

## 4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial and Advisor Trust, qualified institutions.

## 5. Party-in-Interest Transactions

Certain of the Plan's investments are in funds that are managed by Lincoln Financial. Lincoln Financial holds the Plan's investments, receive interest, dividends, and contributions, in addition to processing distributions to participants. Transactions with Lincoln Financial qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

The Plan issues notes to participants that are secured by the balances in the participants' accounts. These transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

## 6. Tax Status

The Plan has adopted the Retirement Advantage, Inc. Volume Submitter 403(b) Plan. The IRS has determined, and informed the Retirement Advantage, Inc. by a letter dated August 2, 2019, that the Plan is designed in accordance with the applicable sections of the Code. Accordingly, the Plan is permitted to rely on the opinion letter. Although the Plan has been amended since receiving the opinion letter, the Plan Sponsor believes that the Plan currently is designed and is being operated in compliance with the applicable requirements of the Code.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS audits for any tax periods in progress.

### **7. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### **8. Plan Termination**

Although it has not expressed any intention to do so, LISH has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

### **9. Delinquent Participant Contributions**

During the Plan year ended December 31, 2024, participant contributions and loan repayments totaling \$51,711 were not remitted to the Plan within the period prescribed by Department of Labor regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. Plan management is working on correcting the late remittances as of date of this report.

### **10. Subsequent Events**

The Plan's management has performed subsequent event procedures through October 15, 2025, which is the date the financial statements were available to be issued, and there were no subsequent events requiring adjustments to the financial statements or disclosures as stated herein.
