Scope and Nature of the ERISA 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the ZeroFox 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it was permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of Plan:

The following description of the ZeroFox 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of ZeroFox, Inc. (the "Company"). Employees become eligible to participate after 3 months of service and attaining the age of 21. Eligible employees may enter the Plan on the first day of the month on or after the eligibility requirements have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: The Plan provides for participant contributions of pre-tax and Roth annual compensation, as defined in the Plan. Participants are automatically enrolled at 2% of compensation as defined in the Plan. Participants of qualifying age may make additional "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain limitations. The Company may elect to make a discretionary matching contribution on the participant's elective contribution. The Company did not elect to make discretionary matching contributions on the participant's elective contributions for 2024 and 2023.

Participant Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions; if applicable and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Participants may direct the custodian as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

Vesting: Participants are immediately vested in their contribution, plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service using a graded vesting schedule over a five-year period.

Payment of Benefits: Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment as described by the Plan document.

Plan Administration: Overall responsibility for administering the Plan rests with the Company. Participant accounts are administered by an affiliate of the custodian.

Notes to Financial Statements, Continued

1. Description of Plan, Continued:

Plan Trustees: Certain employees of the Company serve as the trustees of the Plan. The trustees are not compensated by the Plan for services rendered.

Forfeitures: Forfeited balances of terminated participants' non-vested accounts are used to pay plan expenses or offset Company contributions. There were no forfeited balances available at December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies:

Basis of Accounting: The financial statements of the Plan are prepared on the accrual method of accounting.

Investment Valuation and Income Recognition: The Plan's Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net investment income (loss) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent Events: Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued, and has determined there are no subsequent events to be reported in the accompanying financial statements.

Notes to Financial Statements, Continued

3. Fair Value Measurements:

The Financial Accounting Standards Board (“FASB”) has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets. There were no Level 2 assets or liabilities in the Plan as of December 31, 2024 and 2023.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no Level 3 assets or liabilities in the Plan as of December 31, 2024 and 2023.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts (“PSA”): Valued daily based on the market value of the underlying net assets in each separate account. The majority of the underlying net assets have observable Level 1 quoted pricing inputs which are used to determine the unit value of the PSA which is not publicly quoted. The PSAs invest in mutual funds and domestic stocks. The redemption frequency of each of these PSA’s is daily, and there are no redemption restrictions. There are no unfunded commitments related to the Plan’s investment in PSAs.

Stable value fund: Valued based on the fair value using the NAV practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund. In accordance with ASU 2015-07, these investments have been excluded from categorization in the fair value hierarchy.

The methods described above may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Administrative Expenses:

Although not required by the Plan, some of the costs of the Plan administration are absorbed by the Company. The Plan paid administration fees to the custodian in the amount of \$131,324 in 2024 and \$98,858 in 2023.

5. Related Party Transactions:

The Plan invests in pooled separate accounts and a stable value fund managed by affiliates of the custodian. These are related-party transactions and are identified as parties-in-interest in the accompanying schedule of assets (held at end of year). The Plan paid administrative fees to the custodian (see Note 4).

6. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

7. Tax Status:

The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated June 30, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

7. Tax Status, Continued:

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any tax jurisdiction.

8. Risks and Uncertainties:

The Plan provides for investments in various securities. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the financial statements.

9. Financial Information Certified by a Qualified Institution:

Principal Trust Company, the custodian of the Plan, and Principal Life Insurance Company, an affiliate of the custodian, have certified that the following information is complete and accurate as of and for the years ended December 31, 2024 and 2023:

10. Prohibited Transactions:

During 2023, the Company failed to remit contributions to the Plan timely on several occasions. The Company has remitted the participant contributions and any appropriate corrective contributions to participants for lost earnings related to these events.
