Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H (Form 5500), Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The certified investment information in the supplemental schedule agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following brief description of the Virtuoso, Ltd. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan established to provide retirement, disability, and death benefits for qualified employees of Virtuoso, Ltd. (the Plan Sponsor, Virtuoso or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by a committee (the Investment Committee or Plan Administrator) whose members are appointed by the Plan Sponsor's board of directors. Under the Plan Document, Reliance Trust Company (Reliance or the trustee) holds the Plan's investment assets and executes investment transactions. Automatic Data Processing, Inc. Retirement Services (ADP) maintains the accounting of participant accounts.

Eligibility

The Plan covers all employees of the Plan Sponsor who have reached age 21 and have completed thirty days of service. Eligible plan participants may begin making contributions as of the first day of the month following the date on which the eligibility requirements were satisfied.

Contributions

The Plan includes an automatic salary deferral feature of 3% where the Plan Sponsor will automatically withhold a portion of participant's compensation from their pay each payroll period and contribute that amount to the Plan as a pre-tax 401(k) deferral. Participants may elect an alternative deferral amount or elect not to defer under the Plan. Each year, participants may contribute up to 100% of pre-tax or after-tax Roth annual compensation, as defined in the Plan document, not exceeding the Internal Revenue Service (IRS) limit of \$22,500 in 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

The Plan Sponsor may make matching and profit-sharing contributions at the discretion of the Plan Sponsor's board of directors. For the year ended December 31, 2024, the Employer made a discretionary match contribution of 100% of participant deferrals up to 3% of compensation. Employer match contributions are paid annually in April and are included as a contribution receivable in the statement of net assets available for benefits as of December 31, 2024 and 2023. There were no profit-sharing contributions made in 2024.

Participants direct the investment of their contributions and rollover contributions, if any, and the Plan Sponsor's matching and profit-sharing contributions, if any, into various investment options offered by the Plan. The Plan currently offers registered investment companies and a stable value common/collective trust fund as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's and the Plan Sponsor's contributions and allocations of plan earnings (losses) and administrative expenses. Allocations are based on participant account balances or earnings, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and rollover contributions, if applicable, plus actual earnings thereon. Vesting in the Plan Sponsor's contribution portion of their accounts is based on years of continuous service to the following vesting schedule:

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested account balances totaled \$121,557 and \$14,566, respectively. In accordance with Plan provisions, amounts will be used to pay for expenses of the Plan or to reduce future employer contributions. During the year ended December 31, 2024, forfeited funds of \$17,202 were used to fund employer contributions paid during 2024.

Payment of Benefits

On termination of service, death, disability or retirement, a participant is 100% vested and may elect to receive either a lump-sum amount equal to the value of the participant's account or installments over a period of not more than the assumed participant life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. If the value of the vested account balance does not exceed \$5,000, then a distribution of the vested balance will be made automatically, regardless of whether the participant consented to receive the amount. Hardship withdrawals and certain other in-service withdrawals at age 59½ are also allowed by the Plan if certain criteria are met.

Notes Receivable from Participants

Participants are allowed to borrow from their account, subject to a minimum loan of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by, if any, the highest outstanding loan balance within the previous 12-month period, or 50%, of the participant's vested account balance. Loans are secured by the balance in the participant account and bear a reasonable rate of interest in accordance with prevailing rates which is fixed for the term of the loan.

Principal and interest are paid ratably through payroll deductions over a period not to exceed five years from the date of the loan, unless used to acquire principal residence, in which case the repayment period may not exceed 20 years. As of December 31, 2024, interest rates on outstanding loans ranged from 4.25% to 7.25% and had maturity dates ranging through August 2027.

Partial Plan Termination

During 2020, as a result of an employer initiated restructuring due to COVID-19, employee terminations were instituted by Virtuoso, which resulted in a reduction of the Company's workforce. Virtuoso created a partial plan termination as defined by ERISA. Under ERISA, a partial plan termination may occur if 20% or more of the plan participants are terminated because of an action taken by the plan sponsor, such as downsizing. If a partial plan termination occurs, full vesting is required for the terminated participants, but the remaining participants' vesting continues to be determined according to the Plan provisions. Virtuoso has provided full vesting, to the extent participants were not already vested, for those terminated employees deemed to be affected by the partial plan termination.

Plan Termination

The Plan Sponsor has reserved the right to amend, modify, or terminate the Plan at any time, subject to the Plan document and applicable laws and regulations. The Plan Sponsor has no intentions of terminating the Plan and is not aware of any occurrences that could reasonably result in the termination of the Plan. In the event of Plan termination, participants will become 100% vested in their entire account balance, including employer contributions, if any, regardless of years of service.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, benefits paid to participants, investment advisory, and recordkeeping fees are charged directly to the participant's account and are included in expenses. Investment related expenses paid to investment advisors, transfer agents, and others described in each fund prospectus or other published documents are deducted by the investment funds or accounts prior to the allocation of the Plans' investment earnings activity and are, therefore, included in net appreciation in fair value of investments.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies (RICs) - RICs are valued at the daily closing price as reported by the fund. RICs held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The RICs held by the Plan are deemed to be actively traded.

Common Collective Trust (CCT) - Common/collective trusts are valued at the NAV of units held. The NAV, as provided by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCT will sell for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and dividend and interest income per the statement of changes for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule are in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. Related Party and Party-in-Interest Transactions

Administrative fees were paid to ADP, the recordkeeper of the Plan, from Plan assets. ADP may also receive certain revenue sharing from the RICs. Northwestern Mutual Investment Services, LLC was

paid fees for investment advisory services and also receives certain indirect fees. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. The above transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

7. Tax Status

The Plan uses a pre-approved plan document sponsored by ADP, LLC. ADP, LLC received an opinion letter from the IRS, dated October 6, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.
