Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Taylor Bank 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the Financial Statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Notes to Financial Statements

Note 1. Description of the Plan

The following description of The Taylor Bank 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees who are at least 18 years old and have completed three months of service with Calvin B. Taylor Banking Company (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the Company oversees governance of the Plan. The Plan's 401(k) Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 90% of their compensation as defined by the Plan, and within IRS limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute distributions from other qualified plans. The Company may make a matching contribution, at a percentage determined annually by management. For the years ended December 31, 2024 and 2023, the matching contribution was 50% of the first 6% of compensation that a participant deferred. The Company may elect to make an additional discretionary contribution to the Plan. The Company's Board of Directors approved a discretionary contribution of \$220,000 and \$215,000 for the years ended December 31, 2024 and 2023, respectively.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers a stable value fund (collective trust account) and mutual funds. Participants may change their allocations on a daily basis.

Participants may make pretax and after tax (Roth) contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's matching contribution and discretionary contribution, and Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined by the Plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. A participant's interest in the matching contribution and discretionary contribution vests 25% after two years of service, and 25% each year thereafter. A participant is 100% vested after five years of credited service.

Forfeited Accounts

Forfeitures of matching and discretionary contributions are allocated to remaining active participants based on eligible compensation. Forfeitures of \$28,602 and \$13,028 were allocated to remaining active participants during the years ended December 31, 2024 and 2023, respectively. There were \$18,161 and \$28,602 of unused forfeitures as of December 31, 2024 and 2023, respectively.

Payment of Benefits

Upon retirement after age 59 ½, death, disability, or termination of employment with the Company, a participant may elect to receive a distribution of his account balance in a lump sum or in installments (provided the account balance is greater than \$5,000). The participant may elect the method and timing of the cash payment in accordance with the Plan Agreement. Participants that remain employed with the Company may not receive benefits from the Plan.

Participants may receive hardship distributions in accordance with Plan provisions.

Notes Receivable from Participants

Participants may borrow from their accounts. The minimum amount of a note is \$1,000 with a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance in the Plan. The notes are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, as of December 31, 2024, which represented the Wall Street Prime Rate plus one percent at the time the loans were originated. Loan terms range from one to five years, except that a loan used to purchase a primary residence may be repaid over a longer term. Principal and interest are paid ratably through semi-monthly payroll deductions. A participant may have a maximum of two notes outstanding at any time.

Note 2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Notes to Financial Statements

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain investment advisory and recordkeeping fees are allocated to participants. Other costs of administering the Plan, paid by the Company, are not reflected in these financial statements.

Payment of Benefits

Benefit payments are recorded upon distribution. At December 31, 2024 and 2023, there were no benefit claims filed by terminated employees that had not yet been paid.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure from December 31, 2024 through October 15, 2025, the date the financial statements were available to be issued.

Notes to Financial Statements

Note 3. Information Certified by Custodian

The following is a summary of the investment and notes receivable from participants information as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedules, that was provided by the Reliance Trust Company (Reliance). The Plan Administrator has obtained certifications from Reliance that the information is complete and accurate.

The custodian's certified investment income was \$1,362,124 and \$1,615,492 during the years ended December 31, 2024 and 2023, respectively. The custodian's certified interest on notes receivable from participants was \$11,647 and \$7,985 during the years ended December 31, 2024 and 2023, respectively.

Note 4. Fair Value Measurements

Accounting standards provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation method are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Notes to Financial Statements

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation method are unobservable and include situations where there is little, if any, market activity for the asset or liability. The inputs into the determination of fair value are based upon the best information in the circumstances and may require significant management judgment or estimation.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques should maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above for investments valued using Level 2 or Level 3 inputs may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methods or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methods used at December 31, 2024 and 2023.

Mutual Funds

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Collective Trust Account

The Invesco Stable Value Trust, Class IV may invest in contracts issued by banks, insurance companies, or other financial institutions that hold synthetic guaranteed investment contracts. The fund may also invest in traditional guaranteed investment contracts. The fund, which is designed for stability of principal, is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full or partial redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

(a) In accordance with ASC 820-10, certain investments that are measured at fair value using the net asset value practical expedient have not been classified in the fair value hierarchy. The mutual funds in the Plan have no limits on withdrawal amount or redemption frequency. There is no redemption notice period for any of the funds.

For investments in certain entities that do not have a readily determined fair value, ASC 820 allows the fair value measurements to be based on reported net asset value if certain criteria are met and establishes additional disclosures related to these investments. Due to the nature of the investments in the collective trust account, the redemption frequency is daily and there are no required redemption notices or unfunded commitments.

Note 5. Risks and Uncertainties

The Plan invests in mutual funds and a collective trust account. Such investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes to Financial Statements

Note 6. Party-In-Interest Transactions

Reliance is a custodian of the Plan assets. The Plan pays fees to ADP, LLC and ADP Broker-Dealer for recordkeeping and administrative services. The Plan pays fees to Cetera Advisors, LLC for investment advisory services. The Plan lends funds to its participants according to applicable provisions of the Plan Agreement. The Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules.

Certain Plan investments are managed by Reliance Trust Company and, therefore, these transactions qualify as party-in-interest transactions.

Reliance Trust Company provides certain administrative services to the Plan, pursuant to an agreement, and receive revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the party-in-interest for administrative services to the Plan.

If the revenue received by this party-in-interest from such mutual fund service providers exceeds the amount owed under the agreement, excess amounts are remitted to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to participant accounts. During 2024, there were no excess amounts allocated to participants based on their respective account balance. The Plan or Plan Sponsor may make direct payments to a party-in-interest for administrative expenses not covered by revenue sharing.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8. Tax Status

The Plan obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

In connection with the change, the Plan was amended and restated to adopt a pre-approved plan document sponsored by Transamerica Retirement Solutions, LLC effective January 1, 2025. In connection with the amendment and restatement, the Plan instituted an auto-enrollment provision whereby all newly eligible employees will be automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants will have their deferral rate set at 3% of eligible compensation.
