Independent Auditors' Report

To the Plan Administrator and Participants of the
MKS2 LLC Retirement Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the MKS2 LLC Retirement Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years then December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF PLAN

The following brief description of the MKS2 LLC Retirement Trust (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for complete information.

General - The Plan is a defined contribution plan covering substantially all employees of MKS2 (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Broadridge Matrix Trust Company was the Plan's custodian; Decimal, Inc. dba Ubiquity Retirement + Savings was the Plan's record keeper. On October 11, 2024, John Hancock Life Insurance Company became the custodian and record keeper. The Plan is administered by the Company.

The Company had a second retirement plan, the MKS2 SCA Savings Plan (the Savings Plan). The trustees of the Savings Plan adopted an amendment that provided for the merger of the Savings Plan into the Plan. On October 14, 2024, \$1,239,242 was transferred from the Savings Plan into the Plan.

Eligibility - Employees are eligible to participate in the Plan if they are employed by the Company, perform an hour of service, are not a member of a collective bargaining unit, not a leased employee, and are not a nonresident alien. Employees eligible to participate in the Plan must opt-in to participate.

Contributions - As defined by the Plan, participating employees were allowed to contribute a percentage of their pretax earnings up to \$23,000 and \$22,500 in 2024 and 2023, respectively. Investments are selected by the participant. Participants who are age 50 or older may elect to defer additional amounts (called catch-up contributions) to the Plan. The maximum catch-up contribution allowed was \$7,500 and \$7,500 in 2024 and 2023, respectively.

Distributions to participants from other qualified trusts, retirement accounts, or bonds may be applied as rollover contributions.

Participant Accounts - Each participant's account is credited with the participant's contribution, the Company's matching contribution, and any earnings on their individual selected investments. Earnings, gains, and losses are allocated to each participant's account in proportion to the ratio of the participant's investment in each fund to all participants' total investment in each fund at the end of the quarter. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. A participant is always 100 percent vested.

1. DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits - Under the terms of the Plan, participants are eligible for benefit payments upon actual retirement on or after the participant's normal retirement date. The Plan also provides for distributions to participants, or their beneficiaries, upon death, disability and termination of employment. Under certain conditions of financial hardship, a participant may withdraw all or any portion of their contributions during employment. Financial hardship expenses include deductible medical expenses, funds for the purchase of a principal residence, tuition and related educational expenses for a participant, spouse or dependents, funds to prevent eviction or mortgage foreclosure on a principal residence, payments for burial or funeral expenses for a participant's deceased parent, spouse, children or other dependents, and expenses for the repair of damage to a participant's principal residence that would qualify for the casualty deduction for tax purposes. Once a participant receives a hardship withdrawal, their contributions will be suspended for six months.

Federal Income Tax Status - The Plan adopted a non-standardized form of a volume submitter plan that has received an opinion letter from the Internal Revenue Service as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

The Plan has adopted Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) 740-10, *Accounting for Uncertainty in Income Tax*. That standard prescribes a minimum recognition threshold and measurement methodology that a tax position taken or expected to be taken in a tax return is required to meet before being recognized in financial statements. It also provides guidance for de-recognition, classification, interest and penalties, accounting in interim periods, disclosure, and transition.

Expenses - With the exception of certain professional services contracted for by the Company, the Plan's administrative expenses are paid out of plan assets as provided by the plan document.

Participant Loans - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Participant loans are secured by the balance in the participant's account and bear interest at a reasonable interest rate of prime plus 2%. Principal and interest is paid ratably through payroll deductions over a period generally not to exceed five years.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination distributions will be made as soon as administratively practicable after the Plan terminates.

2. SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

Basis of Accounting - The Plan's financial statements are reported on the accrual basis of accounting.

Investment Valuation and Income Recognition - Investments are stated at fair value in accordance with the FASB ASC 820. Fair values of all plan investments are based on prices quoted in an active market. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investments are directed by participants.

Fair Value Measurements - The Plan follows ASC 820, issued by the FASB. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Fair Value Measurements (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds - Mutual funds are priced and trades are executed at the published net asset value (NAV) daily, or the public offering price for accounts trading under rights of accumulation.

Money market accounts are valued at the institutional statement balance at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Risks and Uncertainties - Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the near-term could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Accounting Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

Subsequent Events - Management of the Plan has evaluated subsequent events for disclosure through the date of the Independent Auditors' Report, the date the financial statements were available to be issued.

3. LOANS TO PARTICIPANTS

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loans must be repaid over a period of up to five years unless the loan is used for the purchase of a participant's primary residence in which the repayment period is extended to within a reasonable time commensurate with the repayment period permitted by commercial lenders for similar loans. Loans are secured by a portion of the participant's vested account in the interest accumulation account not to exceed 50 percent and bear interest at a reasonable rate of interest that may not exceed the legal limit. Loan repayments must be made at least quarterly and repayment schedules must result in substantially level amortization of the loan over the applicable term.

At December 31, 2024 and 2023, the Plan had loans outstanding to plan participants totaling \$80,465 and \$22,013, respectively. Interest rates on loans range from 5.25 percent to 10.50 percent, and maturity periods range from 1 to 5 years as of December 31, 2024.

4. CERTIFIED FINANCIAL INFORMATION

As permitted by the rules and regulations of the Department of Labor with respect to reporting and disclosure under ERISA, Broadridge Matrix and John Hancock Life Insurance Company have certified to the Plan Administrator that the investments (stated at fair value or contract value) and participant notes receivable, together with all other transactions which affect those assets are complete and accurate.

The Plan's cash, investments, and participant notes receivable are held by the custodians, Broadridge Matrix for 2023 and through October 10, 2024, and John Hancock Life Insurance Company from October 11, 2024, to December 31, 2024. Investments are presented at fair value as determined by quoted market or contract prices as determined by the custodians.
