### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Sharp NEC Display Solutions of America, Inc. Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of the Plan**

The following description of the Sharp NEC Display Solutions of America, Inc. Retirement Plan (Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General and Transfer of Assets***

The Plan is a defined contribution plan covering all employees of Sharp NEC Display Solutions of America, Inc. (Company) except leased employees, employees on assignment from an affiliated company and employees covered by a collective bargaining agreement. Regular full-time and regular part-time employees become participants immediately upon employment. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. Effective January 1, 2024, all Sharp NEC Display Solutions of America, Inc. employees became employees of a related entity Sharp Electronics Corporation. Furthermore, those employees became eligible for the Sharp Employees Savings Investment Plan (SIP) under the new employer and all active employees' balances including notes receivable totaling \$42,963,382 were transferred to the SIP as of January 31, 2024. As of December 31, 2024 only inactive employee balances remain in the Plan.

***Contributions***

Each year participants may contribute up to 60% of pre-tax annual compensation, as defined in the Plan, within the contribution limitation of the Internal Revenue Code (IRC). All eligible employees are automatically enrolled into the Plan at a contribution rate of 3% of pre-tax annual compensation. Participants may contribute amounts representing after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Effective January 1, 2016, the Plan was amended requiring the Company to make matching contributions which equal 50% of the first 6% of compensation that a participant contributes to the Plan, as well as an additional nonelective contribution equal to 3% of eligible wages. For the years ended December 31, 2024 and 2023, the Company made nonelective contributions of \$119 and \$514,483, respectively. For the years ended December 31, 2024 and 2023, the Company made matching contributions of \$0 and \$481,316, respectively.

***Investments***

Participants direct the investment of all contributions into various investment options offered by the Plan. At December 31, 2024 the Plan offers various registered investment companies and a money market fund as investment options for participants.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Effective January 1, 2016, participants are 100% vested in all Company contributions plus actual earnings thereon after completing one year of service. Prior to January 1, 2016, vesting in the Company's matching contribution and additional annual contribution portion of their accounts plus actual earnings thereon was based on years of continuous service as follows:

Participants will become 100% vested upon death, disability or termination of employment when eligible to retire under the provisions of the Plan.

***Participant Loans***

Participants may borrow from their investment accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account and bear interest at the prevailing rate used by commercial lending institutions. There were no outstanding loans as of December 31, 2024. Principal and interest were paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service due to death, retirement or other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Certain participants may elect to receive benefits in the form of installments, or an annuity contract as specified in the plan agreement.

***Forfeitures***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$33,858 and \$18, respectively. These accounts are used to reduce administrative expenses and Company contributions, as defined in the plan agreement. During 2024 and 2023, forfeitures reduced Company contributions by \$30 and \$34,501, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Quoted market prices are used to value registered investment company investments. The money market fund is valued at cost which approximates fair value. The common or collective trust fund is valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan provides for investments that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain administrative fees of \$12,511 and \$36,426, prior to the effect of revenue sharing amounts (Note 4) were paid by the Plan during 2024 and 2023, respectively, and were recognized as incurred. All other professional fees are paid by the Company. The Company also employs certain personnel who administer the Plan for which the Plan does not reimburse the Company. Additionally, certain investment fees are netted against net appreciation in fair value of investments.

**Note 3. Information Certified by the Plan's Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments, at fair value, and notes receivables from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- The information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

**Note 4. Party-in-Interest Transactions and Revenue Sharing**

Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

The Plan invests in certain funds of the plan trustee. The Plan recognizes the income from revenue-sharing agreements when received. The revenue credit account had a balance of \$2,558 and \$358 at December 31, 2024 and 2023, respectively. This account can be used by the Company to offset plan expenses or reallocated to participant accounts. During 2024 and 2023, the Plan received \$5,986 and \$17,464, respectively, of revenue-sharing income all of which was used to offset plan expenses.

**Note 5. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted market prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

**Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The money market fund is valued at cost which approximates fair value (Level 1 inputs). The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6. Tax Status of the Plan**

The Plan operates under a non-standardized pre-approved profit sharing/money purchase/CODA agreement sponsored by FMR LLC. This non-standardized plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the non-standardized plan constitutes a qualified plan under Section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will be 100% vested in their accounts.

**Note 8. Delinquent Participant Contributions**

The Company made late contributions totaling \$119,702 and \$118,974 during the plan years ended December 31, 2023 and 2022, respectively. The Company utilized the Department of Labor Voluntary Fiduciary Corrections Program calculator to determine lost earnings to self-correct these delinquent contributions. Lost earnings were contributed during the 2024 plan year.
