### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Walbro LLC UAW Local 9699 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Walbro LLC UAW Local 9699 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Walbro LLC (the “Company”) who are at least 18 years of age, are covered by a collective bargaining agreement between the Company and the UAW Local 9699 and have achieved seniority status under said agreement. Leased employees and nonresident aliens with no U.S. source income are excluded from participating in the Plan.

Effective December 31, 2024, the Plan was merged into the First Brands Group 401(k) Plan with Empower Trust Company as its trustee.

Eligibility

Eligible employees, as defined, are eligible to defer compensation by contributing to the Plan and receive a non-discretionary Company matching contributions equal to 50% of the participant’s contributions up to 4% of eligible wages. Employees enter the Plan on the first of the month following date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Effective November 18, 2022, participants are automatically enrolled to make salary deferral contributions of 4% of compensation, as defined unless an election to opt-out of the automatic enrollment is made by the employee. Deferral rates for participants automatically enrolled increase 1% per year to a maximum of 8%. Participants may defer up to 25% from eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Effective January 1, 2022, all participants are eligible to receive employer nonelective contributions equal to 3% of eligible compensation, as defined.

The plan agreement contains various limitations on the amount of employee and employer contributions to the Plan, in accordance with Sections 401 and 415 of the Internal Revenue Code (IRC) on a pre-tax or post-tax basis. Participants age 50 and over may make catch-up contributions up to an additional \$7,500.

Roth 401(k) contributions

The Plan allows for Roth Elective Deferrals that are includible in participant’s gross income at the time deferred and have been irrevocably designated as Roth Elective Deferrals by participant.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, if any, as well as allocations of the Company's non-elective contribution and plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and any rollover contributions made to the Plan, plus actual earnings thereon. Vesting in the remainder of their accounts, for those with an original hire date of November 9, 2006 or later, is based on years of credited service. A participant is 100% vested after three years of credited service or upon attaining their normal retirement age. Participants with an original hire date prior to November 9, 2006 who were participants in the Walbro Engine Management, LLC UAW Local 9699 Pension Plan on July 5, 2009 are immediately vested in employer contributions. The Plan defines a year of credited service to be a twelve consecutive month period commencing with the participant's hire date (elapsed time method). In the event of death, disability or retirement at designated ages, participants become fully vested.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into a variety of investments as more fully described in the Plan's literature. Participants may change their investment options at any time.

Forfeitures

There were no forfeited nonvested accounts at December 31, 2024. Forfeited nonvested accounts totaled \$31,815 at December 31, 2023. Forfeitures of terminated participants' nonvested accounts are used to reduce Company contributions or plan expenses. During the year ended December 31, 2024, forfeitures used to reduce Company contributions and pay Plan expenses totaled \$31,991 and \$16,789, respectively.

Payment of Benefits

A participant is entitled to 100% of his or her account balance upon retirement, death, or disability. The Plan also allows for hardship distributions, as defined, and distributions upon reaching age 59 ½.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value by Fidelity Management Trust Company (Fidelity), the Trustee of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Plan's administrative expenses are paid either by the Plan or the Company as provided by the Plan agreement. Expenses that are paid by the Company are excluded from these financial statements. Fees related to plan administration are either charged directly to participant accounts or are included in administrative expenses.

Income Taxes

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan Sponsor has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 and for the year ended December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued. See Note 10.

NOTE 4 – INVESTMENTS

The fair value framework requires categorization of assets and liabilities into three levels based upon the assumptions (inputs) used to price the assets or liabilities. Level 1 provides the most reliable measure of fair value; whereas, Level 3 generally requires significant management judgment.

The three levels are defined as follows:

- Level 1 - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 - Significant unobservable inputs that reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

**Mutual Funds:** The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges.

**Common Collective Trusts:** The fair values of participation units held in collective trusts are based on the net asset values per unit, as a practical expedient of fair value, as reported by the fund managers. The collective trust provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 5 – RELATED PARTY TRANSACTIONS

Certain plan investments are managed by Fidelity, the trustee of the Plan, and, therefore, these transactions qualify as party-in-interest. The Plan paid certain expenses to Fidelity and other service providers related to plan administration and investment activity. These transactions qualify as exempt party in interest transactions under ERISA.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 7 – INCOME TAX STATUS

The Company has adopted a pre-approved defined contribution plan published by FMR LLC, who obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receipt of the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.
