INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Alamo 1 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Alamo 1 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Alamo 1 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion on the 2024 Financial Statements



Note 1 – Description of Plan

The following description of the Alamo 1 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Alamo Environmental, Inc. dba Alamo 1 (the "Company") who are at least 21 years old and who have completed one year of service with at least 1,000 hours, except for nonresident aliens, employees covered by a collective bargaining agreement, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provides for automatic enrollment. Any newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a one percent withholding of pretax annual compensation. This withholding will increase by one percent each subsequent year until the automatic election reaches a maximum withholding contribution of five percent of compensation. The Company contributes ten percent of eligible participants' contributions up to a maximum of four percent of eligible compensation. Participants must be employed on the last day of the Plan year to receive the Company's matching contribution. Profit sharing amounts may be contributed at the discretion of the Company. Participants must complete at least 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to receive an allocation of any discretionary profit-sharing contribution. There were no such contributions for the year ended December 31, 2024. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, as well as allocations of the Company's discretionary profit-sharing contribution, if any, and Plan earnings. Participant accounts may also be charged with an allocation of certain administrative expenses. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary profit-sharing contributions, if any, are based on the ratio of the participant's compensation to total compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Benefits are payable in lump sum, installment or partial payments.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of continuous service of at least 1,000 hours per year. A participant is 20 percent vested after two years of service is completed and vests an additional 20 percent per year until full vesting after six years.

Forfeitures

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,095 and \$5,222, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During the year ended December 31, 2023, \$2,095 of forfeited nonvested accounts were used to reduce Company contributions or pay Plan expenses.

Terminated Employees with Vested Benefits

As of December 31, 2024, there were 5 participants with vested balances totaling \$28,204 that remained in the Plan at year-end. The benefit payments are not reflected in the financial statements until benefit claims have been processed and approved for payment

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as distribution administration fees, are charged directly to the participant's account and are included in administrative expenses. Investment advisory and management fees are also charged to participants based on account balances.

Funding Policy

It is the policy of the Plan Sponsor to remit the employee contributions as soon as administratively possible.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's collective trust fund investments are valued at their net asset value per unit as a practical expedient as reported by the fund manager of the collective trust.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions.

Contributions

Participant contributions and the related Company matching contributions are recognized in the period the participant contribution is withheld from compensation. Company discretionary profit-sharing contributions, if any, are recognized in the period the related eligible compensation is paid to the participant.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events for disclosure in these financial statements through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3 – Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Hand Benefits & Trust Company, the custodian of the Plan.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

Note 5 – Risks ad Uncertainties

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested.

Note 7 – Tax Status

The Plan is a pre-approved plan of Benefit Plans Administrative Services LLC which received an opinion letter on June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the form of the plan document was under the applicable requirements of the Internal Revenue Code (“IRC”). The Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in accordance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator has analyzed the tax position taken by the plan has concluded that as of December 31, 2024, there are no uncertain positions taken nor expected to be taken that would require recognition of a liability or disclosure in the financial statements. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date which it was filed, whichever is later.

Note 8 – Related Party Transactions and Transactions with Parties-in-Interest

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under DOL regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investment advisors, legal counsel, and Plan auditor.

During the year ended December 31, 2024 and 2023, the Plan made direct payments of \$12,302 and \$10,144, respectively, to certain parties in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan Sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for the investment management services are included in the net appreciation (depreciation) in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

Note 10 – Operational Failures Related to Participant Deferrals and Matching Contributions

During the year ended December 31, 2024, the plan sponsor identified certain operational errors related to the definition of compensation used for participant elected deferrals and matching contributions. According to the Plan’s governing documents, compensation for elected deferrals and matching contributions is pretax annual compensation, which includes bonuses and automobile allowances, and excludes compensation deferred under Section 125 cafeteria plans. Pretax annual compensation also does not include certain reimbursements, including telephone reimbursements.

However, the plan sponsor determined that elected deferrals were erroneously withheld on compensation amounts excluded under Section 125 cafeteria plans. In addition, elected deferrals, were not withheld on certain compensation that should have been included, specifically bonuses and automobile allowances.

The plan sponsor also determined that matching contributions were calculated erroneously based on incorrect compensation. The compensation used to calculate matching contributions excluded automobile allowances and it should have been included. The compensation used to calculate matching contributions also included telephone reimbursements and it should have been excluded.

The plan sponsor intends to correct these operational errors through the Self-Correction Program (SCP) under the IRS Employee Plans Compliance Resolution System (EPCRS). The correction may include the calculation and deposit of missed elective deferrals, matching contributions, and the distribution of excess contributions, adjusted for earnings, as applicable. The amount of the correction cannot be reasonably determined as of the date of this report. Management has evaluated the nature of these errors and determined that they do not have a material impact on the accompanying financial statements.
