**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Window Nation 401(k) and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Window Nation 401(k) and Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Notes 3 and 4, to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

### NOTES TO THE FINANCIAL STATEMENTS

#### 1. DESCRIPTION OF PLAN

The following brief description of The Window Nation 401(k) and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

##### General

The Plan is a defined contribution plan adopted by Window Nation, Inc. (the Company). The Plan was amended and restated effective April 16, 2021 and adopted the Great-West Trust Company, LLC (GWT) prototype plan document. Employees that are covered by a collective bargaining agreement, leased employees or non-resident aliens are not eligible for the Plan. Each eligible employee of the Company can become a participant in the Plan on the first entry date following the date the employee attains twenty-one years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In recent years, the Plan has been amended to comply with the Heroes Earnings Assistance and Relief Tax (HEART) Act, the Worker, Retiree, and Employer Recovery Act (WREERA), and other Internal Revenue Service (IRS) and Department of Labor (DOL) guidance. The purpose of these changes was to comply with IRS and DOL regulations and maintain the Plan's tax exempt status.

##### Contributions

Participants may elect to contribute their eligible compensation plus additional catch-up contributions on a pre-tax basis, subject to IRS limitations for the Plan year. The Plan also permits rollover contributions from other qualified retirement plans. The Company may make a matching contribution to each participant's account based on the participant's deferral contribution. Matching contributions totaled \$518,455 for the year ended December 31, 2024. Participants direct the investment of contributions into a variety of investment options offered by the Plan. The GWT plan document also permits after-tax Roth contributions and has an automatic deferral feature. Employees that do not complete a salary reduction agreement to contribute to the Plan will be automatically enrolled and have their deferral rate set as 1% of eligible compensation. This automatic deferral amount will increase by 1% each year up to a maximum of 6%. These annual increases will occur as soon as administratively feasible following the anniversary date following the date that an employee's automatic enrollment begins.

The Company also offers a discretionary profit sharing contribution to eligible employees. The discretionary profit sharing contribution is determined annually by the Company. The Company may also make a discretionary Qualified Nonelective Contribution (QNEC) to the Plan. No discretionary profit sharing contributions or QNECs were made for the year ended December 31, 2024. Total annual contributions made to the Plan on behalf of any participant are subject to limitations imposed under the Internal Revenue Code (IRC).

##### Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's matching, discretionary QNEC, and discretionary profit sharing contributions, and Plan earnings (losses), and charged with an allocation of administrative expenses. The Company's matching contributions are allocated based on participants' deferrals. Discretionary QNEC and profit sharing contribution allocations are based on participant compensation or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. DESCRIPTION OF PLAN (continued)

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service according to the following schedule:

#### Forfeitures

Forfeitures are created when participants terminate employment prior to becoming entitled to full benefits. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$85,855 and \$60,414, respectively. Forfeitures totaled \$75,709 for the year ended December 31, 2024. Forfeitures used to reduce Company contributions or Plan expenses totaled \$50,268 for the year ended December 31, 2024.

#### Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Lump sum distributions are required if the vested balance is \$1,000 or less. For accounts greater than \$1,000, the participant must consent to any distribution of their account. The Plan Administrator may distribute the participant's vested account in a lump sum without consent following the later of the calendar year in which the participant attains age 70½ or they terminate employment. In-service distributions may be made from fully vested accounts if the participant has attained age 59½. In the case of hardship, a participant may apply for a distribution described in the Plan document.

#### Administrative Expenses

Administrative expenses are paid by the Company or the Plan. During the year ended December 31, 2024, administrative expenses paid by the Plan totaled \$135,353.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

##### Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on the investments purchased and sold, as well as held, during the year.

##### Payment of Benefits

Benefit payments to participants are recorded when paid. Benefit payments totaled \$1,989,743 for the year ended December 31, 2024.

##### Subsequent Events

The Plan evaluated subsequent events through October 14, 2025, the date these financial statements were available to be issued.

#### 3. CERTIFICATION

Investment information included in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments held at December 31, 2024, and net appreciation (depreciation) in the fair value of investments, interest and dividends for the year ended December 31, 2024, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by GWT, the Plan custodian and have not been audited by the independent auditors.

#### 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

Fixed annuities – Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issues.

Collective trust funds – Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to measure fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the net asset value. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trusts, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers between levels of the fair value hierarchy as of the actual date of the event of change in circumstances that caused the transfer. There were no transfers between levels of the fair value hierarchy during 2024.

5. TAX STATUS

The trust established under the Plan, which holds the Plan's assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and accordingly, the trust's net investment income is exempt from income taxes. The Plan has adopted an IRS approved prototype plan. The prototype plan has received a favorable opinion letter from the IRS that it qualifies under IRS Code Section 401(a), provided all terms of the Plan are followed. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan evaluates its tax positions in accordance with FASB ASC 740. At December 31, 2024, the Plan Administrator believes that all of its tax positions are appropriate based on current facts and circumstances, and no liability related to uncertain tax positions needs to be recorded.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their account balances and these balances would be distributed to the participants after payment of any administrative expenses.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan transactions include units of investment accounts managed by GWT for the year ended December 31, 2024. Therefore, these transactions qualify as party-in-interest transactions.

8. RISKS AND UNCERTAINTIES

The participants direct the Plan to invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
