### Note 1—Description of the Plan

The following description of the Wincorp International, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan’s provisions.

*General* – The Plan is a defined contribution plan covering all full-time employees of Wincorp International, Inc. and its related entities, International Poultry Breeders, LLC; International Poultry Breeders Hatcheries, Inc.; England Farms, Inc.; England Transport, Inc.; Wincorp Properties, Inc.; and The Best Dressed Chicken, Inc., (collectively the “Sponsor”, “Employer” or “Company”), as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Employees of the Company are considered eligible for participation when they have reached six months of service and are age 20.5 or older. An eligible employee may enter the Plan on the next semi-annual entry date after all entry requirements have been met.

*Administration of Plan Assets* – The Plan is administered by the Company. The Plan’s assets were maintained and administered by Reliance Trust Company (the “qualified institution”) during 2024 and to the date of the change in trustee – see *Change in Trustee* paragraph in Note 1. The Plan’s recordkeeping services and maintenance of participant account records are managed by ADP Retirement Services. The Plan administrator is responsible for the oversight of the Plan and determines the appropriateness of the Plan’s investment offering and monitors investment performance.

*Change in Trustee* – On December 31, 2024, the formal transfer of all assets from Reliance Trust Company to Bank of America, N.A. was initiated in the amount of \$13,977,997. The transfer was not completed until January 2025. As such, the amount received by Bank of America, N.A. is recorded as assets-in-transit as of December 31, 2024.

*Employee Contributions* – For the year ended December 31, 2024, participants may contribute up to \$23,000 of pre-tax or post-tax annual compensation subject to certain Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e., rollover contributions).

*Employer Contributions* – The Company may make a matching contribution equal to 100% of salary deferrals that do not exceed 5% of individual participant compensation, with the Company determining the amount of the discretionary percentage each year. During the year ended December 31, 2024, employer matching contributions totaled \$705,343. The Company may also make a discretionary profit sharing contribution to the Plan. All participants share in the allocation regardless of service completed during the Plan year or employment status on the last day of the Plan year. There was no discretionary profit sharing contribution made for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

*Participant Accounts* – Each participant’s account is credited with the participant’s contributions, Employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

### Note 1—Description of the Plan (continued)

*Investment Options* – The Plan’s assets are held and managed by the qualified institution. The participants direct the investment of their account balance and may select from various investment options maintained by the qualified institution. Participants may change their investment option selections on any business day as defined by the Plan.

*Vesting* – Participants are 100% vested in their individual deferral and rollover contributions and the allocated earnings thereon. A participant’s vested interest in the Employer’s contributions are based upon the participant’s years of continuous service. A participant is 100% vested after five years of credited service. Vesting in the remainder of their accounts is based on years of continuous service as follows:

1	20%
2	40%
3	60%
4	80%
5	100%

Participants become fully vested in the event of retirement, death, and disability, as defined by the Plan.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested portion of their accounts balance. The loans are secured by the balance in the participant’s account. The loan interest rate, determined quarterly, is set at prime plus 1%, as defined. Principal and interest is paid ratable through biweekly payroll. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

*Payment of Benefits* – A participant’s entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant’s account or annual installments. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. Immediate lump-sum distributions may be made to terminated participants if the participant’s vested account balance is \$5,000 or less. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

*Forfeitures* – Forfeitures may be used to pay Plan expenses or to reduce Employer contributions, if any. At December 31, 2024 and 2023, there were no forfeited nonvested account balances. During the year ended December 31, 2024, forfeitures totaling approximately \$49,000 were used to pay Contributions.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements as well as the reported amounts of changes in net assets during the reporting period. Such estimates include those regarding fair value of investments. Actual results could differ from those estimates.

**Note 2—Summary of significant accounting policies (continued)**

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

*Payment of Benefits* – Benefits paid to participants are recorded upon distribution.

*Administrative Expenses* – Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and for distributions are charged directly to the participant's account and are included in administrative expenses totaling approximately \$51,000. Investment related expenses are included in net appreciation of fair value of investments.

*Investment Valuation and Income Recognition* – Investments in the Plan are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value. A fair value hierarchy exists which requires an entity to maximize the use of observable inputs when measuring fair value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

*Fair Value Measurements* – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value. U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

### Note 2—Summary of significant accounting policies (continued)

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for Plan instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy, if applicable. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds* – Mutual funds are valued based on the same securities traded on a national exchange at the last reported sales price on the last business day of the Plan year; investments traded in the over-the-counter market and listed securities for which no sale was reported on the last day of the Plan year are valued at the last reported bid price. These assets are classified as Level 1 assets within the fair value hierarchy.

*Common Collective Trust Fund* – Investments in the common collective trust funds are stated at estimated daily net asset value (“NAV”), which has been determined based on the unit values of the funds. The investment is valued at a daily-calculated unit value, which is determined by the organization sponsoring such fund by dividing the funds' net assets at fair value by its units outstanding at each valuation date. As the investment is indirect, NAV is used as a practical expedient to estimate fair value and the trusts are shown outside the fair value hierarchy.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 3—Information certified by the qualified institution (unaudited)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the qualified institution has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedule:

- Notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits. As of December 31, 2023, common collective trust funds had no unfunded commitments and redemptions are processed daily with a no notice period.

**Note 5—Tax status**

The underlying non-standardized profit sharing plan has received a determination letter from the IRS dated October 6, 2020, stating the written form of the underlying document is qualified under Section 401(a) of the IRC, and any employer adopting this form of the Plan will be considered to have a Plan qualified under Section 401(a) of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator and the Plan's tax counsel have analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. Additionally, the Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6—Parties-in-interest transactions**

Certain Plan investments and the related transactions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, were in investment funds managed by the qualified institution; therefore, these investments and transactions qualify as party-in-interest transactions. Fees paid during the year for accounting and other services rendered by parties-in-interest were approximately \$51,000. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants.

### **Note 7—Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8—Plan termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event such discontinuance results in termination of the Plan, the Plan provides that the assets be allocated among the participants and beneficiaries in the amounts credited to each participant's respective account at the effective date of such termination. In the event of Plan termination, participants will become 100% vested in their account balances.

### **Note 9—Subsequent events**

The Plan's management has evaluated events through October 14, 2025, the date the financial statements were available to be issued. No events have occurred subsequent to the date of the financial statements that would require adjustment to, or disclosure in, the financial statements.
