DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following description of the Murphy Auto Group 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees of Murphy Auto Group Inc. (the “Company” or “Employer”), who are age 21 or older, excluding leased employees. The Plan was formed and adopted on September 1, 1996, and was restated January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Plan is administered by the Company. The Plan’s assets are maintained and administered by John Hancock Life Insurance Company, the qualified institution.

Participant Contributions – Participant contributions may be either on a pre-tax or after-tax basis, up to the maximum limitations of the Internal Revenue Code (“IRC”). The participants’ basic annual contributions cannot exceed \$23,000, and an additional \$7,500 for catch-up contributions for participants who are 50 or older.

Employer Contributions – Employees become eligible for matching contributions and profit-sharing contributions after 90 days of service. The Company may make a discretionary-matching contribution on behalf of each eligible participant. Management made matching contributions equal to 10% of the participant’s contribution up to 4% of the participant’s eligible compensation for the year ended December 31, 2024. No profit-sharing contributions were made during the year ended December 31, 2024.

Participation Accounts – Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contributions and Plan earnings and charged with participant distributions and an allocation of administrative expenses. Allocations are based on participant earnings, deferrals, or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Participants may direct the investment of their account balances into various investment options offered by the Plan.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Each participant’s Company matching and discretionary contribution plus actual earnings thereon become vested according to the following schedule for years of service:

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than one loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years. Notes are secured by the vested balances in participants’ accounts. The interest rate on loans outstanding as of December 31, 2024 ranged between 4.25% to 9.50%. Notes receivable from participants are recorded at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are deemed distributions based upon the terms of the Plan document.

Note 1—Description of the Plan (continued)

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a partial payment or a lump-sum amount, equal to the value of the participant’s vested interest in his or her account as defined in the Plan Agreement. The lump-sum can be paid in a cash distribution, direct rollover distribution, or a combination cash & direct rollover distribution. A participant who terminates with a vested balance of less than \$5,000 will be mandatorily cashed out. Participants may request an in-service distribution upon reaching the age of 59½ or as a qualified reservist.

Hardship Distribution – Hardship distributions are permitted if the distribution is due to expenses incurred or necessary for medical care described in the IRC Section 213(d), purchase of a principal residence, payment of tuition, to prevent eviction from or foreclosure of the principal residence, or any other condition which the Commissioner of the Internal Revenue Service (“IRS”) deems an immediate and financial need of the participant.

Forfeitures – As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$72,000 and \$39,000 respectively. These amounts may be used to pay Plan expenses or to reduce any nonelective contributions or Employer-matching contributions. During the year ended December 31, 2024, approximately \$15,500 were used to pay Plan expenses.

Administrative Expenses – Administrative expenses are paid by either the Company on behalf of the Plan or from Plan assets. There is no guarantee the Company will continue to pay the Plan’s expenses.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

Note 2—Summary of significant accounting policies (continued)

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability, and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Pooled Separate Accounts – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. These investments measured using NAV practical expedient are exempt from classification under the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with that of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest income is recognized when earned. Net appreciation in fair value of investments includes the Plan's gains or losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when they have been processed and paid by the Plan.

Note 3—Information provided and certified by the qualified institution (unaudited)

The Plan management has elected the method of compliance as permitted by 29 CFR 2520.103-8 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. John Hancock Life Insurance Company (the “qualified institution”) as of December 31, 2024 and 2023, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and was not subjected to any auditing procedures performed by the independent public accountant:

Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;

Net appreciation in fair value of investments, interest income on notes receivable from participants, and transfers into the Plan as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and

Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4—Fair value measurements

Pooled separate accounts are measured at fair value using NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. As of December 31, 2024 and 2023, pooled separate accounts had no unfunded commitments, and redemptions are processed daily with a no notice period. As all of the Plan’s 2024 and 2023 investments are exempt from the fair value hierarchy, the table has been excluded.

Note 6—Party-in-interest transactions

Certain Plan investments were managed by the qualified institution, throughout the year; therefore, these investment transactions qualify as party-in-interest transactions. The Plan's administrative expenses are paid in part by the Plan and in part by the Plan sponsor, as provided by the Plan document. In addition, certain administrative functions are performed by employees of the Plan sponsor. Neither the Plan sponsor nor any of its employees receive reimbursement and/or compensation from the Plan. Notes receivable from participants also qualify as party-in-interest transactions as they are transacted with Plan participants.

Note 7—Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8—Income tax status

The IRS has determined and informed the Plan administrator by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9—Risks and uncertainties

The Plan provides for various investment options in investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Note 10—Subsequent events

Plan management has evaluated all events subsequent to the statement of net assets available for benefits date of December 31, 2024 through October 14, 2025, which is the date these financial statements were available to be issued.

Plan Amendments – Effective January 1, 2025, the Plan has been amended to become a traditional safe harbor plan. The Employer will make matching contributions intended to satisfy the QACA "ADP test safe harbor" requirements. These contributions will be made to the accounts of all eligible participants who make elective deferrals. The Employer will match 100% of the participants elective deferrals that do not exceed 4% of the participants compensation.
