**INDEPENDENT AUDITOR'S REPORT**

To the Board of Trustees  
of the International Union of Elevator Constructors Death Benefit Plan

**Opinion**

We have audited the accompanying financial statements of the International Union of Elevator Constructors Death Benefit Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the period from inception through December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the period from inception through December 31, 2024 and 2023, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

**Responsibilities of Plan Management for the Financial Statements**

Plan management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, Plan management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Plan management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by Plan management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS  
DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the International Union of Elevator Constructors Death Benefit Plan (Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

- A. General - The International Union of Elevator Constructors Death Benefit Plan is a single employer defined benefit health and welfare benefit plan providing death benefits to active members and probationary apprentices, of the International Union of Elevator Constructors. The Plan was formed as of January 1, 2023 pursuant to an Agreement and Declaration of Trust. The Plan is operated and administered by a Board of Trustees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. Benefits – Dependents of eligible members, and dependents of probationary apprentices, satisfying certain requirements are provided a death benefit for on-the-job fatalities. The Death Benefit amount of \$225,000 is payable for any on-the-job fatality that occurs on or after January 1, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The accompanying financial statements are prepared on the accrual basis of accounting. The significant accounting principles and practices utilized to prepare the financial statements are described as follows:

- A. Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- B. Accounting Standards Codification - The Financial Accounting Standards Board ("FASB") publishes a single source of authoritative nongovernmental U.S. GAAP, the Accounting Standards Codification, referred to in these notes as "ASC".
- C. Payment of Benefits – Benefit payments to participants are recorded upon distribution. Payments disbursed for a future fiscal year are reported in the financial statements as prepaid benefits.
- D. Cash - In Trust with Sponsor - This amount represents assessments for the Plan received by the Plan's Sponsor, the International Union of Elevator Constructors, and held in cash as of the end of the fiscal year.
- E. Contributions - All active members were assessed twenty-five dollars (\$25.00) on December 1, 2023 and December 1, 2024. Local Unions are responsible for collecting the IUEC Death Benefit assessment and transmitting them to the Plan's Sponsor, the International Union of Elevator Constructors.
- F. Expenses - All expenses of the Plan are paid by the International Union of Elevator Constructors, the Plan Sponsor.

3. FUNDING POLICY

The Sponsor's funding policy is to assess active members for the contributions to the Plan. If the IUEC Death Benefit Fund balance falls below two times the total IUEC Death Benefit amount, the goal is to assess and determine the amount of any additional IUEC Death Benefit assessment(s) considered required.

4. RELATED PARTY TRANSACTIONS

At December 31, 2024, and during the period then ended, all of the assessments received for the Plan were held in trust by the Plan's Sponsor, the International Union of Elevator Constructors, in cash.

5. SUBSEQUENT EVENTS

ASC Topic 855 - Subsequent Events establishes standards of accounting for the disclosure of events that take place after the date of the financial statements, but before the financial statements are issued. Depending upon facts and circumstances, for certain subsequent events their effect must be recognized in the financial statements while for others applicable information should be disclosed in the notes to the financial statements. Plan management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

6. TAX STATUS

The Plan operates as Voluntary Employees' Beneficiary Association (VEBA) and is anticipating but has not received from the Internal Revenue Service notification that it is exempt from federal income taxes pursuant to Internal Revenue Code Section 501(a) as an organization described in Internal Revenue Code Section 501(c)(9). The Plan and Trust will not, however, be exempt from taxes on net income from unrelated business activities, if any. A VEBA that is exempt from federal taxation is required to operate in conformity with the Internal Revenue Code to maintain its exempt status. The Trustees believe that the Plan and Trust are being operated in compliance with all applicable requirements to be tax exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

ASC 740 - Income Taxes clarifies the accounting for uncertainty in income taxes recognized in an organization's financial statements and prescribes a recognition threshold and measurement attribute for tax positions taken or expected to be taken on a tax return, including the entity's status as a tax-exempt entity. The Plan has determined there is no impact on the Plan's financial statements as of March 31, 2024.

7. PLAN CONTINUATION

It is the present intention of the Trustees and Sponsor to continue the Plan indefinitely. In the event of the termination of the Plan for any reason, the assets of the Plan shall be used to or for the benefit of the participants and beneficiaries. Article IX of the Agreement and Declaration of Trust describes the procedure upon termination.
