## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of the PsiQuantum 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to the participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements, including omissions, are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

#### **Other Matter – Supplemental Schedules Required by ERISA**

The supplemental schedules included in the accompanying table of contents are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by the qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### 1. Description of Plan

The PsiQuantum 401(k) Plan (the Plan) was established by PsiQuantum, Corp. (the Company), effective January 1, 2017, to provide participants with a method to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Company has appointed a Plan committee, consisting of Company employees, to manage the operations and administration of the Plan. The Company has contracted with Empower Trust Company, LLC to serve as Plan trustee, and Empower Annuity Insurance Company of America to serve as the Plan investment custodian and third-party administrator to process and maintain the records of participant data (collectively, Empower). The Company has engaged Vita Planning Group LLC as an investment advisor to assist the Plan in selecting the investment options offered to the participants and monitoring investment performance.

#### *Eligible Participants:*

Company employees, as defined by the Plan agreement, may begin participating in the Plan on the first day of the month following their date of hire. Certain temporary employees whose regularly scheduled service is less than 1,000 hours per year, and nonresident alien employees, are excluded from participating in the Plan.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax salary deferrals or Roth post-tax contributions up to 90% of their annual eligible compensation, as defined by the Plan agreement. Participants who have reached the age of 50 may elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other qualified plans (rollovers), subject to Code regulations.

#### 1. Description of Plan (continued)

##### *Contributions:* (continued)

The Plan provides for automatic Plan enrollment on the date employees are eligible to participate in the Plan. The automatic salary deferral contribution rate is 5% of participant eligible compensation, as defined in the Plan agreement, unless participants request a different amount to be contributed or formally decline participation. In January of each year, the automatic contribution percentage increases 1%, until it reaches 10% of compensation, unless participants make an affirmative election to change the deferral percentage or formally decline participation. Participants may adjust their deferral rate or discontinue their contributions at any time.

The Company may make discretionary matching contributions to the Plan as determined by the Company's Board of Directors. In 2024, the Company made matching contributions to the Plan equal to 50% of participant contributions, up to a maximum of \$5,000 of eligible compensation, as defined by the Plan agreement. Company matching contributions were \$1,289,305 in 2024.

Contributions are subject to certain limitations under the Code.

##### *Participant Accounts:*

Each participant's account is credited with participant contributions, rollovers, and an allocation of Company contributions, plus earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant account balances.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

##### *Vesting:*

Participants are fully (100%) vested in their account balances.

##### *Notes Receivable from Participants:*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

#### 1. Description of Plan (continued)

##### *Notes Receivable from Participants: (continued)*

Participants may borrow up to one-half of their account balance, for a minimum of \$1,000 and a maximum of \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a term of up to 15 years may be granted. Participants may only have one note outstanding at a time. Participant notes are evidenced by a written note, secured by the participant account balance, and bear interest at the prime rate, as published in The Wall Street Journal on the 1<sup>st</sup> business day of the month the note is granted, plus 2%. The interest rate on the participant notes outstanding as of December 31, 2024 range from 9.75% to 10.50%. Repayment of principal and interest is generally made through payroll deductions.

##### *Payment of Benefits:*

Upon termination of service, participants may elect to leave their account balances in the Plan or receive their benefits in a lump sum amount equal to the value of the participant account balance, or in installment payments. Accounts between \$1,001 and \$7,000 may be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Accounts with a balance of \$1,000 or less may be distributed directly to the participants without participant approval. Benefits are recorded when paid.

##### *Administrative Expenses:*

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain account maintenance and transaction fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

##### *Risks and Uncertainties:*

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risks in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

##### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

#### 2. Summary of Significant Accounting Policies

##### *Basis of Accounting:*

The Plan prepares its financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Investments:*

The Plan's investments consist of mutual funds, collective trust funds and a guaranteed interest account. These investments are accounted for as follows:

*Mutual Funds:* These funds are valued at the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

*Collective Trust Funds (CTFs):* CTFs are valued using the NAV practical expedient as reported by Empower. The NAV practice expedient is based on the fair value of the underlying assets owned by the CTFs, minus its liabilities, and then divided by the number of units outstanding. The NAV practice expedient of the CTFs is calculated based on a compilation of primarily observable market information.

##### *Investments:* (continued)

*Guaranteed Interest Account:* The EI Fixed Account Fund (the Fund) is a guaranteed interest account and is part of Empower's general fund account. Empower sets the guaranteed interest rate quarterly for all existing assets in the portfolio. The Fund is valued using the NAV practical expedient. NAV, as reported to the Plan by Empower, represents contributions made under the Fund, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their account balance at contract value. There are no reserves against contract value for credit risk to Empower or otherwise.

The methodology for calculating the Fund's interest crediting rate is based on the earnings of the underlying assets in the entire portfolio compared to the minimum stated interest crediting rate and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for the Fund may be derived by averaging the quarterly gross interest rates for the Fund during the year. The crediting interest rate is based on a formula agreed upon with Empower but may not be less than zero percent.

The NAV practical expedient would not be used for the CTFs or the Fund if it is determined to be probable the Plan will sell the investments for an amount different from the reported NAV. If the Plan initiates a full redemption of the trust, the Empower reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidated will be carried out in an orderly business manner.

##### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those investments.

#### *Fair Value Measurement:* (continued)

The three-level hierarchy for fair value measurement is defined as follows:

- Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds are recorded at fair value and classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023. The CTF and the guaranteed interest account are valued using the NAV practical expedient and are excluded from the fair value hierarchy under GAAP.

#### *Income Recognition:*

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

#### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### 4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Nonexempt Prohibited Transactions

In 2023 and 2024, participant contributions and note repayments totaling \$292,344 and \$353,736, respectively, were not remitted on a timely basis as required by the Department of Labor (DOL). The DOL considers delinquent contributions to be nonexempt prohibited transactions with the Plan sponsor that can jeopardize the Plan's tax-exempt status.

6. Party-In-Interest Transactions

The guaranteed interest account is managed by Empower. As Empower is the Plan's trustee, purchases and sales of this investment by the Plan qualify as party-in-interest transactions. Notes receivable transactions with participants also qualify as party-in interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

7. Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
