Opinion

We have audited the financial statements of Town Pump Inc. Employee Benefits Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and statements of benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefit and statement of changes in benefit obligations for the year ended December 31, 2024 and the related notes to the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Employee Benefits Plan's internal control. Accordingly, no such opinion is expressed.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Town Pump Inc. Employee Benefits Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a partially self-funded employee health and welfare benefit plan that provides health and other benefits covering substantially all active employees of Town Pump, Inc., ET. AL. (the Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides health benefits including medical, hospital, maternity, surgical, dental, and other eligible medically related, necessary expense, life insurance and death benefits to eligible employees of the Sponsor, and their beneficiaries and covered dependents as well as to former employees and/or dependents that have elected to continue their coverage under COBRA (Consolidated Omnibus Budget Reconciliation Act of 1985) and its amendments.

Benefits are offered to full-time employees who have satisfied the applicable eligibility requirements working an average of thirty hours per week and have met the required waiting period. Employees must then elect coverage or waive coverage by the completion of an enrollment or a waiver form within thirty-one days of their eligibility date.

Benefit claims of active participants and their dependents are provided by the self-funded assets of the Plan. The Plan has retained the services of Coastal Administrative Services, Inc., an independent third-party administrator, to handle and process the benefit claims. The responsibility for the payments to participants and providers is retained by the Plan. For the years ended December 31, 2024 and 2023, aggregate and specific stop-loss insurance for the Plan was underwritten by HCC Life Insurance Company and Tokio Marine HCC, respectively. The stop-loss insurance is triggered when annual benefits paid to an individual participant exceed \$500,000. Life insurance benefits and accidental death and dismemberment benefits are covered by a group-term policy with Hartford Life and Accident.

Contributions

The Sponsor, employees that have elected to be covered, and COBRA participants all make contributions to the Plan. These contributions provide the Plan's funding. Participant contributions for the Plan year ended December 31, 2024 were \$2,207,764. Sponsor contributions for the Plan year ended December 31, 2024 were \$6,132,775.

Note 1: Description of Plan (Continued)

Plan Termination

Although it has not expressed any intentions to do so, the Sponsor has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In case of Plan termination, all previous contributions shall continue to be utilized for the purpose of paying benefits under provisions of the Plan with respect to claims arising before such termination, or shall be used for the purpose of providing similar health benefits to participants, until all contributions are exhausted.

Tax Status

The trust established under the Plan is an IRC Section 419A trust. Under 419A(g)(1) any tax due on deemed unrelated income as described in 419A(g)(2) would be included as gross income to the employer. No determination letter from the Internal Revenue Service has been requested for the Plan. The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions and other evidence. It is the opinion of the Plan Administrator that the Plan has no uncertain tax positions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Incurred but not Reported Claims (IBNR)

Plan obligations as of year-end for claims incurred but not reported are estimated through the use of benefit payment history data. Based on this information, an estimate of claims incurred, but not reported is calculated. There is a reasonable possibility that a significant change in this estimate could occur in the near term.

Town Pump Inc. is obligated to contribute amounts necessary to pay for the benefits of the Plan which may ultimately exceed the estimate.

Use of Estimates

The preparation of the accompanying financial statements in conformity with accounting principles generally accepted in the United States (GAAP) requires management to make certain estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Estimates and assumptions made by management include IBNR. Actual results could differ from these estimates.

Notes to Financial Statements

Note 2: Summary of Significant Accounting Policies (Continued)

Cash Equivalents

The assets of the Plan are comprised of cash and money market funds. Participant contributions are remitted after each payroll period into the trust account. Monthly, the Sponsor transfers money to the trust account. Deposits maintained in the trust account are restricted for payment of plan expenses. The trust account is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. As of December 31, 2024 and 2023, the Plan's deposits in the trust account were \$1,992,155 and \$1,131,574, respectively. As of December 31, 2024 and 2023, \$6,238,129 and \$3,979,616, respectively, were held in money market mutual funds. These funds are not insured by the FDIC.

Pharmacy Rebates

The Plan receives rebates for medical prescriptions from TrueScripts. The pharmacy rebate is paid to the Plan in full and recorded on the statement of changes in net assets available for benefits net of benefits paid for participant claims. As of December 31, 2024, there was no rebate receivable.

Note 3: Benefit Obligations

Qualified health care costs incurred by participants and their dependents are covered by the Plan. At the end of any Plan year, there may be claims that have been incurred by the participants and their dependents that have not been reported to the Plan. These claims are estimated by comparing reported claims of the current year to reported claims of the prior year to estimate the percentage of claims that will be reported at a later date. December 31, 2024 and 2023, incurred but not reported claims were estimated to be \$825,988 and \$330,318, respectively. As of December 31, 2024 and 2023, claims to be submitted to the Sponsor, but not yet processed were \$437,731 and \$292,290, respectively.

Note 4: Administrative Expenses

Administrative expenses are disclosed on the financial statements and paid from the net assets of the Plan. The Sponsor pays certain other miscellaneous expenses on behalf of the Plan and is not reimbursed for those expenses. Expenses paid by the Sponsor are not included in these financial statements.

Note 5: Other Matters

The Plan was established to offer a program of benefits operating as an "Employer Welfare Benefit Plan" under the Employee Retirement Income Security Act of 1974 (ERISA) and any amendments thereto.

Employee contributions to the Plan are made on a pre-tax basis pursuant to Section 125 of the Internal Revenue code. The Sponsor shares the premium cost with the participants. A contribution rate schedule is determined annually by the Sponsor.

Note 6: Related-Party Transactions and Party-in-Interest Transactions

Coastal Administrative Services, is a Third Party Administrative, working through the Plan. For the Plan year ended December 31, 2024, Coastal Administrative Services received \$243,531 in administrative service fees paid from net assets of the Plan.

6 Degrees Health DX LLC (6 Degrees) is a contract service provider, the plan administrator under the Plan. For the Plan year ended December 31, 2024, 6 Degrees received \$277,204 in administrative service fees paid from net assets of the Plan.

Marsh McClennan Agency (MMA) is a contract service provider, the broker under the Plan. For the Plan year ended December 31, 2024, MMA received \$159,827 in administrative service fees paid from net assets of the Plan.

Prism Health Strategists LLC (Prism) is a contract service provider, the third party administrator under the Plan. For the Plan year ended December 31, 2024, Prism received \$16,677 in administrative service fees paid from net assets of the Plan.

Innovative Care is a contract service provider, the Medical Management under the Plan. For the Plan year ended December 31, 2024, Innovative care received \$6,671 in administrative service fees paid from net assets of the Plan.

Benefitfocus is a COBRA Administrative, working through the Plan. For the Plan year ended December 31, 2024, Benefitfocus received \$9,055 in administrative service fees paid from net assets of the Plan.

Superior Vision is a contract service provider, the third party administrator under the Plan. For the Plan year ended December 31, 2024, Superior Vision received \$597 in administrative service fees paid from net assets of the Plan.

The plan administrator, the trustees, and various members of the benefits committee are employees of the Company and plan participants. The only transactions between the parties are contributions to the Plan and payment of plan expenses.

Note 7: Plan Amendments

Amendments to address and modify definitions and benefits available under the Plan were made during 2024 and 2023. Participants should refer to the plan document for a complete description of the Plan's provisions.

Note 8: Medicare Prescription Drug Act

The Medicare Prescription Drug Improvement and Modernization Act of 2003 provides a prescription drug benefit under Medicare Part D as well as federal subsidy to sponsors of retiree health care benefit plans that provide a benefit that is at least actuarially equivalent to Medicare Part D.1. For single-employer plans, the Medicare subsidy amount is paid to the sponsors and does not flow into the plan. The Plan Administrator has determined that benefits provided by the Plan are not actuarially equivalent to Medicare Part D.1. Thus, the changes in benefit obligations do not reflect any amount associated with the Medicare subsidiary because the Plan is not directly entitled to the Medicare subsidy.
