We have performed the audits of the accompanying financial statements of The Rawlings Group 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the U. Management has obtained a certification from Fidelity Management Trust Company (the "Trustee"), a qualified institution, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

#### Note A--Description of Plan

The following description of The Rawlings Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General--The Plan is a defined contribution plan sponsored by The Rawlings Company LLC, Rawlings & Associates, PLLC, Rawlings Financial Services, LLC, The Rawlings Foundation, Inc., The Crab Orchard Animal Sanctuary, Inc., and Crab Orchard Farm. Effective April 1, 2024, the Plan was amended to include only The Rawlings Company LLC, Rawlings & Associates, PLLC, and Rawlings Financial Services, LLC (collectively referred to as the "Company") as participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). An employee becomes a participant in the Plan on the first entry date (first day of each month) coinciding with or immediately following attainment of age eighteen.

Contributions--A participant may agree to a deferral in salary as a percentage of his or her annual compensation, up to Internal Revenue Code ("IRC") limitations. If a participant elects to make salary deferral contributions to the Plan, the Company may make a discretionary employer matching contribution equal to 20% of the first 10% of compensation that a participant contributes to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. The automatic deferral percentage is increased annually by 1% up to a maximum of 10% until changed by the participant. Contributions are automatically invested in a designated balanced fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participant Accounts--Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution, Plan earnings, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting--Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 33% vested in employer contributions after one year of credited service, 66% vested after two years, and 100% vested after three years. Participants terminated prior to April 1, 2020 receive a different vesting schedule in the remainder of their accounts: 0% vested for less than two years of credit service, 20% vested for two years, 40% for three years, 60% for four years, 80% for five years, and 100% for 6 or more years of service. Participants may also become 100% vested due to death, disability or reaching early retirement age 55 after 6 years or normal retirement age.

Investment Options--Upon enrollment in the Plan, a participant may direct contributions to various investment options available as set forth in the Plan. Participants may change their investment options at any time during the year.

Payment of Benefits--A participant who has become entitled to receive payment of benefits whether retired, disabled, death or terminated may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or receive monthly payments upon the purchase of a life annuity.

Notes Receivable from Participants--A participant may borrow a portion of such participant's vested accrued benefit under the Plan. Participants may borrow a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must bear a reasonable interest rate and be repaid over a reasonable period of time not to exceed five years, except when the loan is secured by a home mortgage. Principal and interest are paid ratably through semi-monthly or bi-weekly payroll deductions.

Forfeitures--Forfeitures from nonvested accounts are used to reduce employer contributions. For the years ended December 31, 2024 and 2023, \$66,394 and \$44,000, respectively, was utilized to reduce the employer contributions. There were no forfeitures remaining as of December 31, 2024 and 2023.

#### Note B--Summary of Accounting Policies

The Plan follows accounting principles generally accepted in the United States of America ("GAAP") as outlined in the Financial Accounting Standards Board ("FASB") *Accounting Standards Codification*. Significant accounting policies are as follows:

Basis of Accounting--The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition--The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants--Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits--Benefits are recorded when paid.

Administrative Expenses--Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participants' accounts.

Estimates--The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of asset and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Date of Management's Review--Subsequent events were evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

#### Note C--Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including the fair value of investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company.

#### Note D--Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted market prices for identical assets (Level 1) and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

##### *Level 1 Fair Value Measurements*

The fair values of the money market funds are based on quoted market prices in active markets, and this is considered Level 1 of the fair value tiers. The fair values of money market funds are based on the closing price reported on the active market where the individual securities are traded.

The fair values of common stock are based on quoted market prices in active markets, and this is considered Level 1 of the fair value tiers. The common stock held by the Plan were purchased through the Plan's self-directed brokerage account option. The fair values of common stock are based on the closing price reported on the active market where the individual securities are traded.

The fair values of mutual funds are based on quoted net asset values of the shares held by the Plan at year end, and this is considered in Level 1 of the fair value tiers. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of mutual funds are based on the closing price reported on the active market where the individual securities are traded.

#### **Note E--Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan and discontinue its contributions at any time subject to the provisions of ERISA. Upon termination of the Plan, participants become 100% vested in their account balances.

#### **Note F--Tax Status**

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the non-standardized pre-approved profit sharing plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the Plan Administrator believes that the adopted non-standardized pre-approved profit sharing plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note G--Related Party Transactions**

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the services amounted to \$15,525 for the year ended December 31, 2023. Fees paid by the Plan for services net of any revenue sharing returns amounted to -\$16,835 for the year ended December 31, 2024.

The Plan also holds notes receivable from participants, which also qualify as party-in-interest.

#### Note I--Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

#### Note J--Employer Contributions Receivable

On March 28, 2024, the Plan Sponsor paid a cash gift to employees that was unique and non-recurring in nature. Due to the nature of the gift, it was misinterpreted to be excluded from the Plan's definition of compensation. As a result, participants were not provided with the opportunity to defer withholdings to the Plan, and the gift was not considered in the calculation of employer match at year end. Management has reviewed the Plan Document and recorded a receivable from the sponsoring employer to make the participant account balances whole. As of December 31, 2024, the Plan has recognized a receivable in the amount of \$1,779,864, representing the qualified non-elective contribution due to account for the missed employee deferrals, the matching contributions due from the employer for the gift paid to eligible participants during the plan year, and estimated lost earnings.

Management believes that the employer has a formal commitment to fund these contributions, based on the Plan's established compensation definition, and the employer is intent to remit the contributions in accordance with applicable regulations. The collectability of the receivable has been evaluated, and no allowance has been recorded.
