## INDEPENDENT AUDITOR'S REPORT

To the Trustee of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of RPS/RPH Employee Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RPS/RPH Employee Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of RPS/RPH Employee Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. #### NOTE 1-DESCRIPTION OF PLAN

The following description of the RPS/RPH (Company) Employee Savings Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Effective December 31, 1994, Real Property Services Corp. Employee Savings Plan was merged with the Real Property Health Facilities Corp. Employee 401(k) Plan into the RPS/RPH Employee Savings Plan. Participants should refer to the Amended and Restated Plan document for a complete description of the merged plan's provisions.

- A. General. The Plan is a defined contribution plan covering all full-time and part-time employees of affiliated employers of the Company who have completed at least 6 months of service. The Plan was adopted with an effective date of September 1, 1991 and was amended and restated in its entirety on September 30, 2003 in order to comply with the requirements of the Employee Retirement Income Security Act of 1974, and the Internal Revenue Code of 1986, as amended by the Uruguay Round Agreements Act, the Small Business Job Protection Act of 1996, the Tax Payer Relief Act of 1997, the Uniformed Services Employment and Reemployment Rights Act of 1994, the Internal Revenue Service Restructuring and Reform Act of 1998, the Community Renewal Tax Relief Act of 2000, and all applicable rulings and regulations issued thereunder. Effective September 16, 2013, the Plan treats same-sex spouses as spouses for plan purposes, including beneficiary and benefits. Effective January 1, 2015, the Plan was restated to bring the Plan into compliance with the Pension Protection Act of 2006 and other legislative and regulatory changes. Effective November 12, 2018, the Plan was amended to elaborate on specific terms of the Plan and, effective January 1, 2019, to allow for employer safe harbor contributions. Effective April 18, 2024, the Plan's Recordkeeper was changed from Newport Trust Company, LLC to Ascensus, LLC with Newport Trust Company, LLC remaining as the Trustee.
- B. Contributions. Employees may elect to contribute pre-tax or after-tax (Roth) dollars to the Plan, through payroll deductions, any amount of eligible compensation up to \$23,000 and \$22,500 for 2024 and 2023, respectively. Contributions are accepted as either a percentage or a flat dollar amount with no minimum. Participants who reach age 50 during the calendar year may be eligible to make catch-up contributions up to \$7,500 and \$7,500 for 2024 and 2023 in addition to the IRS limit of \$23,000 and \$22,500 for 2024 and 2023, all respectively. Participants can also elect a direct rollover of an existing balance from a tax-qualified retirement or savings plan into the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company will make a Safe Harbor contribution to the participant's account in an amount equal to 100% of their salary deferrals that do not exceed 3% of their compensation plus 50% of their deferrals between 3% and 5% of compensation. The Company may also make non-elective or discretionary contributions to the Plan as determined annually. These contributions are credited to participants' accounts in the first quarter of the year following the end of the fiscal plan year. At December 31, 2024 and 2023, the Company's contribution receivable totaled \$205,093 and \$202,820, respectively.

- C. Participant Accounts. Each participant's account is credited with the participant's contribution and allocation of the Company's Safe Harbor contribution, applicable discretionary contributions, and Plan earnings. Company contributions are invested in the investment options in the same allocation percentages as each participant's contributions. The Company contribution is to follow the investment directions of the employee account, but all employees have the option of changing that for both existing and new contributions, just as they have the choice of separately directing new and existing employee contributions. The benefit for a participant is the benefit that can be provided from the participant's vested account.
- D. Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account or \$50,000 as defined in the Plan document. The loans are collateralized by the balance in the participant's account, have maturity dates ranging from June 3, 2025 to October 15, 2029, and bear interest at the prime rate at the time the loan is made plus 2%. Principal and interest is paid ratably through semi-monthly after-tax payroll deductions. All principal and interest payments are allocated to the Plan's investment funds based on the participant's investment elections at the time of payment. Loans which are granted and repaid in compliance with the Plan provisions will not be considered distributions to the participant for tax purposes. During the year ended December 31, 2024, loans deemed as distributions totaled \$3,447. There were 20 and 18 loans outstanding at December 31, 2024 and 2023 totaling \$164,528 and \$173,119, all respectively.
- E. Vesting. Participants are immediately vested in their elective deferral contributions and Safe Harbor contributions and the actual earnings thereon. Vesting in the employer discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after four years of credited service.

- F. Payment of Benefits. On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may request a withdrawal of all or a portion of their elective contribution account balance if they can demonstrate financial hardship as defined by the Plan. Such amounts will be considered distributions to the participant for income tax purposes.
- G. Forfeitures. Forfeited funds are used to reduce employer contributions for the current Plan year. All forfeitures accumulated within the Plan are eliminated when the employer match contribution is made in the first quarter of the following year.

**NOTE 2-SIGNIFICANT ACCOUNTING POLICIES****Basis of accounting**

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Accounting principles generally accepted in the United States of America include Accounting Standards Codifications (ASC) or Accounting Standards Updates (ASU) issued by the Financial Accounting Standards Board (FASB) as further described.

**Investment valuation and income recognition**

A stable value fund's investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4. The Statements of Net Assets Available for Benefit present the fair value of the investment contracts. The Statement of Changes in Net Assets for Benefits is prepared on a contract value basis.

The Plan offers investments in various registered investment companies (mutual funds) or interest bearing investments (management accounts) maintained by Newport Trust Company, LLC, which are valued and reported at fair value. Fair value is the exchange price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. See Note 3. The Plan presents in the Statement of Changes in Net Assets Available for Benefits, the net appreciation (depreciation) in the fair value of its investments which consists of the related gains (losses) and the unrealized appreciation (depreciation) on those investments.

Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Realized gains and losses on investments are recognized upon the sale of the related investments and unrealized appreciation or depreciation is recognized at period end when the carrying values of the related investments are adjusted to their estimated fair market value. Purchase and sales of securities are reflected on a trade-date basis.

Earnings on investments are allocated on a pro rata basis to individual participant accounts based on the type of investment and the ratio of each participant's individual account balance to the aggregate of participant account balances.

**Notes receivable from participants**

Notes receivable from participants are stated at the outstanding principal balance of the loan, which approximates fair value. As of December 31, 2024 and 2023, the Plan does not have an allowance for credit losses, as repayments of principal and interest are generally received through payroll deductions and the notes are collateralized by the participants' account balances.

The Plan is subject to the Loans to Participants topic of the FASB issued ASU 2010-25, Reporting Loans to Participants by Defined Contribution Pension Plans (ASU 2010-25), which requires loans to participants in an entity's defined contribution plan be classified as notes receivable. These loans are to be reported separately from plan investments.

#### **Plan administration costs**

The Company absorbs Plan administration costs related to legal, accounting, record keeping, and general administration; however, the Company does not absorb 100% of these costs. The Company passes on the following Plan administration costs to participants: asset based fees, distribution fees, and loan fees.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Use of estimates**

The preparation of financial statements in conformity with accounting principles general accepted in to United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **Accounting for uncertainty in income taxes**

The Plan is subject to the Income Taxes topic of the FASB ASC 740, which provides guidance for how uncertain income tax positions should be recognized, measured, presented and disclosed in the financial statements. The Plan is required to evaluate the income tax positions taken or expected to be taken to determine whether the positions are more-likely-than-not to be sustained upon examination by the applicable tax authority. The Plan has determined that the application of the Income Taxes Standard does not impact the operations of the Plan and that no provision for income tax is required in the Plan's financial statements. There has been no interest or penalties recognized in the Plan's statements of net assets available for benefits as of December 31, 2024 and 2023 or its statement of changes in net assets available for benefits for the year ended December 31, 2024. Generally, federal and state returns are subject to examination for three years after the later of the original or extended due date or the date filed with the applicable tax authorities.

#### **Subsequent events**

The Plan Administrator performed an evaluation of the Plan's activity through October 8, 2025, the audit report date, and has concluded that there are no significant subsequent events that require disclosure through the date these financial statements were available to be issued.

### **NOTE 3-FAIR VALUE MEASUREMENTS**

Fair value is defined as the exchange price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Accounting guidance establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value.

The fair value hierarchy input levels are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following provides a description of the valuation methodology used for assets measured at fair value. There have been no changes in valuation methodologies at December 31, 2024, compared to December 31, 2023. The Company's policy for determining the timing of significant transfers between levels is at the end of the reporting period, if applicable. There were no transfers between level 1, 2 or 3 assets or liabilities during the year ended December 31, 2024.

Mutual funds - These investments are public investment securities valued using the Net Asset Value (NAV) provided by Newport Trust Company, LLC. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, if applicable, and then divided by the number of shares outstanding. The NAV is quoted in an active market. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4-COMMON / COLLECTIVE TRUSTS

The Plan offers a stable value fund, the Standard's Stable Asset Fund II (the Fund), that seeks to preserve a participant's principal investment while earning a level of interest income that is consistent with principal preservation. The Fund seeks to maintain a stable net asset value, but it cannot guarantee that it will be able to do so. The yield of the Fund will fluctuate.

The Fund invests in benefit-responsive investment contracts issued by insurance companies and other financial institutions (Contracts), fixed income securities, mortgage loans, and money market funds. Under the terms of the Contracts, the assets of the Fund are invested in fixed income and shares of money market funds. The Fund may also invest in futures contracts, option contracts, and swap agreements. Contract value, as reported by the Fund, is the beginning balance plus any deposit and credited interest, less any withdrawals, charges or expenses at measurement that approximates fair value. Participants may ordinarily direct or withdraw or transfer all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the Fund or otherwise.

The fair value of the Fund at December 31, 2024 and 2023 was \$92,171 and \$110,797, respectively. Fair value was obtained directly from Newport Trust Company, LLC at December 31, 2024 and 2023 as a practical expedient for fair value.

#### NOTE 5-PARTY-IN-INTEREST TRANSACTIONS

Newport Trust Company, LLC is the Trustee, as defined by the Plan, and therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan are incorporated in the return for the various mutual funds. The funds pay Newport Trust Company, LLC a fee for its services, which include any fee Newport Trust Company, LLC pays to the sub-advisors. There were no additional fees paid outside of the funds. Total fees incurred by the Plan to Newport Trust Company, LLC and affiliates amounted to \$44,105 for the year ended December 31, 2024. These fees are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

The Company President and Chief Executive Officer, Chief Financial Officer, and Risk Manager are currently participants in the Plan and serve as the trustees. The Risk Manager serves as the Plan Administrator of the Plan.

Notes receivable from participants are permitted party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### NOTE 6-PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

#### NOTE 7-INFORMATION PREPARED AND CERTIFIED BY PLAN TRUSTEE

Certain information related to investments from participants disclosed in the accompanying financial statements and supplemental schedules, including investments from participants held at December 31, 2024 and 2023, and net appreciation(depreciation) in fair value of investments and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Newport Trust Company, LLC. #### NOTE 8-TAX STATUS

The Plan qualifies as a cash or deferred arrangement under Section 401(k) of the Internal Revenue Code (Code), and therefore, is exempt from federal income taxes under Section 501(a) of the Code. A favorable tax determination letter dated in January of 2020 has been obtained from the Internal Revenue Service. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Company believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code, and therefore, believe the Plan is qualified as tax-exempt.

Under a plan qualified pursuant to Section 401(k) of the Code, participants generally will not be taxed on contributions or matching contributions, or earning thereon, until such amounts are distributed to participants or their beneficiaries under the Plan. The tax-deferred contributions and matching contributions are deductible by the Company for tax purposes when those contributions are made, subject to certain limitations set forth in Section 404 of the Code.

Participants or their beneficiaries will be taxed, at ordinary income tax rates, on the amount they receive as a distribution from the Plan at the time they receive the distribution. However, if the participant or beneficiary receives a lump sum payment of the balance under the Plan in a single taxable year, and the distribution is made by reason of death, disability, or termination of employment of the participant, or after the participant has attained age 59 1/2, then certain special tax rules may be applicable.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other taxing authorities.

The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in process. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### **NOTE 9-RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across 28 participant directed fund elections and a common /collective trust fund. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
