## **INDEPENDENT AUDITOR'S REPORT**

To the Board of Trustees  
Milwaukee Painters Local Union No. 781 Health Fund

### **Opinion**

We have audited the accompanying financial statements of Milwaukee Painters Local Union No. 781 Health Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Supplemental Schedules

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The schedule of assets (held at end of year) as of December 31, 2024 and schedule of reportable transactions for the year ended December 31, 2024, are presented for the purpose of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The schedules of administrative expenses for the years ended December 31, 2024 and 2023 are provided for informational purposes only. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedule of assets (held at end of year) and schedule of reportable transactions, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content of the supplemental schedule of assets (held at end of year) and schedule of reportable transactions are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Milwaukee Painters Local Union No. 781 Health Fund (the Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor. The Plan covers workers in the painting and the finishing trade of glazing, covering Southeastern Wisconsin.

#### General

The Plan was formed in 1951 by and between the Local Unions #781, #1204, and #934 of the International Brotherhood of Painters and Allied Trades AFL-CIO (the Unions) and the Wisconsin Painting Contractors Association (the Association) to provide health and other benefits to eligible members and covered dependents. Retirees are entitled to benefits if they have attained the required eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by a Board of Trustees (the Trustees) consisting of a union group and employer group of representatives, each having equal voting power.

#### Administration

The Trustees have overall responsibility for the operation and administration of the Plan. The Trustees have engaged the services of BeneSys as the third-party administrator (TPA) to handle the daily administration of the Plan.

#### Contributions

The Plan is financed by employer contributions based on hourly rates established in the collective bargaining agreements in effect between the unions and participating employers. The contribution rate was \$10.34 per hour through May 2023, then increased to \$10.40 per hour through May 2024, and then increased to \$10.50 per hour effective June 1, 2024. In addition to deductibles and copayments, retiree contributions ranged between \$81 and \$1,625 depending on the type of coverage. For the years ended December 31, 2024 and 2023, the retiree contributions are an estimated 95% and 101%, respectively, of the projected cost of providing their postretirement benefits.

Employer and participants' contributions are received from employers and participants for the operation of the Plan. Employer contributions are recognized in the period that coincides with the completion of the related work hours. Participant contributions are recognized in the period of benefit coverage.

**1. DESCRIPTION OF THE PLAN (Continued)**

Eligibility

Employees and their dependents are eligible to participate in the Standard Plan of Benefits on the first day of the third month after they are credited with at least 130 hours of employer contributions for work performed in three consecutive months. For example, if one met the initial eligibility requirement of 130 hours in January, their coverage would be effective the first day of April. Hours worked by apprentices are recognized for eligibility purposes from the beginning date of employment, although employer contributions may not be required during the probationary period. Once initial eligibility is established, the participant must stay on the Standard Plan until the next open enrollment period. The Plan has open enrollment each fall during which a participant must choose the health care plan for the following calendar year.

The participant may choose from: The Premier Plan which has the lowest deductibles and out-of-pocket costs and has a minimum work requirement of 150 hours per month; the Standard Plan which has higher deductibles and out-of-pocket costs and has a work requirement of 130 hours per month; or the Basic plan which has very high deductibles and out-of-pocket costs with a work requirement of 120 hours per month. Employer contributions for hours worked in excess of the monthly Plan requirement are credited to the participant's Health Reimbursement Arrangement (HRA). There is a three-month lag period to apply to the eligibility month, so that a participant's hours worked in a work month will be used to continue eligibility in the third month following that work month. If the participant's hours fall short of the Plan requirement, then they can continue coverage by using their HRA account (if sufficient funds) or they can make a self-payment.

Benefits

The Plan provides health benefits (medical, vision, dental, and prescription drugs), life insurance, short and long-term disability benefits, and accidental death and dismemberment benefits. There are three classes of participants to determine eligibility for benefits: Class A - active eligible employees neither permanently and totally disabled nor retired and their eligible dependents. Class B - former employees who are permanently and totally disabled, not eligible for Medicare and retired employees not eligible for Medicare who continue eligibility under applicable provisions of the eligibility rules and their dependents who are not eligible for Medicare and spouses not eligible for the AARP Program. Class C - former employees who are eligible for Medicare, and who continue eligibility under applicable provisions of the eligibility rules and their dependents eligible for Medicare.

Insured Benefits

The Plan fully insures its dental and organ transplant benefits. The Plan purchases annual insurance contracts for these benefits. Premiums for these benefits are paid to the insurance companies from the assets of the Plan.

**1. DESCRIPTION OF THE PLAN (Continued)**

Self-Insured Benefits

All other benefits are self-insured. The claims for self-insured benefits are processed by the TPA or by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan. Ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan uses a pharmacy benefit manager (PBM), which periodically makes refunds to the Plan based on the Plan's utilization pattern of specific drugs.

Stop Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured medical benefits. Under this policy, the Plan will be reimbursed for claims paid in excess of \$400,000 per individual per policy year.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, estimated health claims incurred but not reported (IBNR), postretirement benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates. Estimates that are particularly susceptible to significant change in the near-term are the liabilities for IBNR and the postretirement benefit obligations. Although it is not possible to measure the degree of variability inherent in these estimates, management believes that the liabilities reported are adequate. Any adjustment determined to be necessary is reflected in current operations.

Cash

Cash is defined as currency on hand, in demand deposits.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Concentrations

Credit Risk - The Plan maintains its cash balance in financial institutions, which at times may exceed federally insured limits. As of December 31, 2024 and 2023, the Plan had \$-0- and \$2,559,341, respectively, deposited in excess of the Federal Deposit Insurance Corporation insurance limits. The Plan has not experienced any losses in such accounts and believes it is not exposed to any significant credit risks on cash.

Employer Contributions – Employers remit contributions to the Plan based on the number of hours worked by the members. Therefore, employer contributions are dependent upon the construction and working environment of the area serviced by the Unions and the Association. Two employers accounted for approximately 23% and 22% of contributions for the years ended December 31, 2024 and 2023, respectively.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies and procedures utilizing information provided by the investment custodian. See Note 5 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Stop-Loss Insurance

Premiums for stop-loss insurance are included as benefit program costs in the accompanying statements of changes in net assets available for benefits. Stop loss refunds are netted with the health and welfare claims when earned. There were no stop loss refunds received for the years ended December 31, 2024 and 2023.

Payment of Benefits

Premiums paid are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when paid by the Plan and the third-party claims processors. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as benefit program costs payable in the accompanying statements of net assets available for benefits. Claim payments are recorded as health and welfare claims in the accompanying statements of changes in net assets available for benefits.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Rebates and Refunds

Rebates due from the Plan's PBM are recorded when known and earned, with the offset against health and welfare claims. Pharmacy rebates totaling \$218,336 and \$150,891 have been netted with health and welfare claims in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Subrogation and medical refunds are recorded when received. These refunds totaled \$109,125 and \$140,294 for the years ended December 31, 2024 and 2023, respectively, and are netted with health and welfare claims in the accompanying statements of changes in net assets available for benefits.

Accumulated Eligibility Credits

The Plan has a Member Dollar Bank (MDB, Dollar Bank or HRA account), whereas if a participant works more hours than are needed to pay for their Plan, the extra hours times the contribution rate will be deposited in the participants "account." If a participant works less than those hours in a month, the money will be taken out of their account before a self-payment is required, but they maintain eligibility rules such that initial and continuing eligibility as earned through hours worked. The Dollar Bank arrangement can be accessed with a HRA debit card (a WEX debit card). The debit card can be used to pay for eligible healthcare expenses as defined under the Internal Revenue Service (IRS) Code Sections 105 and 213(d) provided there are sufficient funds available in their account.

The accumulated eligibility credits as of December 31, 2024 and 2023 are classified into four categories: Eligibility Earned, HRA, Active Dollar Banks and Retiree Dollar Banks. Eligibility Earned is equal to the cost of providing benefits to active members who worked sufficient hours in the final three months of the year to receive coverage in the first three months of the upcoming fiscal year. Active Dollar Banks are representative of unspent balances remaining in each active member's account as of the fiscal year end and the Retiree Dollar Banks are the retired participants' unspent account balances. The active dollar bank of a participant who goes to work for a non-signatory contractor is forfeited and returns to the trust after six months if they do not return to covered work.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Postretirement Benefit Obligations

Postretirement benefits have been recognized for future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. These benefit obligations represent the actuarial present value of the cost of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from employers and current Plan participants. The obligations represent the amounts that are to be funded by contributions from the Plan's participating employers, retirees, and from existing Plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligations are the portions of the expected postretirement obligations that are attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligations is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, medical and prescription drug cost trend rates were 8.00% and gradually decreasing to 4.50% in 2035 and remain at that level thereafter, for December 31, 2024, and 7.75% gradually decreasing to 4.50% in 2035 and remain at that level thereafter, for December 31, 2023. Vision trend rates and administrative expense increases were 3% for all years for December 31, 2024 and 2023.

The following were other significant actuarial assumptions used to determine the postretirement benefit obligations as of December 31, 2024 and 2023:

The forgoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

Claims Incurred but not Reported

Benefit obligations other than postretirement benefit obligations include health claims currently payable and health claims incurred but not yet reported. Claims paid by the claims processor prior to the year-end that are not reimbursed by the Plan as of year-end are recorded as claims payable and included in claims payable and claims incurred but not reported in the Plan's benefit obligations. See Note 3.

Claims incurred but not yet reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the plan administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

The postretirement benefit obligations are not vested and can be modified or eliminated by action of the Trustees in accordance with terms of the governing documents. The Trustees are responsible for developing and implementing the funding policy.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts as postretirement benefit obligations. If the assumed rates increased by one percentage point in each year, it would increase the obligations as of December 31, 2024 and 2023 by \$261,213 and \$95,401, respectively. These calculations do not include the retiree prescription drug plan federal subsidies. The Plan is not eligible to receive the subsidies since the Plan is not actuarial equivalent to the Medicare Part D Standard Benefits.

**4. CHANGES IN PLAN'S BENEFIT OBLIGATIONS (Continued)**

The valuation assumption changes increased obligations by \$1,832,126 as of December 31, 2024. This was the result of updating the valuation year per capita health costs, partially offset by updating the trend rates on per capita health costs and retiree contribution rates. More detail is provided in the December 31, 2024 Valuation Report prepared by Segal and dated August 11, 2025.

The valuation assumption changes increased obligations by \$20,930 as of December 31, 2023. This was a net result of reducing the percentage of future participants assumed to elect coverage from 75% to 35%, reducing the assumed portion of future disabled members eligible for Medicare from 50% to 0%, increasing the percentage of future retirees assumed to have an eligible spouse who opts for health coverage at that time from 60% to 70%, updating the trend rates on per capita health costs, and increasing the discount rate from 4.75% to 5.25%. More detail is provided in the December 31, 2023 Valuation Report prepared by Segal and dated September 3, 2024.

**5. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2: Inputs to the valuation methodology other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets,
- Quoted prices for identical or similar assets or liabilities in inactive markets,
- Inputs other than quoted prices that are observable for the asset or liability,
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**5. FAIR VALUE MEASUREMENTS (Continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Cash equivalent:* Valued at the deposit account balances, payable on demand.

*Mutual funds and money market mutual fund:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the US Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds and money market mutual fund held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. TAX STATUS**

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC). The Plan has obtained a favorable tax determination letter dated August 11, 1997 from the IRS and is therefore not subject to tax under present income tax laws. The plan sponsor believes that the Plan and trust, as amended, continue to qualify and to operate in accordance with applicable provisions of the IRC.

US GAAP require plan management of an organization to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. PLAN TERMINATION**

Although they have not expressed any intention to do so, the Trustees have the right under the plan document to modify the benefits provided to participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, the remaining assets shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to participants in the order of their entitlement.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

**10. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 15, 2025, which was the date that these financial statements were available for issuance and determined that there were no significant nonrecognized subsequent events through that date.
