The following description of the CBT 401(k) and Profit Sharing Plan, (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document.

General

The Plan is a defined contribution plan covering eligible employees of CBT/Childs Bertman Tseckares Inc. (the “Employer”) who have attained the age of 21 (“Participants”). Employees who are covered by a collective bargaining agreement, leased employees, interns, co-op students, and nonresident aliens who do not receive any United States sourced income are not eligible to participate in the Plan. There is no service requirement for eligibility. Employees may enter the Plan on the day coinciding with or immediately following the date on which they meet the eligibility requirements. Fidelity Management Trust Company (“FMTC”) provides asset custodian services and also serves as Trustee for the Plan. Fidelity Workplace Services, LLC, an affiliate of FMTC, provides recordkeeping services for the Plan. Certain employees at the Employer also serve as the trustees for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are participant-directed.

Participant Deferral Contributions

Participant deferral contributions to the Plan are deferrals of the employee’s compensation. Each year, Participants may elect to defer up to 90% of eligible compensation, as defined by the Plan, not to exceed a dollar limit established under the Internal Revenue Code (the “IRC”). Participants may make pre-tax and Roth contributions to their accounts. Participants who have attained age 50 by the end of the plan year are eligible to make catch-up contributions. Participants may contribute amounts representing distributions from other qualified plans (“Participant Rollovers”).

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation on a pre-tax basis and their contributions are invested in the applicable target date fund based on the employee’s birth date. The automatic pre-tax deferral election and the default investment option remain in effect until the Participant changes them.

Non-Elective Employer Contributions

Non-elective employer contributions are made at the discretion of the Employer’s Board of Trustees, subject to certain Internal Revenue Service (“IRS”) limitations. To be eligible for the non-elective employer contribution, Participants must be employed by the Employer on the last day of the Plan year and have completed a year of service, defined as 1,000 hours during the Plan year, unless their employment terminated due to death, disability, or retirement. Employer contributions are allocated to employee groups as determined by the Employer. Participants within each allocation group are allocated a contribution based on the ratio that each Participant’s compensation bears to the total compensation of all Participants within their applicable group, as defined by the Plan. The Employer elected to make a non-elective employer contribution of \$100,000 for the year ended December 31, 2024.

1. Description of Plan (continued)

Participant Accounts

Each Participant's account is credited with the Participant's deferral contributions, the respective Employer contributions, if any, an allocation of Plan's investment earnings or losses, and is charged with an allocation of certain administrative expenses paid by the Plan. Allocations are based on Participant compensation, account balances, or specific Participant transactions, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

Vesting

Participants are vested immediately in their deferral contributions, rollover contributions and non-elective employer contributions plus allocated earnings thereon.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 and up to a maximum amount equal to the lesser of \$50,000 reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made or 50% of their vested account balance. Loan terms range from one to five years, or up to ten years if for the purchase of a primary residence. Loans are secured by the vested balance in the Participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. A Participant may only have one loan outstanding at a time. Notes receivable from Participants, with interest rates ranging from 8.75% to 9.50% at December 31, 2024 and 4.25% to 9.25% at December 31, 2023, mature at various dates through April 2033. Principal and interest are paid ratably through payroll deductions. If a Participant ceases to make loan repayments and the Plan administrator deems the loan to be in default, the Participant's loan balance is reduced and a benefit payment is made in accordance with the Plan document.

Payment of Benefits

Upon termination of service due to death, disability, retirement or termination of employment, a Participant may elect to receive a partial withdrawal or lump-sum distribution in an amount equal to the value of the Participant's vested interest in their account. The payment can either be a cash distribution subject to income tax withholdings or a tax free rollover to an individual retirement account ("IRA") or another qualified plan. If a Participant's vested account is more than \$1,000 but less than \$5,000, the Plan administrator, after notification, may distribute the benefit into an IRA on behalf of the Participant. If the vested account balance is less than \$1,000, the Plan administrator, after notification, may distribute the benefit to the Participant.

In-service withdrawals from a Participant's vested account balances are permitted upon reaching age 59½. In-service withdrawals are also permitted from a participant's deferral account balance due to financial hardship, as defined in the Plan document. Participants must have obtained all distributions, other than the hardship withdrawal, before financial hardship withdrawals are allowed. Hardship withdrawals are subject to a \$500 minimum.

1. Description of Plan (continued)

Expense Account

The Employer has a revenue sharing arrangement with FMTC that provides for an expense reimbursement to the Plan. These reimbursements are held in an ERISA expense account and are utilized to pay for certain Plan administrative expenses. During the year ended December 31, 2024, the Plan received \$3,497 of expense reimbursements, \$3,476 of which was allocated back to Participants and \$23,000 which was used to pay administrative expenses. At December 31, 2024 and 2023 unallocated amounts in the ERISA expense account totaled \$3,500 and \$26,479 respectively.

Plan Administration

The Employer is the Plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. Individual Participant accounts are charged directly for loan recordkeeping and benefit disbursement processing fees, if applicable. Individual Participant accounts may also be charged with an allocation of administrative expenses, if not paid by the Employer.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could vary from the estimates that were used.

Investment, Investment Valuation, and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of mutual funds includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

2. Summary of Significant Accounting Policies *(continued)*

Fair Value Measurements

The Plan follows GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Mutual funds: As of December 31, 2024 and 2023, mutual funds amounted to \$44,618,984 and \$41,971,107, respectively, and are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 investments.

Notes Receivable from Participants

Loans to Participants are reported as notes receivable from Participants at the unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from Participants is recognized on the accrual basis of accounting. Related fees are recorded as administrative expenses when incurred.

Payment of Benefits

Benefit payments to Participants are recorded during the period in which they are paid.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of mutual funds, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC, a qualified institution.

4. Risks and Uncertainties

The Plan invests in investment securities, which are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

5. Party-In-Interest Transactions

Plan investments include shares of mutual funds managed by Fidelity Investments, an affiliate of FMTC. The Plan also has a revenue sharing arrangement with FMTC (see Note 1). FMTC is the Trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Administrative expenses of \$32,029 were paid to FMTC or affiliates of FMTC and \$64,011 was paid to an investment advisor during the year ended December 31, 2024. Notes receivable from Participants also qualify as exempt party-in-interest transactions as defined by ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become fully vested in their accounts and any unallocated assets of the Plan shall be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

7. Tax Status

The underlying volume submitter profit sharing plan with a cash or deferred arrangement ("CODA") has received an opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the IRC, and that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the date of these financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of an entity is considered a tax position. No such uncertain tax positions have been recognized by the Plan as of December 31, 2024 or 2023.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
