### ***Basis for Opinion***

### Note 1 - Description of plan

#### General

Effective January 2018, Material in Motion, LLC (formerly Material in Motion, Inc.) (the "Company", "plan administrator", and "Plan Sponsor") adopted a defined contribution 401(k) plan (the "Plan") covering all eligible employees of the Company who are age 21 or older and have completed one year of service.

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Administration

The Company has appointed an Administrative Committee (the "Committee") to manage the operations and administration of the Plan. The Company has contracted with Automatic Data Processing, Inc. ("ADP") to adopt a non-standardized pre-approved 401(k) plan. ADP, as the third-party administrator, is responsible for processing Plan transactions, maintaining the records of participant data, and monitoring compliance with governmental regulatory requirements. The Company contracted with Reliance Trust Company ("Reliance Trust") to act as the Plan trustee and custodian for the years ended December 31, 2024 and 2023.

#### Contributions

Each year, participants may elect to defer up to 90% of their eligible compensation as defined in the Plan document. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds and a money market fund to its participants. The Company currently makes safe harbor matching contributions equal to 100% of elective deferrals up to 4% of eligible compensation. Such safe harbor matching contributions for the years ended December 31, 2024 and 2023 were \$397,337 and \$378,369, respectively. Contributions are subject to certain IRS limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions, safe harbor matching contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions, the employer safe harbor contributions, plus actual earnings thereon.

### **Note 1 - Description of plan (continued)**

#### **Payment of benefits**

Upon reaching the age of 59½ and at the discretion of the participant or upon termination of service due to death, disability, or retirement, a participant or the designated beneficiary may elect to receive a lump-sum, direct rollover or installments equal to the value of the participant's vested interest in his or her account.

Upon termination, if the participant's or beneficiary's vested account balance is \$7,000 or less, the Plan allows the trustee to distribute the vested account balance to an Individual Retirement Account ("IRA") for the participant's benefit. Vested balances of \$1,000 or less may be distributed as a lump-sum amount without the participant's consent.

### **Note 2 - Summary of accounting policies**

#### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### **Use of estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

#### **Investment valuation and income recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of benefits**

Benefits are recorded when paid.

### Note 2 - Summary of accounting policies (continued)

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Pursuant to a revenue sharing arrangement with ADP, the Plan's investment advisor receives asset-based fees calculated at 30 basis points of the invested assets. Amounts received under such revenue sharing arrangement by the investment advisor amounted to \$15,258 and \$10,255 during the years ended December 31, 2024 and 2023, respectively. Fees related to the administration of participant withdrawals are charged directly to the participant's account, are included in administrative expenses on the statements of changes in net assets available for benefits and amounted to \$6,065 and \$4,472 for the years ended December 31, 2024 and 2023, respectively. Total administrative expenses paid by the Plan for the years ended December 31, 2024 and 2023 were \$21,323 and \$14,727, respectively. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each investment fund and charged to participants' accounts.

#### Subsequent events

In preparing its financial statements, the Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified investments

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust, a qualified institution.

The Plan's investments in mutual funds (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$469,808 and \$551,703 during 2024 and 2023, respectively.

### Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's investments in money market and mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded. The money market funds held by the plan are valued at quoted prices in active exchanges.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

No assets were noted at Levels 2 and 3 for the years ended December 31, 2024 and 2023. There have been no changes in the methodologies used at December 31, 2024 and 2023.

### Note 5 - Rollover contributions

During 2024, the rollover contribution of \$17,381 from another plan was from one active participant. There were no rollover contributions in 2023.

### Note 6 - Related party transactions and party-in-interest transactions

The Plan Sponsor has contracted with ADP, a third-party administrator to process and maintain the records of participant data and monitor compliance with governmental regulatory requirements. The Plan Sponsor also contracted with Reliance Trust to maintain custody of certain Plan investments during 2024 and 2023 as well as an independent investment advisor to monitor investment performance. Expenses for the Plan were paid to these parties-in-interest by the Plan Sponsor as well as participants (see Note 2 - Expenses). All these transactions are considered party-in-interest transactions under ERISA regulations but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

### Note 7 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

### Note 8 - Tax status

The Internal Revenue Service has determined and informed ADP by letter dated October 6, 2020 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan's third-party administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date and through the date of issuance of the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position not likely to be sustained upon examination by taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

### Note 9 - Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks related to geopolitical tensions, economic instability, and changes in international trade policies, including the imposition of new tariffs, could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
