NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the HKS, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General: The Plan is a defined contribution plan whereby eligible employees of HKS, Inc. (the Company) are permitted to make pretax contributions that are tax-deferred under Section 401(k) of the Internal Revenue Code (IRC). The Plan also allows for participants to make elective contributions on an after-tax basis. The Plan is intended to satisfy the requirements for a qualified retirement plan under the appropriate provisions of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Full-time employees of the Company become eligible for participation upon attaining the age of 21 and having one hour of service.

Contributions: Participants may authorize the Company to make payroll deductions under the Plan in accordance with IRS regulations from their eligible compensation as defined by the Plan document. In addition, those participants, who are over the age of 50 or turning age 50 on or before December 31, 2024, are eligible for an additional catch-up contributions. The percentage contribution may be increased, decreased, revoked, or resumed at any time during the year. Such changes are effective as of the next pay period. Contributions made by participants are credited to their individual accounts and are made on a pretax basis assuming applicable regulations set forth in the IRC are satisfied.

The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their contribution rate set at 6% of their eligible compensation. On the anniversary of the participant's automatic enrollment, the contribution rate will increase by 1% until a maximum of 12% is reached unless the participant elects otherwise.

The Plan allows the Company to make discretionary matching contributions and profit-sharing contributions in an amount determined by the Company at its discretion. Full-time employees are eligible to receive matching contributions upon reaching 1,000 hours of service and must be employed by the Company on the last day of the Plan year. For the year ended December 31, 2024, the Company contributed a matching contribution equal to 50% of the participant's elective deferral up to 6% of eligible compensation. No profit sharing contributions were made for the year ended December 31, 2024.

Vesting: Participants are immediately vested in their contributions plus actual earnings or losses thereon. Vesting in employer contributions plus actual earnings or losses thereon is based on years of service. Participants vest 25% per year after one year of service and are 100% vested after four years of service. One year of service is credited to a participant upon completion of 1,000 hours of service during the Plan year, as defined in the Plan document.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Participant Accounts: Under the Plan, each participant's account is credited with the participant's contribution, the Company's contribution, if any, and any allocation of investment income, and is charged with his or her withdrawals and an allocation of administrative expenses. Investment income is allocated daily to participants. The benefit to which a participant is entitled is provided from the participant's vested account. All employer and participant contributions are invested under the direction of the participant. The Plan also allows participants to alter their elections among funds on a daily basis.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Forfeitures: Forfeited, non-vested accounts are retained in the Plan and may be used to first pay administrative expenses of the Plan and then to reduce the Company's matching contribution to the Plan. For the year ended December 31, 2024, \$309,446 of unvested balances from terminated participants were added to the Plan's forfeiture account, and \$528,461 of forfeited employer contributions was used to offset employer contributions and plan expenses. The remaining balances of forfeitures available to offset future employer contributions and administrative expenses as of December 31, 2024 and 2023, were \$549,756 and \$768,771, respectively.

Payment of Benefits: Upon termination of service, a participant's account balance will be either paid in a lump-sum, partial lump-sum, or paid in periodic installments over a period not to exceed the participant's life expectancy. If a participant's vested balance is \$5,000 or less, the participant will receive a single distribution of their entire vested account balance. The Plan provides for the automatic cash out of vested participant balances less than \$1,000. The Plan provides for the automatic rollover of vested participant balances above \$1,000, but less than \$5,000 into an individual retirement account if the participant does not elect to have the distribution paid directly to an eligible retirement plan in a direct rollover or to receive the distributions directly. Participants may elect to defer the payment of benefits until the participant attains the age of 72 (73 if you reach age 72 after December 31, 2022). Participants may choose to receive in-service withdrawals after age 59 ½. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan.

Notes Receivable from Participants: Participants may request a note from the Plan in an amount not to exceed the lesser of (1) 50% of their vested account balance, or (2) \$50,000. The notes are secured by the balance in the participant's account and bear interest at a rate determined by the plan administrator. The interest rate is fixed for the life of the note. For notes receivable outstanding at December 31, 2024, interest rates range from 4.25% to 9.50% with maturities through November 2033. Note defaults for terminated employees are reported as deemed distributions within benefits paid to participants in the statement of changes in net assets available for benefits (modified cash basis).

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and other certain administrative fees are paid by the Plan. Certain Plan expenses, such as transaction fees from receiving a note, withdrawal, or distribution from the Plan, are deducted from individual participants' accounts and are included in administrative expenses in the statement of changes in net assets available for benefits (modified cash basis).

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Contributions and distributions are recorded on a cash basis. Investments are recorded at fair value.

Estimates: The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023 as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. If a participant ceases to make note payments and the Plan Administrator deems the participant note to be in default, the participant note receivable balance is reduced and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements (modified cash basis) and ERISA-required supplemental schedule (modified cash basis), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trust provides for daily redemptions by the Plan participants at reported net asset value per share. However, if the Plan was to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary to the Plan or party rendering services to the Plan, the employer, and certain others. Certain Plan investments are issued by an affiliate of the trustee, and therefore these transactions and the Plan's payment of trustee fees, record keeping fees, and investment management fees to the trustee qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 - TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Vanguard Fiduciary Trust Company. The prototype plan has received an opinion letter, dated June 30, 2020, from the Internal Revenue Service as to the prototype plan's qualified status. Although the Plan has been amended from the original prototype document, plan management believes the Plan is currently operating in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan holds various investments which are exposed to various risks, such as interest rate, market, liquidity, credit risks, and global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (modified cash basis).

NOTE 8 - PLAN TERMINATION

While there is no intention to do so, the Company reserves the right to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, the participants become fully vested in their employer contribution balances, and the net assets of the Plan will be distributed to the participants of the Plan in accordance with the provisions of ERISA.

NOTE 9 - SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 15, 2025, the date the financial statements were available to be issued. There are no significant events subsequent to December 31, 2024 that require disclosure.
