Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Creative World of Child Care Inc. 401K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Under the modified cash basis of accounting, certain additions are recognized when received and certain deductions are recognized when paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Purchases and sales of investments are recorded on a trade date basis. Net appreciation in fair value of investments includes realized gains and losses on investments sold during the year as well as net appreciation(depreciation) of the investments held at the end of the year.

Financial Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Administrative fees

The Plan and Plan Sponsor share in the payment of the administrative expenses of the Plan. Substantially all of the fees paid by the Plan are investment advising fees and plan administration fees.

Benefit Payments

Benefits are recorded when paid to participants.

2. DESCRIPTION OF PLAN

The following brief description of the Creative World of Child Care Inc. 401K Plan (the "Plan") is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted by the stockholder of CWCC, Inc., (the "Company") on January 1, 2007. To be eligible to participate in the plan, an employee must complete a year of eligibility service. A year of eligibility service is accomplished after completing 1,000 hours of service during the first 12 months of employment, or any calendar year thereafter.

A participant may make contributions by entering into a salary reduction agreement with the Company whereby the participant authorizes the Company to reduce their earnings by such percent, as they shall specify, subject to the Plan specified limits.

2. DESCRIPTION OF PLAN(Continued)

The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), except for Title IV. The provisions of ERISA to which the Plan is subject relates, among other things, to reporting and disclosure requirements, participation and vesting standards, fiduciary responsibility and enforcement of rights. Title IV of ERISA, which does not apply to the Plan, provides for insuring of benefits upon plan termination. Insurance benefits of the type specified in Title IV of ERISA will not be extended to participants or their beneficiaries by the Company or any other person or entity.

Contributions

Employee: Participants may elect to contribute a portion of their compensation, up to the maximum permitted by the Internal Revenue Code, to the plan. Participants are 100% vested in their contributions, and they designate if the contribution is a traditional 401(k), Roth or catch-up contribution. Participants also designate how their contributions are to be invested in the funds that are offered by the Plan. Contributions are funded to the Plan as soon as administratively possible after each payroll.

Employer: The Company makes Safe Harbor Contributions equal to 100% of the first 3% of eligible earnings that employees defer as an elective deferral and an additional 50% on the next 2% of employees' eligible earnings that are deferred as an elective deferral. All eligible employees are immediately 100% vested in the Company match.

The Company may decide to make Nonelective Contributions to the Plan. The non-elective contribution will be allocated to all employees eligible to participate in the Plan. Nonelective contributions are allocated in proportion to the participant's eligible earnings to the eligible earnings of all other employees who share in the contributions. Participants vest in non-elective contributions at the rate of 20% per year after two years of service. Participants are 100% vested after six years.

Benefits Payments

Upon termination of service due to death, disability, or retirement a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59 ½ and hardship distributions subject to plan provisions.

Participant Accounts

Reliance Trust Company is the custodian of the Plan's investments. Participant accounts are funded through participant contributions, the Company's matching contributions, net earnings and losses, and distributions and withdrawals. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances. The benefit to which a participant is entitled is the benefit that can be provided by the participants vested balance.

Forfeitures

Forfeitures of employer contributions are to be used to reduce matching contributions or to pay for reasonable plan expenses. Plan forfeiture balances were \$10 and \$11 as of December 31, 2024 and 2023, respectively. \$681 and \$0 were used to pay for employer matching contributions during 2024 and 2023, respectively.

3. INVESTMENTS

Fair Value Measurement

The investments were held by Reliance Trust Company, and are administered by ADP Retirement Systems. The investments are not federally insured. The schedule on page 12 shows the detail of the investments held by the Plan at December 31, 2024.

The Fair Value Measurement and Disclosure Topic of FASB ASC establishes a fair value hierarchy that prioritizes the inputs used to measure the fair value of assets into three levels of input and expands disclosures regarding the fair value measurements. The FASB ASC Topic defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The disclosures that follow do not relate to what is known as investment risk, such as the risk of a permanent decline in the fair value of an investment, or an investment's custodial risk. The levels of input described below relate solely to the process of determining the fair value of each of the investments held by the Plan. The three levels of input are as follows:

- Level 1 Inputs are unadjusted quoted prices in active markets for identical assets, and the Plan has the ability to access that information on December 31, 2024 and 2023.
- Level 2 Inputs are other than Level 1 quoted prices that are observable either directly or indirectly.
- Level 3 Valuations based on unobservable inputs such as when observable inputs are not available or inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Level 1 Investments

The reported fair values of the Plan's investment in mutual funds shown below are based on quoted active market prices.

4. TAX STATUS

The plan adopted a non-standardized pre-approved 401(k) Plan which received a favorable opinion letter from the Internal Revenue Service dated October 6, 2020. This letter stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. BENEFITS ALLOCABLE TO WITHDRAWN PARTICIPANTS

At December 31, 2024 and 2023, there was \$0 due to participants who had withdrawn from the Plan and requested benefit payments prior to year end.

6. PARTICIPANT – DIRECTED INVESTMENTS

The Plan's investments are 100% participant directed and appreciated in value in 2024 by \$364,454.

7. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at anytime and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer's contributions to their accounts.

8. INFORMATION CERTIFIED BY PLAN CUSTODIAN

The Plan Administrator has elected the method of compliance permitted by an ERISA Section 103(a)(3)(C) audit. Accordingly, Reliance Trust Company has been contracted as the custodian of the plan and certified the completeness and accuracy of the following:

- Investments reflected on the accompanying statement of net assets available for benefits(modified cash basis) as of December 31, 2024 and 2023.
- The Related Investment Activity reflected on the accompanying statement of changes in net assets available for benefits(modified cash basis) for the year ended December 31, 2024.
- Investments reflected on the schedule of assets(held at end of year) as of December 31, 2024.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. PARTY-IN-INTEREST TRANSACTIONS

Fees paid by the plan to Rightwealth advisors, LLC were \$6,932 for financial advising services for the year ended December 31, 2024. Fees paid by the plan to ADP, Inc. were \$845 for record keeping services for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

11. SUBSEQUENT EVENTS

Management has evaluated, for possible adjustment to or disclosure in the financial statements, events occurring after December 31, 2024, through the date of the independent auditors' report, which is the date on which the financial statements were available to be issued. On January 1, 2025, the Plan switched custodians from Reliance Trust Company to ADP Retirement Trust Services, LLC.
