1. Plan Description

The following description of the Bellomy Research 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan covering all full-time employees of the plan sponsor, Bellomy Research (the "Company" or "Employer"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The effective date of the Plan was January 1, 2016.
- b) *Eligibility* – The Plan substantially covers all employees of the Company who have completed two months of service and are age eighteen or older. Participants are enrolled on the first day of the calendar month after the eligibility requirements are met. Participants can enter the Plan on the first day of the month after meeting the eligibility requirements.
- c) *Employee Contributions* – Each year, participants may contribute up to 100 percent of compensation, as defined in the plan, subject to the annual statutory limits. Contributions may be made on a pre-tax or after-tax (Roth) basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).
- d) *Employer Contributions* – The Company may make matching and profit sharing contributions. Allocations of these contributions to participants will be made in accordance with the formula selected by the Company, as defined by the Plan document. Plan was amended effective January 1, 2017. Participants are required to be employed by the company on the last day of the Plan year to receive matching and profit sharing contributions, except for instances of death, disability and attainment of normal retirement date. No profit sharing contributions were made for 2024 or 2023.

- e) *Participants Accounts* – Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses, if not paid by the Company. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- f) *Vesting* – Participants are vested immediately in their contributions and the Company’s contributions, plus actual earnings thereon.
- g) *Payment of Benefits* – On termination of service due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service for other reason, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
- h) *Forfeited accounts* – Forfeitures of non-vested balances may be used to reduce employer contributions or used to pay Plan expenses. As of December 31, 2024 and 2023 the forfeitures balance was \$0.
- i) *Notes receivable from participants* – Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant’s account and bear interest at local prevailing rates as determined periodically by the loan administrator. Principal and interest is paid ratably through monthly payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Accordingly, actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through October 15, 2025 which is the date the financial statements were issued.

3. Information Prepared and Certified by the Trustee

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Capital Bank and Trust Company, the Plan's trustee. The trustee has certified that the information below is complete and accurate.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority;
- Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets or quoted prices from identical or similar assets in inactive markets;
- Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

6. Related Party Transactions

Certain plan investments are shares of mutual funds managed by American Funds, an affiliate of Capital Bank and Trust Company. Capital Bank and Trust Company is the trustee of plan assets and, therefore, these transactions qualify as party-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

8. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by CCH Incorporated DBA FTWilliam Com ("FTWilliam"). FTWilliam obtained its latest opinion letter dated October 6, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
