#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the **Belmond USA, Inc. 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information on the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matters — Supplemental Schedule Required by ERISA***

#### Note 1. Description of Plan

The following description of the Belmond USA, Inc. 401(k) Plan (the Plan) provides only general information. The Plan was formerly known as the Orient-Express Hotels, Inc. 401(k) Plan. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

##### General

The Plan is a defined contribution plan that was adopted by Belmond USA, Inc. (the Company) and its Affiliates, Venice Simplon Orient-Express, Inc. (VSO), '21' Club Inc. (21 Club), El Encanto Hotel, and Garden Villas (El Encanto), collectively, the "Affiliates", for the benefit of their employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Administrative Committee oversees the governance of the Plan, including determining the appropriateness of the investment offerings and monitoring investment performance.

##### Plan Amendments

The Plan has been restated to comply with current law.

The Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 (the Act) was enacted to enhance retirement savings opportunities and improve retirement plan administration in the United States. The Act provides a broad range of mandatory and optional provisions affecting retirement plans, including increasing participation, improving portability of retirement savings, and expanding penalty-free withdrawal options for certain circumstances. Plan sponsors may elect to adopt certain provisions voluntarily before their mandatory effective dates. For the year ended 2024, the Plan adopted the following voluntary provision under the SECURE 2.0 Act:

- The automatic cash-out threshold for former participants' account balances was increased from \$5,000 to \$7,000.

Management has evaluated the impact of this amendment and determined that it does not materially affect the financial statements as of and for the year ended December 31, 2024. This change is intended to improve participant experience and administrative efficiency in accordance with recent legislative developments.

##### Eligibility and participation

An employee of the Company or its Affiliates is eligible to participate in the Plan if he or she has completed at least 90 days of continuous employment, has attained age 20½, is not a non-resident alien, and is not covered by a collective bargaining agreement, unless such agreement specifically provides for the application of the Plan to such employee.

Plan entry dates are the first day of January, April, July, and October of each year.

##### Contributions

Each year participants may contribute up to 100% of pre-tax annual compensation not to exceed the annual maximum deferral prescribed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company and its Affiliates have adopted safe harbor matching provisions. Under these provisions, the Company and its Affiliates contribute safe harbor matching contributions equal to 100% of contributions made by a participant that do not exceed 3% of the participant's compensation, plus 50% of the contributions made by a participant that exceed 3% of the participant's compensation but that do not exceed 5% of the participant's compensation. The Company and its Affiliates made safe harbor matching contributions of approximately \$400,000 and \$379,000 during the years ended December 31, 2024 and 2023, respectively.

#### **Note 1. Description of Plan (Continued)**

##### Investment options

Upon enrollment in the Plan, participants may direct their contributions and the Company's and its Affiliates' contributions in a variety of investment options as more fully described in the Plan's literature.

##### Participant accounts

Each participant's account is credited with the participant's contribution, the Company's and its Affiliates' safe harbor matching contributions, and Plan earnings, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are immediately vested in their contributions and the Company's and its Affiliates' safe harbor matching contributions plus actual earnings thereon. A participant who dies, becomes permanently disabled, or attains normal retirement age while employed will also become 100% vested. Participants are 100% vested in rollover and transfer contributions.

##### Forfeitures

At December 31, 2024 and 2023, forfeited balances of terminated participant's non-vested accounts, and earnings thereon, were insignificant to the Plan. Forfeited balances may be used to reduce the Company's and its Affiliates' matching contributions or pay plan administrative expenses as directed by the plan administrator. During the year ended December 31, 2024 and 2023, no forfeitures were used to reduce the Company's and its Affiliates' matching contributions or to pay administrative expenses.

##### Participant notes receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years unless the loan is used to acquire a primary residence. The loans are secured by the balance in the participant's account and accrue interest at 3.25% to 9.50% which represents a rate similar to the rate charged for a loan made under similar circumstances by persons in the business of lending money. Principal and interest are paid ratably through payroll deductions. No participant may have more than one loan outstanding at any one time.

##### Withdrawals

Prior to termination of employment, a participant may withdraw any part or all of the vested balance of his or her account (excluding earnings) if the participant has attained age 59½ or has become disabled. If the participant has not attained age 59½ or become disabled, the participant may take a "hardship" withdrawal from his or her account to the extent needed to satisfy an immediate and heavy financial need caused by medical expenses, the purchase of a primary residence, the cost of post-secondary school tuition, funeral expenses, or impending eviction or mortgage foreclosure. Hardship withdrawals are subject to approval by the plan administrator.

##### Payment of benefits

On termination of service, a participant may elect to receive the value of the vested interest in his or her account as a lump-sum distribution, roll the vested balance into an individual retirement account (IRA) or other qualified plan, or leave the balance in the Plan. On termination of service due to death, the value of the deceased participant's account shall be distributed to the participant's beneficiary.

Payment of benefits (continued)

The Plan's provisions allow the plan administrator to require terminated participants to take a distribution if their account balance is less than \$7,000 (formerly \$5,000). Under these provisions, when mandatory distributions are made, accounts with vested balances less than \$1,000 will receive a lump-sum cash payment when the participant fails to elect other options. If his or her vested account balance exceeds \$1,000 but is less than \$7,000 (formerly \$5,000), a participant may elect to receive a single lump sum or roll over the vested balance into an IRA or other qualified plan. However, if no election is made by the participant, the Plan will automatically roll over the vested balance into an IRA with an affiliate of the Plan's custodian.

**Note 2. Summary of Significant Accounting Policies**

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of December 31, 2024 and 2023. If a participant ceases to make note receivable repayments and the plan administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document

Contributions

Participant contributions and the Company's and its Affiliates' safe harbor matching contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment valuation and income recognition (continued)

Management fees and operating expenses charged to the Plan for investments in shares of registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment returns for such investments.

Payment of benefits

Benefits are recorded when paid.

Plan expenses

Personnel within the Company and its Affiliates perform many administrative duties of the Plan, including maintenance of personnel files and reconciliation of payroll records, at no charge to the Plan. A portion of the administrative expense incurred in connection with administration of the Plan and related trust is paid by the Company and its Affiliates. Any costs not paid by the Plan may be paid by the Company and its Affiliates. Other administrative costs are charged to the individual participant's accounts.

**Note 3. Information Prepared and Certified by Trustee**

Certain information included in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the year then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**Note 4. Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**Note 4. Fair Value Measurements (Continued)**

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

- *Shares of registered investment companies* (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Note 5. Income Tax Status**

The IRS has determined and informed the Company and its Affiliates, by a letter dated August 12, 2013, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such change could materially affect the amount reported in the statement of net assets available for benefits.

**Note 7. Party-in-Interest Transactions**

Certain administrative expenses relating to the maintenance of participant eligibility records are paid by the Company and will not be reimbursed by the Plan. ADP's Retirement Services, the recordkeeper, and Raymond James and Associates, investment advisors, assist the Company with selecting investments and monitoring investment results. Therefore, investment transactions qualify as party-in-interest transactions. Fees paid by the Plan to ADP's Retirement Services for administrative services for the years ended December 31, 2024 and 2023, were approximately \$22,000 and \$22,000, respectively. Fees paid to Raymond James and Associates for investment management services were approximately \$39,000 and \$37,000 for of the years ended December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company and its Affiliates have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
