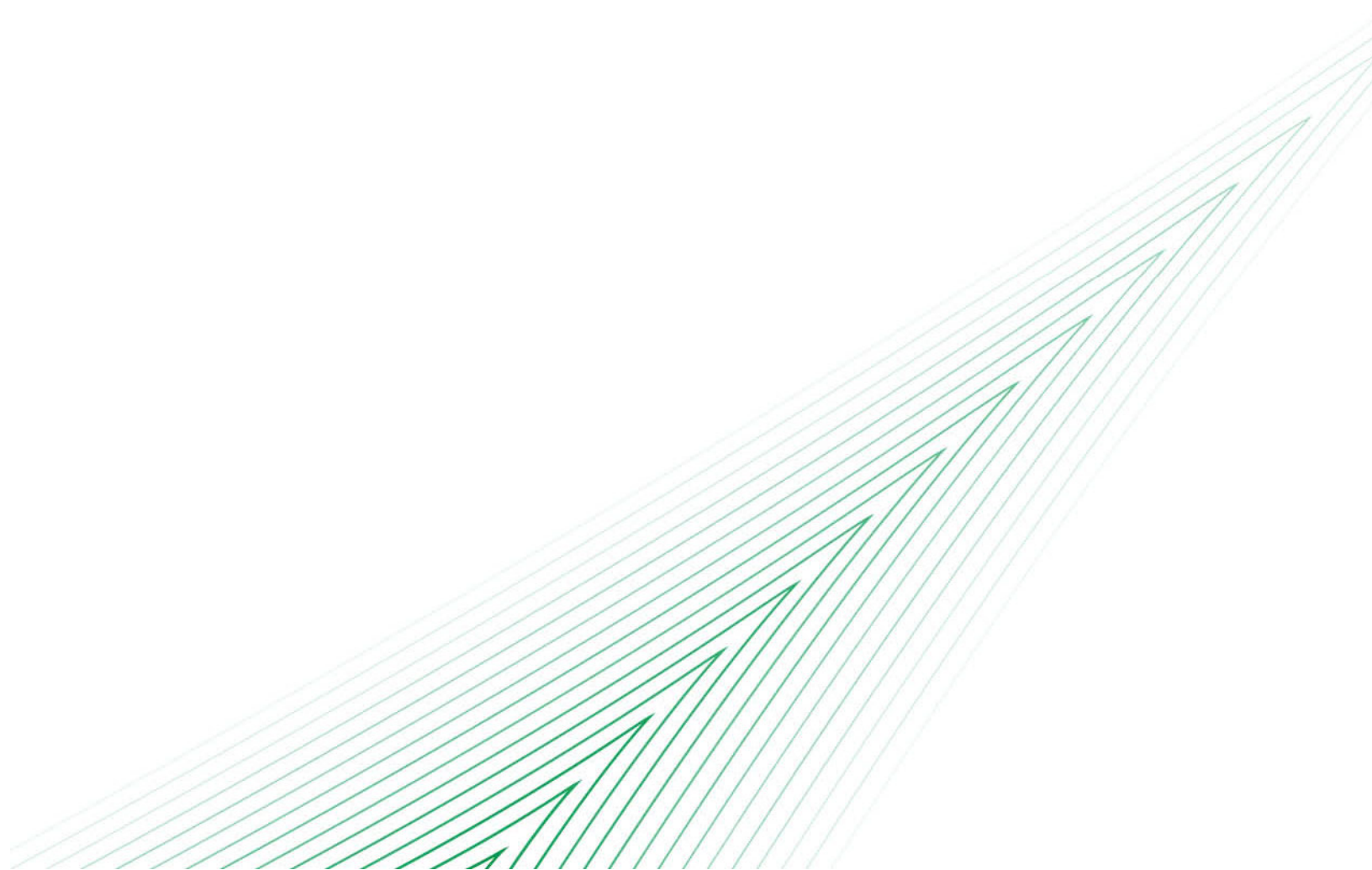

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedules Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the BronxWorks 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. **General** — The Plan was established on January 1, 1986 as a non-ERISA Tax Shelter Annuity (“TSA”) program under section 403(b) of the Internal Revenue Code (“IRC”), covering all employees of BronxWorks, Inc. (“BronxWorks” or “Employer” or “Sponsor”). Mutual of America was primarily responsible for the Plan’s Administration. The Plan provided only employee salary reduction contributions made pursuant to voluntary salary reduction agreements between the Employer and its eligible employees which are excludable from gross income under the IRC. The Plan did not provide for any contributions by the Employer and all contributions were invested in one or more annuity contracts. It met the Department of Labor regulatory safe harbor requirements for exemption from ERISA and therefore, was not subject to the provisions of ERISA. The Employer had no power, responsibility or authority to exercise discretion or make discretionary determinations with respect to the administration of the Plan. All discretionary determinations with respect to an account or annuity contract were made by the issuer, Mutual of America. The Plan was amended and restated effective January 1, 2022 to be in compliance with the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and to now provide for Employer contributions.
- B. **Eligibility** — All employees of the Sponsor are eligible to participate in this Plan and make elective deferrals upon hiring, except those who are non-resident aliens with no U.S. source income and those who are classified or treated as independent contractors (even if a government agency or court with the jurisdiction determines that such persons are deemed to be employees for any purpose under common-law principles or federal, state or local law). All eligible employees must attain the age of 21 and complete one year of service in order to be eligible for Employer contributions.
- C. **Contributions** — Each year, participants of the Plan may contribute up to any percent of pre-tax annual compensation, as defined in the Plan, and can contribute pre-tax and Roth amounts up to the amount allowed under the Internal Revenue Service (“IRS”) rules. Participants who have attained age 50 before the end of the Plan year, and who are making regular contributions, are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan allows for a discretionary matching and discretionary Employer contribution each year.

A fixed Employer contribution using the grouping method will be provided based on each participant's hire date (or most recent rehire date) and the completed years of service as of the month for which the Employer contribution is made. Years of service are based on a participant's contribution service. For this purpose, contribution service is based on the participant's number of consecutive whole years of service determined as of the first day of each month. All contribution service will forfeit upon a severance from employment, and therefore, a rehired employee's contribution service will be reset to zero (0) years on their date of rehire.

The following table represents the percentage of compensation based on the employee hire date:

- D. **Participant Accounts** — Each participant's account is credited with participant's contributions as well as allocations of the Sponsor's contributions, Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings of account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

- E. **Vesting and Forfeitures** — Participants are vested based on continuing years of service. A participant is 100% vested after three years of credited service. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$397,751 and \$274,246, respectively. These accounts will be used to reduce future Employer contributions and were used in 2024 and 2023 to pay Plan expenses.
- F. **Notes Receivable from Participants** — Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan administrator and are generally payable in installments over periods ranging from one to five years (unless the loan is used for the purchase of a primary residence, in which case the repayment period may be up to ten years). Interest rates range from 4.25% to 9.50% for loans issued during the years ended December 31, 2024 and 2023. The loans are repaid directly through to the Custodian. A loan that is considered in default is reported as a deemed distribution which may be a taxable event for the participant.
- G. **Payment of Benefits** — Participants are entitled to distribution of their vested benefits upon termination of service due to severance of employment, death, disability, retirement, qualified distribution or termination of the Plan. Hardship distributions are allowed under the Plan only on the participant deferred amount.
- If the individual's vested account balance is not greater than \$7,000, the participant will receive a single-sum payment.
 - If the individual's vested account balance is greater than \$7,000, the participant may elect to receive a single-sum payment or installment distribution.
- H. **Administrative Expenses** — Administrative expenses are paid by the Plan Sponsor, except for certain contract administrative fees which are paid for by the Plan. Fees paid to the Custodian for investment management and bookkeeping services are paid by the Plan as a reduction of the investment return (see Note 5).

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

- A. **Basis of Accounting** — The Plan prepares its financial statements using the accrual basis of accounting. The Plan adheres to accounting principles generally accepted in the United States of America ("U.S. GAAP").
- B. **Use of Estimates** — The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- C. **Investment Valuation and Income Recognition** — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment advisers, Custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- D. **Notes Receivable from Participants** — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as deemed distributions based on the terms of the Plan agreement and amounted to \$-0- and \$14,931 for the years ended December 31, 2024 and 2023, respectively.
- E. **Payment of Benefits** — Benefits are recorded when paid.

NOTE 3 – INVESTMENTS – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN AS COMPLETE AND ACCURATE

As noted in the independent auditors' report, the Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information, and the information contained in the supplemental schedule of assets (held at end of year), was certified as complete and accurate by Lincoln Financial Group Trust Company, Inc. ("Lincoln"), Custodian of the Plan, and was not subjected to any auditing procedures performed by the independent auditors except for comparing such information to information included in the Plan's financial statements.

The Custodian has certified to the completeness and accuracy of the investments included in the financial statements as of December 31, 2024 and 2023 and investment activity included in the financial statements for the years then ended:

Notes receivable from participants amounted to \$273,574 and \$112,646 as of December 31, 2024 and 2023, respectively, have been certified by the custodian. Interest income on notes receivable from participants of \$21,852 and \$18,571, respectively for the years ended December 31, 2024 and 2023, respectively, have also been certified by the Custodian.

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820, "Fair Value Measurement," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

NOTE 4 – FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Lincoln Stable Value Account

The portfolio is valued on a daily basis, and the crediting rate is calculated based on the weighted average of the crediting rates of all of the book value instruments of the fund. Participant account balances are credited daily with interest and don't fluctuate with market ups and downs.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED-PARTY TRANSACTIONS (PARTY-IN-INTEREST)

The Plan's investments include certain stable value funds managed by the Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are reflected as administrative expenses in the accompanying financial statements and amounted to \$3,044 and \$45,534 for the years ended December 31, 2024 and 2023, respectively.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE 7 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the balance of participant accounts will be distributed in a lump sum or by delivery of a fully paid annuity contract as permitted by Internal Revenue Service regulations.

NOTE 9 – DELINQUENT PARTICIPANT CONTRIBUTIONS AND LOAN REPAYMENTS

In accordance with the Department of Labor's Regulation 2510.3102, an employer is required to segregate participants' contributions from its general assets as soon as practical, but in no event more than the 15th business day following the end of the month within the time frame required by the Department of Labor ("DOL") under the Plan asset rules.

Contributions for certain payroll periods in 2024 and 2023 amounting to \$192,245 and \$103,248, respectively, were not remitted by the Sponsor to the recordkeeper within the period prescribed by the Department of Labor regulations. The Sponsor agreed to absorb all costs incurred by the Plan because of the untimely remittance of the contributions and is in the process of correcting the late remittances.

NOTE 10 – IRC COMPLIANCE TESTS

As of the date of this report, the Plan did not comply with regulations concerning relevant IRC compliance tests. The Plan Custodian has commenced preparation of such tests and in case corrective actions are needed, the Sponsor agreed to absorb all costs incurred by the Plan.

NOTE 11 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
