Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Erdman Company Employees Profit Sharing/401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



NOTE 1 DESCRIPTION OF PLAN

The following description of the Erdman Company Employees Profit Sharing/401(k) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan.

General

The Plan is a defined contribution plan established by the Erdman Company (the Company). All employees, with the exception of independent contractors, leased employees, union employees, and nonresident aliens, who have completed at least 30 days of service, as defined in the Plan, and are age 21 or older are eligible to participate. The employee is eligible for the Company contribution after completing one month of service. Employees must have completed at least 1,000 hours of service with the Company during the preceding 12-month period and be employed on the last day of the Plan year to be eligible for any profit sharing contributions.

Upon enrollment in the Plan, a participant may direct employee 401(k) contributions and Company matching contributions to any combination of available investment options.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may defer up to 100% of eligible compensation subject to Internal Revenue Service (IRS) limits. A participant may designate all or a portion of their elective deferrals as Roth deferrals. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. The Plan also provides for automatic savings increases whereby a participant's deferral percentage is automatically increased by 1% on an annual basis until the percentage reaches 15%, unless the participant elects otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Company matching and profit sharing contributions are at the discretion of the Company. Profit sharing contributions are allocated based on the participant's annual compensation. During the year ended December 31, 2024, the Company made a matching contribution of up to 2.50% of the gross compensation contributed by the participants. No discretionary profit-sharing contributions were made by the Company for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings, including an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan permits the transfer of funds from other qualified plans.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of credited service. A participant is 100% vested after five years of service.

Forfeited Accounts

Forfeitures of nonvested contribution accounts are used to reduce Company contributions or to pay future administrative expenses in accordance with the Plan document. During the year ended December 31, 2024, forfeitures of \$32,208 were used to reduce Company contributions, and forfeitures of \$51 were used to pay administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$15,120 and \$4,527, respectively.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance. Individual loan amounts must be at least \$500; however, aggregate loan amounts may not exceed \$50,000. The interest rate for the loans shall be prime rate plus 1%. Loan terms may range from one to five years, or longer if for the purchase of a primary residence. The loans are secured by the balance in the participant's account. Principal and interest is paid ratably through periodic payroll deductions.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon the participant's death, disability, retirement, or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement at age 65 and early retirement after attaining age 55 and seven years of service.

Terminated employees with vested account balances in excess of \$5,000 may elect to receive a single lump sum distribution of their entire vested account balance or choose to rollover their vested account balance to another qualified retirement account. Terminated employees with vested account balances of less than \$5,000 will receive their balance in a single lump sum distribution.

Termination of Plan

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Plan Expenses

Substantially all of the Plan's administrative expenses are paid by the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes both realized and unrealized investment gains and losses.

Benefit Payments

Participant withdrawals are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

NOTE 3 INVESTMENTS

Charles Schwab Trust Bank, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of the participant-directed investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Exchange Traded Funds: Valued at the net asset value (NAV) of shares held by the Plan as of the close of the last business day of the year.

Cash Equivalents: Valued based on cost, which approximates fair value in a noninflationary economy.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 6 TAX-EXEMPT STATUS OF THE PLAN

The Plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is therefore, not subject to tax under current income tax law. The prototype Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were shares of funds managed by Charles Schwab Trust Bank (Charles Schwab). Charles Schwab is the Plan trustee as defined by the Plan and, therefore, qualifies as a party-in-interest. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 NON-EXEMPT TRANSACTION

The Plan failed to remit employee deferral contributions for certain payroll periods during the year ended December 31, 2024 within the timeframe prescribed by the Department of Labor. This is deemed a prohibited transaction in accordance with ERISA and the Internal Revenue Code. The Plan is in the process of correcting the prohibited transaction by depositing the lost earnings.
