Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gitibin & Associates, LLC dba Go Rentals 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of Plan

The following description of the Gitibin & Associates, LLC dba Go Rentals 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General – The Plan was established on January 1, 2016, in accordance with Section 401(k) of the Internal Revenue Code (IRC). It is a defined contribution plan for the benefit of all employees of Go Rentals, Inc. and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Go Rentals, Inc. (the Company) is the Plan's sponsor and serves as Plan Administrator. The Plan's administrative committee oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility – Employees of the Company are eligible to participate in the Plan upon reaching age 21 and after completing one year of service in which at least 1,000 hours are worked. Participants must complete at least 1,000 hours of service during the Plan year and be employed with the Plan for at least six months to be eligible to receive any employer paid profit sharing contributions.

Contributions – Employee contributions to the Plan (voluntary contributions) are deferrals of the employee's compensation made through a direct reduction of compensation in each payroll period. The maximum tax deferred contribution may not exceed the Internal Revenue Service (IRS) limit. Upon enrollment in the Plan, a participant may direct employee contributions in various investment options. Participants may change their options at any time.

The Plan may elect to make a matching contribution. Also, the Plan may make a profit sharing contribution to be allocated to each participant. No employer contributions were made for the year ended December 31, 2024.

Participant accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Plan's contribution, and (b) Plan earnings; and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Each participant's interest in voluntary contributions is vested immediately. Matching and profit sharing contributions are vested in accordance with the Plan's vesting schedule as follows:

Notes to Financial Statements

Notes receivable from participants – Prior to January 1, 2023, participants may have borrowed against their Plan account balance within Plan guidelines. Loan terms are at the discretion of the borrower but generally cannot exceed five years. The loan amount must be a minimum of \$1,000 but cannot exceed the lesser of (a) one-half of the participant's nonforfeitable interest under the Plan, or (b) \$50,000. Interest is charged on the outstanding balance at rates determined by the Plan Administrator based on prevailing interest rates. Principal and interest are paid ratably through payroll deductions. The notes are secured by the vested balance in the participant's account, and a participant can have a maximum of one outstanding loan at any time. Effective January 1, 2023, the Plan no longer permits new participant loans under the Plan. As of December 31, 2024, the Plan has one outstanding loan with an interest rate of 5.75% maturing in July 2027.

Benefit payments – Upon termination of service due to death, disability, retirement, or for other reasons, a participant may receive a lump-sum distribution equal to the vested portion of his or her account, as defined in the Plan Document. Participants may also elect to roll over their account into another tax-deferred account or remain in the Plan until they are legally required to begin taking distributions. All vested account balances not exceeding \$5,000 will be immediately distributed in a lump-sum payment. Additionally, under certain circumstances of financial hardship or attaining the age of 59½, participants are allowed to withdraw certain funds from the Plan.

Forfeitures – Forfeitures are the nonvested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan, must be used in the subsequent year, and may first be used to pay Plan administrative expenses, with any remaining amount used to reduce future Plan contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$261 and \$260, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements of the Plan have been prepared on the accrual method of accounting and in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates – The process of preparing financial statements in accordance with GAAP requires the use of estimates and assumptions regarding certain types of assets and liabilities, revenues and gains, and expenses and losses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

Investment valuation and income recognition – The Plan's investments are reported at fair value. The Plan's trustee, John Hancock Life Insurance Company (U.S.A.) (John Hancock), certifies the fair value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Notes to Financial Statements

Income recognition – Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain administrative functions are performed by officers or employees of the Plan. No such officer or employee received compensation from the Plan. Some administrative expenses incurred by the Plan are absorbed by the Plan. The administrative expenses that are paid by the Plan consist of fund management fees, bank service charges, and other administrative fees charged by the trustee.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Pooled separate account investments – Units held in pooled separate accounts (PSAs) are valued using the net asset value practical expedient (NAV practical expedient) of the PSA as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the pooled separate accounts, minus its liabilities, and then divided by the number of units outstanding.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Concentrations, Risks, and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 5 – Certified Investment Information

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103–8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.), the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the schedule of assets (held at end of year).

Note 6 – Tax Status of the Plan

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Parties-in-Interest Transactions

Certain investments in pooled separate accounts and the interest-bearing cash account are managed by John Hancock, the trustee as defined by the Plan, and therefore, these investments qualify as exempt party-in-interest transactions.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 9 – Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company has determined the amount of related lost earnings and will remit these amounts to participants' accounts subsequent to year end.
