## **Independent Auditor's Report**

To the Plan Committee of the  
Blue Ridge Medical Center Retirement Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of the Blue Ridge Medical Center Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**DECEMBER 31, 2024**

**NOTE 1 – PLAN DESCRIPTION**

The following description of the Blue Ridge Medical Center Retirement Plan (the “Plan”) is provided for general information purposes only. Reference should be made to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Blue Ridge Health Center, Inc. (the “Company”) and is sponsored by the Company. Employees of the Company become eligible to participate in the Plan upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the requirements of Section 403(b) of the Internal Revenue Code.

**Administration**

The Company is the Plan sponsor and the Plan administrator. Assets of the Plan are held at Ascensus Trust (“Ascensus”) and Lincoln Life Insurance Company (“Lincoln”).

**Contributions**

*Employer* – The Company may make profit sharing contributions at its discretion. The Company also makes discretionary matching contributions equal to 50% of the first 5% of employee contributions. Employees are eligible for these contributions once they have attained 21 years of age and completed three months of service.

*Participant* – Participants may contribute up to 100% of compensation, as defined in the Plan, subject to certain Internal Revenue Service (“IRS”) limitations. The IRS limit for elective deferrals is \$23,000 for the year ended December 31, 2024. In addition, participants who are age 50 or older are permitted to make catch-up contributions each year, subject to IRS limitation of \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Participant accounts**

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and plan earnings, and charged with an allocation of administrative expenses, where applicable. Allocations are based on participant earnings or account balances, as defined. Discretionary matching allocations are based on amounts contributed to the Plan by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are fully vested immediately in their contributions plus actual earnings thereon. Company matching and discretionary contributions are fully vested after three years of service, plus actual earnings therein.

### **Forfeited accounts**

Forfeitures of matching contributions are used to reduce the employer's matching contributions or for administrative expenses. The balance of forfeited non-vested accounts was \$8,827 and \$4,270 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$12,434 from forfeited non-vested accounts was used to pay administrative expenses of the Plan.

### **Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the vested balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

## **NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

### **Basis of accounting**

The financial statements of the Plan have been prepared using the accrual method of accounting generally accepted in the United States of America ("GAAP").

### **Use of estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from such estimates.

The Plan's assets are invested in various financial instruments including registered investment companies and pooled separate accounts investing in stocks, bonds, and fixed income securities. Investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risk in the near term could materially affect participant's account balances and amounts reported in the financial statements.

### **Investment valuation and income recognition**

The Plan's investments are stated at fair value determined by quoted market prices of the underlying securities as stated by the trustee. Participant loans are stated at cost, which approximates fair value.

### **Notes receivable from participants**

Participant loans are classified as notes receivable from participants on the statement of net assets available for benefits and are valued at their unpaid principal balance, plus accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### **Payment of benefits**

Benefits are recorded when paid and classified as deductions in the accompanying statement of changes in net assets available for benefits.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### Subsequent events

The Plan administrator has evaluated subsequent events and transactions through October 15, 2025, the date the Plan's financial statements were available to be issued, for purposes of recording and disclosing such events considered to have a material impact on the accompanying financial statements.

### NOTE 3 – INFORMATION CERTIFIED BY TRUSTEES

The Plan administrator has elected the method of compliance permitted by 28 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Plan's trustees, Ascensus and Lincoln, except for comparing such information certified by the trustees to the related information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year).

### NOTE 4 – INVESTMENTS

In accordance with GAAP, the Plan uses a fair market value measurement framework that requires fair value to be determined based on the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

The framework establishes a hierarchy with three levels of valuation inputs based on the extent to which the inputs are observable in the marketplace. Observable inputs reflect market data obtained from sources independent of the reporting entity and unobservable inputs reflect the entities own assumptions about how market participants would value an asset or liability based on the best information available. An asset's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The three input levels are as follows:

*Level 1:* Quoted prices in active markets for identical securities.

*Level 2:* Other significant observable inputs, including quoted prices for similar securities, quoted prices in markets that are not active, and other inputs that are observable and can be corroborated by observable market data for substantially the same term of securities.

*Level 3:* Significant unobservable inputs that are supported by little or no market activity and that are significant to the fair value of securities.

#### NOTE 5 – TAX STATUS

The Plan adopted a non-standardized pre-approved 403(b) plan that has received a favorable opinion letter from the IRS dated January 1, 2018 stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code). The Plan has not received a determination letter from the IRS specific to the Plan itself but is relying on the ruling obtained by the originator. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management is not aware of any uncertain tax positions taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

## **NOTE 6 – GUARANTEED INVESTMENT CONTRACT**

Prior to 2020, the Plan entered into a guaranteed investment contract with The Lincoln National Life Insurance Company (the "Contract"). The value of the investment was \$348,242 and \$339,300 as of December 31, 2024 and 2023, respectively. This fund includes individual and group deferred annuity contracts that are registered with the Securities and Exchange Commission which provide investment options that include a fixed account. Because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The value of the contract is included in the statement of net assets available for benefits as of December 31, 2024 and 2023 at contract value.

A description of the events that limit the ability of the Plan to transact at contract value and the description of events or circumstances that would allow the Plan to terminate its interest in the contract are described in the Contract itself.

## **NOTE 7 – REINVESTED DISTRIBUTION**

During the year ended December 31, 2024, an uncashed benefit payment check, originally issued and recorded as a distribution during the year ended December 31, 2023, was returned to the plan and the related amount of approximately \$42,900 was reinstated to the participant's account. The reinstatement is presented as a reduction to benefits paid to participants in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

## **NOTE 8 – RELATED-PARTY TRANSACTIONS**

Substantially all of the Plan's assets as of December 31, 2024 are invested in funds managed by Ascensus, and therefore, these transactions qualify as party-in-interest transactions. Total fees paid by the Plan to Ascensus for investment management and other administrative services were \$26,113 for the year ended December 31, 2024.

In addition, the Company pays certain Plan related expenses which are not included in the Plan financial statements.

Included in the Plan assets are notes receivable from participants. As of December 31, 2024 and 2023, notes receivable from participants were \$47,291 and \$33,507, respectively. For the year ended December 31, 2024 interest income related to notes receivable from participants was \$4,114. These transactions qualify as party-in-interest transactions permitted under provision of ERISA.

## **NOTE 9 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## **NOTE 10 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment fund options. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the value of investment securities presented in the statements of net assets available for benefits will occur in the near term and such changes could materially affect participant account balances.
