Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed our audits of the accompanying financial statements of C.E.F.S. Economic Opportunity Corporation Plan (the Plan), employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of C.E.F.S. Economic Opportunity Corporation Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 DESCRIPTION OF PLAN

The following description of C.E.F.S. Economic Opportunity Corporation Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective September 1, 1988. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective March 27, 2020. The Plan excludes leased employees, nonresident aliens, substitutes, work experience participants, and employees working less than 20 hours a week unless they have completed one year of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for the oversight of the Plan. The Executive and Audit Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors.

Eligibility

Employees of C.E.F.S. Economic Opportunity Corporation (the Company) are eligible to participate in the deferral component of the Plan as soon as administratively feasible after their date of employment. Participants are eligible for the nonelective employer contribution after earning one year of service defined as 1,000 hours.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 403(b) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may, at its discretion, elect to make a qualified nonelective contribution to the Plan. For the years ended December 31, 2024 and 2023, the Company nonelective contribution was \$41.54 per pay period for each eligible employee.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's nonelective contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in all contributions plus actual earnings thereon.

Plan Loans

Participants may borrow from Mutual of America a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. These loans are direct loans between the participant and the qualified institution, and as such they are not treated as a transfer from an investment fund to a note receivable from participant fund. However, 120% of the loan is collateralized by the participant's account and this portion of their account is transferred and maintained in the guaranteed investment contract at the time of the loan. Loans must be repaid by the participant in five years unless the proceeds are used to acquire a primary residence which may be repaid at a longer term. The loans bear interest at a reasonable rate determined by the insurance company. In the event of a default, foreclosure on the participant's account balance will not occur until a distributable event occurs in the Plan.

Benefit Payments

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Executive and Finance Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and insurance companies. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA.

Mutual of America Life Insurance Company, the insurance company, has certified to the completeness and accuracy of investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statements of changes in net assets available for benefits for the years then ended, and the schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Nonbenefit Responsive Fixed Accounts: These funds are designed to help accumulate money for retirement by compounding interest on the invested premiums. The fixed annuity contract earns a fixed rate of interest and is backed only by the financial strength of the issuing life insurance company. This contract carries a minimum guaranteed interest rate of 1.10%. The actual rate earned is changed no more than once annually. Fixed annuity contracts are valued at cumulative premiums plus earnings thereon which is considered to be the fair value of this contract.

Variable Annuity Contracts: The variable annuity contracts allow participants to invest in a number of variable investment options which in turn invest in a variety of underlying mutual funds (the underlying mutual funds follow a variety of investment strategies consistent with the asset classes to which the mutual funds belong). This causes the value of the variable annuity contracts to fluctuate with market conditions and may result in the loss of the money invested.

Variable annuity contracts are valued at the net asset value of the units of participation held under the contract at year-end. This value is based on the fair value of the underlying investments (mutual funds) held under the contract.

NOTE 5 INDIVIDUAL ANNUITY CONTRACTS WITH INSURANCE COMPANY

Participants maintain individual annuity contracts with Horace Mann. As part of the contracts, Horace Mann may maintain a portion of the contributions in a “guaranteed account,” which is called the Loan Interest Accumulation Account. The account is credited with earnings on the underlying investments and charged for withdrawals and administrative expenses charged by Horace Mann. The guaranteed minimum rate of interest is based on a formula established by Horace Mann and is between 1% and 4.5%. Any additional interest is not guaranteed. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date unless there have been no purchase payments for two years and the cash value is less than that needed to purchase a \$20 monthly income payment at maturity.

These annuity contracts meet the fully benefit-responsive criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Upon termination of the investment contract, the lump sum liquidation value of the guaranteed account portion of the participant’s accumulation value shall be equal to the product of (a) the participant’s guaranteed account accumulation value on the liquidation date and (b) a market value adjustment percentage. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants. The Plan administrator believes that any events that would limit the Plan’s ability to transact at contract value with participants are probable of not occurring.

Correction to Prior Year

The Horace Mann Fixed Annuity Contract and Horace Mann Loan Interest Accumulation Account were previously presented, recorded, and disclosed as nonbenefit responsive investment contracts valued at fair value. Management determined the basis to conclude it was a nonbenefit responsive contract in prior periods related to transaction restrictions that were not probable of occurrence. Therefore, the financial statements were revised to present, record, and disclose the Horace Mann Fixed Annuity Contract and Horace Mann Loan Interest Accumulation Account as fully-benefit responsive investment contracts valued at contract value. There was no difference between fair value and contract value in making the adjustments to the financial statements.

NOTE 6 PLAN LOANS

Outstanding loans between Plan participants and Mutual of America totaled \$27,600 and \$34,031 as of December 31, 2024 and 2023, respectively and were collateralized by approximately \$33,120 and \$40,837 of investments included in the statements of net assets available for benefits as of December 31, 2024 and 2023, respectively. Plan management believes that the Plan loans have met the conditions for exemption under ERISA and as such they have not been reflected in the accompanying financial statements and supplemental schedule as nonexempt transactions.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would remain 100% vested in their Company contributions.

NOTE 9 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated March 31, 2017 received from the IRS on the volume submitter plan indicating that the Plan is qualified under Section 403(b) of the IRC and is therefore not subject to tax under current income tax law. The volume submitter plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Horace Mann Life Insurance Company or Mutual of America Life Insurance Company. These companies are the insurance companies as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Fees incurred by the Plan for administrative services totaled \$4,323 and \$3,332 for the year ended December 31, 2024 and 2023, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 11 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The Horace Mann and Mutual of America Variable Annuity Contracts are classified as variable annuity contracts in the financial statements included herein. The insurance companies did not file a Form 5500 for the variable annuity contracts, therefore, the underlying assets have been reported on the Form 5500, Schedule H.

The amount related to Plan loan balances (between the participant and Mutual of America) are reflected as Participant Loans on the Form 5500; however, the financial statements reflect the collateral amount within the balance of the Mutual of America Fixed Annuity Contract, as summarized in Note 5.
